**SCOPE OF WORK**

Water service delivery to the Chancery Premises and Offices subscribed to this Contract The United States Embassy in Guatemala is requesting written quotation for water distribution of five-gallon containers at the different sites (as per attachment "B") for a Five-Year Contract that includes One-Base-Year and Four-Renewable-Option-Years. The Scope of Work is as follows:

1. A monthly distribution of 624 – Five-Gallon containers of water at the different sites of the United States Embassy as per Attachment "B".
2. Provide two MSDS (material safety data sheet) for the water, one from the Health Ministry and one from an Independent-Certified-Well-Known-Laboratory.
3. Provide 12 racks of water (these racks will be distributed among the different sites).
4. Provide 25 New Water Dispensers (hot/cold with safety protection for hot water)
5. Replace water dispensers every year (unless the water dispensers remain in good condition after evaluation). Evaluation will be performed and certified by the COR (Contracting Officer Representative).
6. Quarterly maintenance for the water dispensers (the maintenance service should be scheduled thru e-mail one week in advance, and name checks and access request should be processed prior to performing the service with the COR.
7. Provide a Point of Contact (POC name, telephone number and cellular number) to resolve issues related to the distribution of water.
8. Provide a quarterly report for the vehicle and drivers fleet (that includes list of names, DPI number, license number for the drivers, license plates for the vehicles, Brand Name, model, year and color of the vehicle)
9. Provide a water delivery schedule to the different sites, indicating days of delivery (as per attachment "B")
10. Provide 12 portable polyurethane water dispensers (these should be replaced as needed upon request).
11. Provide a consolidated monthly invoice according to delivery notes of each site with a properly signed receipt (printed name, signature and date).

For the purposes of section 7073, it is the Department of State's policy that no award may be made to any corporation covered by (1) or (2) above, unless the Procurement Executive has made a written determination that suspension or debarment is not necessary to protect the interests of the Government.

(b) Offeror represents that—

(1) It is [ ] is not [ ] a corporation that was convicted of a felony criminal violation under a Federal law within the preceding 24 months.

(2) It is [ ] is not [ ] a corporation that has any unpaid Federal tax liability that has been assessed for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability.
