1.0 CONTRACT PRICE

The Contractor shall complete all work, including furnishing all labor, material, transportation, equipment and services, required under this contract for independent valuation and audit of the Pan American Life Insurance Company's (PALIC) U.S. Embassy Local Employee Retirement Plan that it maintains for its locally employed staff for Embassy in Guatemala city, Guatemala. The price listed below shall include all labor, materials, overhead, taxes and profit. STATEMENT

1.0 STATEMENT OF WORK:

The United States Government, through the United State Embassy in Guatemala City, Guatemala, has a requirement for an independent valuation and audit of the Pan American Life Insurance Company's (PALIC's) U.S. Embassy Local Employee Retirement Plan (brokered through TecniSeguros) that it maintains for its locally employed staff. The Plan is funded and administered by PALIC/TecniSeguros. The plan was last evaluated by an independent actuary in June 2007. The actuarial valuation and audit shall be presented in a final survey report with sufficient explanation to allow the reader to understand the actuary's reasoning and in the format specified below.

1.1 TASKS TO BE PERFORMED BY CONTRACTOR:

The Contractor shall provide all the services usually provided by an independent actuary including, but not limited to the following:

- Identify actuarial assumptions: The contractor's recommendations for assumptions for the actuarial study should be presented directly to the U.S. Embassy's COR and Management Counselor, as well as the Comptroller in CGFS, for review prior to embarking on the study. Those assumptions should be based on historical data and expert future forecasts that the contractor collects, as well as guided by generally accepted actuarial standards. The contractor must include an explanation of why and how it selected each particular assumption it is recommending be used. The COR will review them, work with the Management Counselor and the Comptroller, and provide the approved assumptions to the contractor at a pre-determined date.
- Perform an independent actuarial valuation and calculate the plan's projected benefit obligation (PBO) to determine whether the current assets of the fund and current contribution levels are sufficient to meet current and expected future outflows.
- Perform a financial and management audit to determine whether cash inflows (contributions and credited earnings) and outflows (benefit payments and fees) are properly credited and in conformity with the terms of the plan. Identify remedies to correct any discrepancies.
- Analyze the investment performance of the plan by assessing whether the growth of assets is in line with market experiences and ensure completeness, valuation, and safe custody of plan assets.
- Perform sensitivity analysis on assumptions that have the most impact on future costs or that are less reliable for forward planning. Use different actuarial assumptions to determine to what degree the results would be affected by changing its value (e.g. if long term interest rates were slightly higher or lower, if retirement age were higher or lower, if salary increases were higher or lower).
- Identify and substantiate conclusions as to the financial situation of the fund (deficit or surplus).
- Ensure contributions are complete and accurate.
- Ensure completeness and accuracy of benefit calculations and payments and all other plan expenses are fair and reasonable.

- Identify and recommend alternatives to maintain a financially sustainable retirement system.
- Review all significant actuarial assumptions, and make recommendations as to their appropriateness. These assumptions may include but are not limited to: rate of return, interest rates, rate of salary increase, survivor benefits, mortality (including demographic mortality, as well as mortality by gender, if possible), contribution levels, exchange rates, currency fluctuations, longevity, early terminations, inflation, etc.
- Provide a comparison between the PALIC retirement plan and the local social security system (IGSS) which outlines advantages/disadvantages between the two plans.
- Provide an explanation on the redistribution of remaining plan funds if an employee separates from the Embassy before retirement. The explanation should trace the path of redistributed funds and show clearly how they are managed and affect other employees' funds.
- Explain any deviations within this plan from applicable legislation or regulations concerning defined benefit retirement plans in Guatemala City, Guatemala.
- Identify any anticipated changes in local law or practice that may have a bearing on the Embassy's retirement plan.
- Comment on the feasibility of converting the plan to a defined contributions plan.

1.2 SURVEY REPORT GUIDELINES

The Contractor shall prepare a Survey Report in draft and final in accordance with deliverables identified below. The format shall identify:

- The professional qualifications of the certifying actuary.
- Identification of actuarial assumptions (see related task regarding identifying the actuarial assumptions), standards, methods and techniques employed to determine the financial position of the Retirement Fund.
- Comments, opinions and recommendations regarding the operation of the fund based on actuarial analysis of all possible factors that threaten the solvency of the fund and the measures that should be undertaken to avert these threats, all clearly captioned.

Actuarial Certification

- The financial condition of the defined benefit plan.
- The audited value of plan assets the plan held (at the time of the audit), including a description of the value (e.g. fair, historical, etc.), investment policies, investment performance for the period, and any significant activities for the period and the effect on plan assets.
- Identify specific financial and demographic assumptions together with explanatory detail on the assumptions used and how derived. Note where the contractor's recommended assumptions were

not used and why. A summary of changes in assumptions, methodologies, and administrative policies.

- The detail, amount, and description of actuarial gains and losses.
- The projected benefits obligation (PBO) – the amount needed to fully fund the plan’s promised benefits for all employees, with a current or expected future right to the benefits, the amounts of the change in the PBO in the current period, and distinguishing between vested and non-vested accumulated plan benefits.
- Any concerns regarding the financial situation of the insurance company.
- Any other pertinent comments or recommendations not otherwise covered above.

Embassy-Provided Documentation

- At the Contractor’s request, the Embassy will provide relevant information to allow the Contractor to perform a cross-check of the data received from the Plan administrators.

1.3 DELIVERABLES

The Contractor shall comply with the following Delivery Schedule:

- Draft Survey Report in English. Two (2) copies delivered to the Contracting Officer’s Representative not later than 30 days after contract award. The Contracting Officer’s Representative will provide the Contractor with comments/request for revision within 15 days of receipt of the draft report.
- Final Survey Report in English. Two (2) copies delivered to the Contracting Officer’s Representative not later than 15 days after the approval of the draft report.

1.4 QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

“Inverted domestic corporation,” means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

(1) PSC 5510, Lumber and Related Basic Wood Materials;

(2) Product or Service Group (PSG) 87, Agricultural Supplies;

(3) PSG 88, Live Animals;

(4) PSG 89, Subsistence;

(5) PSC 9410, Crude Grades of Plant Materials;

(6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;

(7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;

(8) PSC 9610, Ores;

(9) PSC 9620, Minerals, Natural and Synthetic; and

(10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

Sensitive technology—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—
 - (i) To restrict the free flow of unbiased information in Iran; or
 - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and
- (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—

- (1) Means a small business concern—
 - (i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and
