SECTION 1 - THE SCHEDULE

A. Price and Payment

A.1. Price

The Government will pay for services under this contract at a fixed rate per **English/Spanish** word. This applies to translations into **English/Spanish**, or to translations from **Spanish/English** and **Simultaneous Interpretation Services into English/ Spanish or Spanish/English**. The COR shall determine the number of English words. This rate shall cover all costs associated with the translation and interpretation requirements, including preparation of the translation, interpretation, materials, equipment, overhead and profit. The Government will not pay any additional expenses.

A.2 VALUE ADDED TAX

B. Definitions

"COR" means Contracting Officer's Representative; see FAR 52.212-4 Contract Terms and Conditions – Commercial Items, in Section 2.

"Government" means the United States Government unless otherwise stated.

C. General and Specific Work Requirements

C.1. The Contractor shall perform non-personal translation or simultaneous interpretation services conforming to high professional standards for the Centers for Disease Control and Prevention (CDC), Division of Global Health and AIDS (DGHA) Central America Regional (CAR) Office exclusively. The Contractor shall:

C.2. Translate from and into English/ Spanish scientific documents, producing full, idiomatic translations of a broad range of documents of varying complexity including legal documents, regulations, or government correspondence.

C.3. Agency will provide an electronic version of original/ source document in either English or Spanish to be translated. Format or Electronic documents will be Word (.wpd), Excel (.xls) or PowerPoint (.ppt).

C.4. Contractor is requested to provide an electronic version of the translated document for review by CDC-CAR. Contractor may be asked to make some corrections. Final product must be accepted in writing by CDC-CAR prior to submission of invoices for payment.

C.5. Contractor must follow the layout, design and front of the original/source documentation. Contractor is not expected to translate text embedded in logos; however, there may be documents with flow-charts, tables or illustrations that require translation. Each Task Order will indicate the requirement.

C.6. Contractor is requested to consider that documents may have pages that contain just one or few lines to provide the final rate.

C.7. Properly convey the substance of the words and information to be translated, conducting requisite research and with attention to detail and nuances. The Contractor shall prepare a translation that can be readily understood by the intended target audience. The Contractor shall resolve linguistic problems as they arise and coordinate the work with others as necessary and as directed by the Contracting Officer's Representative (COR).

C.8. Perform analysis as deep as is needed under the circumstances in order to understand correctly the substance of the words and information to be translated, including attention to detail and nuances. The Contractor shall carefully analyze the simplicity or complexity of the language to be used in order to reach adequately the intended target audience. The Contractor shall perform sufficient research as to be able

to apply the correct approach to translating documents that will fit various and complex sets of circumstances. The Contractor shall apply analytical skill to extract essential information from research material in order to apply it readily to the solution of problems of semantics or substance. The Contractor shall resolve linguistic problems as they arise and coordinate the work with others as necessary and as directed by the Contracting Officer's Representative (COR).

C.9. Display fluent written command of English and Spanish, covering a wide range of terminology and specialized vocabulary in many fields, which may include important diplomatic, legal, economic, financial, technical, scientific, or other texts, which may originate from the highest levels of the U.S. government or foreign governments. These documents may include laws, constitutions, treaties, agreements, diplomatic notes, intelligence reports, speeches, etc., for the information of the Embassy/Consulate or for publication and dissemination. Translations shall be of such quality as to accuracy, terminology, and style that they require minimal review by the Embassy/Consulate. The Government may be require the Contractor to compare the English and foreign language versions of texts of treaties, agreements, and other documents for conformity of meaning prior to signature and publication.

C.10. Apply a high degree of judgment to understand the thrust of specific, often conceptually complex statements, such as typically drafted by leading experts in a field, and to transpose them into another language without loss of important nuances. The Contractor shall develop research patterns in order to define the specific parameters that must be mastered to overcome communications problems, often caused by differences in general philosophy, academic education, or scientific methodology among various countries and cultures.

C.11. Simultaneous interpretation Services from and into English/Spanish during meetings, conferences, trainings of broad range of varying complexity including legal communications, regulations, or government communications.

C.12. Contractor must provide all equipment (headphones, sound booth, computers, microphone, additional staff in case is needed. Contractor is responsible for all logistics and set-up at the meeting, conference, or training location to be specified by CDC-CAR.

C.13. CDC-CAR events will be based in Guatemala territory, mainly in Guatemala City and Antigua Guatemala. If travel outside the Guatemala City the costs must comply with foreign per diem rates established monthly by the US. Office of Allowances (http://aoprals.state.gov/content.asp?content_id=184&menu_id=78) and receipts for lodging and transportation are requires.

C.14. The Contracting Officer's Representative (see clause 652.242-70 in Section 2 Addendum) will provide specific guidance and answer questions relative to the requirement described in section C D.1, above. The COR for this contract is:

C.15. Completion Date and Delivery

The contractor shall perform the translation and interpretation services described on each Task Order.

The Contractor shall deliver one paper copy and one electronic format as described on each Task Order.

E.1 Quality Assurance and Surveillance Plan (QASP). This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

E.1.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

E.1.2 STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

E.1.3 PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(d) Comptroller General Examination of Record. (1) The Comptroller General of the United States, or an authorized representative of the Comptroller General, shall have access to and right to examine any of the Contractor's directly pertinent records involving transactions related to this contract.

(2) The Contractor shall make available at its offices at all reasonable times the records, materials, and other evidence for examination, audit, or reproduction, until 3 years after final payment under this contract or for any shorter period specified in FAR Subpart 4.7, Contractor Records Retention, of the other clauses of this contract. If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. Records relating to appeals under the disputes clause or to litigation or the settlement of claims arising under or relating to this contract shall be made available until such appeals, litigation, or claims are finally resolved.
