1. SPECIFICATIONS

The purpose of this firm-fixed price contract is to obtain Microphone System Installation meeting Department of State (DOS) standards, in accordance with the Specifications and References and Standards provided under this Section in Attachments 1 through 3.

2. PERFORMANCE PERIOD, DELIVERABLES, AND DUE DATES

(a) After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of 10 days from date of contract award unless the Contractor agrees to an earlier date) on which performance shall start.

All work under this contract shall not exceed 30 calendar days after the start date shown in the Notice to Proceed.

(b) The Contractor shall deliver to the address in paragraph 3 below the submittals required herein

(c) The Contractor shall deliver to the address in paragraph 3 below, all items priced in paragraph 2, continuation block 23.

3. PLACE OF DELIVERY

4. REINSTALLATION - The Contractor shall reinstall any shades, blinds, draperies, and other window dressing elements temporarily removed to facilitate the microphone installation.

5. WARRANTY - The Contractor warrants items and services provided under FAR 52.212-4. The Contractor shall obtain and furnish to the Government all information required to make any subcontractor's, manufacturer's, or supplier's guarantee or warranty legally binding and effective. The Contractor shall submit both the information and the guarantee or warranty to the Government in sufficient time to permit the Government to meet any time limit requirements specified, but not later than completion and acceptance of all work under this contract.

## 8. PERSONNEL REQUIREMENTS

### 8.1 REMOVAL OF PERSONNEL

The Contractor shall:

- (a) Maintain discipline at the site and at all times;
- (b) Take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by or amongst those employed at the site; and
- (c) Take all reasonable precautions for the preservation of peace and protection of persons and property in the neighborhood of the project against unlawful, riotous, or disorderly conduct.

The Contracting Officer may require, in writing that the Contractor remove from the work site any employee that the Contracting Officer determines:

- (a) Incompetent,
- (b) Careless,
- (c) Insubordinate or
- (d) Otherwise objectionable, or
- (e) Whose continued employment on the project is deemed by the Contracting Officer to be contrary to the Government's interests.

8.2 CONSTRUCTION PERSONNEL SECURITY - After award of the contract, the Contractor has ten (10) calendar days to submit to the Contracting Officer a list of workers and supervisors assigned to this project for the Government to conduct security checks. For each individual the list shall include:

- (a) Full Name
- (b) Place and Date of Birth
- (c) Current Address
- (d) Identification Number

Failure to provide any of the above information may be considered grounds for rejection and/or re-submittal of the application. Once the Government has completed the security screening and approved the applicants a badge will be provided to the individual for access to the site. The Government may revoke this badge at any time due to the falsification of data, or misconduct on site.

8.3 LANGUAGE PROFICIENCY - The Contractor's Manager assigned by the Contractor to superintend the work on-site, as required by FAR 52.236-6, "Superintendence by the Contractor", shall be fluent in written and spoken English.

9. UTILITIES - The Government will ensure that electrical power to operate tools is available at no cost to the Contractor. The Contractor shall not adjust the heating or air conditioning controls in properties with utilities turned on to maintain temperature.

## 10. INSURANCE

Amount of Insurance - The Contractor shall provide and maintain during the entire performance period the following insurance amounts and comply with FAR 52.228-5, "Insurance Work on a Government Installation."

The Contractor shall include all costs in their offers for General Liability (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

The Contractor shall obtain any other types of insurance required by local law. The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to any property of the Contractor, its officers, agents, servants, and employees, or any other person, arising from and incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims, except in the instance of gross negligence on the part of the Government.

The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

Government as Additional Insured - The Contractor shall name "the United States of America, acting by and through the Department of State", on a General Liability Policy as an additional insured with respect to operations performed under this contract.

Time for Submission of Evidence of Insurance - The Contractor shall provide evidence of the insurance required under this contract within ten (10) calendar days after contract award. Failure to timely submit this evidence, in a form acceptable to the Contracting Officer, may result in rescinding or termination of the contract by the Government.

## 11. LAWS AND REGULATIONS

11.1 COMPLIANCE REQUIRED - The Contractor shall, without additional expense to the Government, be responsible for complying with all host country laws, codes, ordinances, and regulations applicable to the performance of the work, and with the lawful orders of any governmental authority having jurisdiction. Host country authorities may not enter the construction site without the permission of the Contracting Officer.

Unless directed by the Contracting Officer, the Contractor shall comply with the more stringent of:

- (a) The requirements of such laws, regulations, and orders; or
- (b) The contract.

If a conflict among the contract and such laws, regulations, and orders, the Contractor shall promptly advise the Contracting Officer of the conflict and recommend a proposed course of action for resolution by the Contracting Officer.

11.2 LABOR, HEALTH AND SAFETY LAWS AND CUSTOMS - The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor,

safety, and similar matters, unless doing so would be inconsistent with the requirements of this contract.

11.3 SUBCONTRACTORS - The Contractor shall give written assurance to the Contracting Officer that all subcontractors and others performing work on or for the project have obtained all required licenses and permits.

11.4 EVIDENCE OF COMPLIANCE - The Contractor shall submit proper documentation and evidence of compliance with this clause to the Contracting Officer.

## 12. SAFETY AND ACCIDENT PREVENTION

(a) General. The Contractor shall provide and maintain work environments and procedures that will:

- (1) Safeguard the public and Government personnel, property, materials, supplies, and equipment exposed to contractor operations and activities;
- (2) Avoid interruptions of Government operations and delays in project completion dates; and
- (3) Control costs in the performance of this contract. For these purposes, the contractor shall: (i) Provide appropriate safety barricades, signs and signal lights; (ii) Comply with the standards issued by any local government authority having jurisdiction over occupational health and safety issues; and (iii) Take any additional measures the Contracting Officer determines to be reasonably necessary for this purpose.
- (iv) [Note to Contracting Officer: If work involves: (a) scaffolding or other work at heights above 2 meters, (b) trenches or other excavation greater than 1 meter, (c) earth moving equipment, electrical hazards, (d) work in confined space (limited exits, potential for oxygen less than 19.5%, (e) toxic or combustible atmosphere, (f) potential for solid or liquid engulfment, or (g) other hazards considered to be immediately dangerous to life or health such as: (1) water tanks, transformer vaults, sewers, cisterns, etc.), or (2) hazardous materials (especially those used indoors, such as paints, solvents, etc.) then additional requirements regarding safety must be specified here as defined by the Post Occupational Safety & Health Officer (POSHO.)]

(b) Records. The Contractor shall maintain an accurate record of exposure data on all accidents incident to work performed under this contract resulting in:

- (1) Death,
- (2) Traumatic injury,
- (3) Occupational disease, or
- (4) Damage to or theft or loss of property, materials, supplies, or equipment.

The Contractor shall report this data as directed by the Contracting Officer.

(c) Subcontracts. The Contractor shall be responsible for its subcontractors' compliance with this clause.

(d) Written Program. Before starting the work, the Contractor shall:

- (1) Submit a written proposal for implementing this clause; and

(2) Meet with the Contracting Officer to discuss and develop a mutual understanding of the overall safety program.

(e) The Contracting Officer shall notify the Contractor of any non-compliance with these requirements and the corrective actions required. The Contractor shall immediately take corrective action after receiving the notice. If the Contractor fails or refuses to promptly take corrective action, the Contracting Officer may issue an order suspending all or part of the work until satisfactory corrective action has been taken. The Contractor shall not be entitled to any equitable adjustment of the contract price or extension of the performance schedule for any suspension of work issued under this clause.

### 13. WORKING HOURS

All work shall be performed during the hours of 1530 until 2330 Monday through Friday and between 0600 and 2200 on holidays or weekends. The holidays are identified in clause 652.237-72. Other hours, if requested by the Contractor, may be approved by the Contracting Officer's Representative. The Contractor shall give 24 hours in advance to COR who will consider any deviation from the hours identified above. Changes in work hours will not be a cause for a price increase.

### 14. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

## ATTACHMENT 1: SCOPE OF WORK

### 1.1 GENERAL

The Contractor shall install 25 window consular microphone upgrade system in accordance with the provided engineering package drawings provided in Attachment 2.

### 1.2 REQUIREMENTS

- 1.2.1 The Contractor shall provide the equipment listed in the PRICES section of Block 23. All equipment shall be as specified but shall not be limited to the items specified herein.
- 1.2.2 The contractor shall provide the necessary personnel and installation tools required to perform this work, as well as a proposed schedule for completion.
- 1.2.3 The Contractor shall complete the entire installation of all equipment and all 25 window systems within the time frame specified in paragraph 2 of the Schedule for Supplies/Services – Block 20.
- 1.2.4 During the installation and cutover, the Contractor shall ensure that no more than 5 of 25 windows are unavailable during normal Consular business hours, which are Monday-Friday (excluding holidays), 0700-1530.
- 1.2.5 The Contractor shall install ceiling paging speakers #1-12 in the Non-Immigrant Visa (NIV) Waiting Room and the NIV half of the applicant entrance lobby (right side of engineering drawing layout plan).
- 1.2.6 The Contractor shall install ceiling paging speakers #13-24 in the Immigrant Visa (IV) Waiting Room and the IV half of the applicant entrance lobby (left side of the engineering drawing layout plan).
- 1.2.7 The Contractor shall connect the public address paging function of Officer Windows #1-13 to ceiling paging speakers #1-12.
- 1.2.8 The Contractor shall connect the public address paging function of Officer Windows #14-25 to ceiling paging speakers #13-24.
- 1.2.9 The Contractor shall demonstrate that all Officer Side gooseneck microphones provide adequate audio volume to the associated Applicant Side window speaker when activated.

- 1.2.10 The Contractor shall demonstrate that all Officer Side headset microphones provide adequate audio volume to the associated Applicant Side window speaker when activated.
- 1.2.11 The Contractor shall demonstrate that all Officer Side gooseneck microphones provide adequate audio volume to all associated Waiting Room Ceiling Mounted Public Address speakers when the public address function is activated.
- 1.2.12 The Contractor shall demonstrate that all Officer Side headset microphones provide adequate audio volume to all associated Waiting Room Ceiling Mounted Public Address speakers when the public address function is activated.
- 1.2.13 The Contractor shall demonstrate that audio volume from the officer gooseneck microphone or headset microphone to the Applicant Side window speaker can be adequately adjusted and muted by the Officer Side window equipment.
- 1.2.14 The Contractor shall demonstrate that audio volume from the officer gooseneck microphone or headset microphone to all associated Waiting Room Ceiling Mounted Public Address speakers can be adequately adjusted and muted by the Officer Side window equipment.
- 1.2.15 The Contractor shall demonstrate that all Applicant Side microphones provide adequate audio volume to the associated Officer Side window speaker when the applicant is speaking.
- 1.2.16 The Contractor shall demonstrate that all Applicant Side microphones provide adequate audio volume to the associated Officer Side headset when the applicant is speaking.
- 1.2.17 The Contractor shall demonstrate that all audio from the Applicant Side microphones to the associated Officer Side window speaker can be adequately adjusted and muted by the Officer Side window equipment.
- 1.2.18 The Contractor shall demonstrate that all audio from the Applicant Side microphones to the associated Officer Side headset can be adequately adjusted and muted by the Officer Side window equipment.

### 1.3 ACCESS

The Government shall provide adequate personnel to permit the installation contractor the necessary access and escort required during installation.

### 1.4 TYPE OF EQUIPMENT

The Contractor shall propose and furnish only equipment that is adequate to complete performance under this contract.

1.5 REMOVAL OF EXISTING MICROPHONE SYSTEM

The Contractor shall remove and discard all replaced equipment from the previous Consular Microphone and Paging System.

1.6 OTHER REQUIREMENTS

The Contractor shall provide for all transportation, lodging, shipping, and per diem expenses for all installation equipment and personnel.

- (3) That it shall comply fully with all laws, decrees, labor standards, and regulations of said country or countries during the performance of this contract.

(b) If the party actually performing the work will be a subcontractor or joint venture partner, then such subcontractor or joint venture partner agrees to the requirements of paragraph (a) of this clause.
