BASIC FUNCTION¹: The incumbent has the lead on development the content of the U.S. Interests Section internet and social media sites, working in collaboration with the PAS Systems Manager and Media/Program Assistant. The incumbent manages the Mission's Facebook page and looks for other innovative and creative ways to reach Cuban youth audiences and the general public, most of whom do not have access to the internet, by using new and emerging information technologies, including social networking applications and other media mechanisms. The incumbent will also develop monthly electronic distribution products with information on U.S. policy and current events and assist with coordinating and facilitating educational and information technology courses.

REQUIRED QUALIFICATIONS: All applicants must provide specific and comprehensive information addressing each selection criterion below.

1. A Two years college/university study is required.
2. Must have three years of administrative, government services, or para-professional experience, including experience in the arts, designing, managing or updating a public website or other social media, preparing software applications, teaching courses, and applying new media applications.
3. Level III (Good Working Knowledge) sp/read English; and Level II (Limited Knowledge) sp/read Spanish is required. (Test to be administered by the Human Resources Office (HR)).
4. Good knowledge of website design and layout. Knowledge of the latest developments in web content management and use of new information technologies, including social networking and other new media applications. Good general knowledge of Cuban cultural, educational, socioeconomic and political structure and institutions.

SELECTION CRITERIA: Management will consider nepotism, conflict of interest, budget, and residency status in determining successful candidacy, as well as the following:

1. Preference: When equally qualified, U.S. Citizen Eligible Family Members (USEFMs) and U.S. Veterans will be given preference. Therefore, it is essential that the candidate address the required qualifications above in the application.

2. Probation: Employees serving a probationary period are not eligible to apply.
3. Waiting Period: Currently employed U.S. Citizen EFM's who hold an FMA appointment are ineligible to apply for advertised positions within the first 90 calendar days of their employment. Currently employed NORs hired under a Personal Services Agreement (PSA) are ineligible to apply for advertised positions within the first 90 calendar days of their employment, unless currently hired into a position with a When Actually Employed (WAE) work schedule.

1. Application for employment (DS-174).
2. Form DD-214, if claiming U.S. Veterans' preference.
3. Any other documentation (copies of essays, certificates, awards, degrees earned, etc.) that addresses the qualification requirements of the position as listed above.

DEFINITIONS:

1. Eligible Family Members (EFM):
 - a) Children who are unmarried and under 21 years of age or, regardless of age, are unmarried and incapable of self-support. The term "children" shall include natural offspring, step-children, adopted children, and those under permanent legal guardianship (at least until age 18), or comparable permanent custody arrangement, of the employee or spouse when dependent upon and normally residing with the guardian or custodial party; ... and
 - b) Spouse or same-sex domestic partner as defined in 3 FAM 1610.
2. U.S. EFM: An EFM eligible for direct hire employment on either a Family Member Appointment (FMA) or Temporary Appointment (TEMP) that is also:
 - a) A U.S. citizen; and
 - b) The spouse or domestic partner (as defined in 3 FAM 1610) of the sponsoring employee, or a child of the sponsoring employee who is an unmarried *child* at least 18 years old; and
 - c) Listed on the travel orders or approved Form OF-126, *Foreign Service Residence and Dependency Report*, of a sponsoring employee, i.e., a direct-hire Foreign Service, Civil Service, or uniformed service member who is permanently assigned to or stationed abroad at a U.S. mission, or at an office of the American Institute in Taiwan; and who is under chief of mission authority, and either:
 - (i) Resides at the sponsoring employee's post of assignment abroad or, as appropriate, at an office of the American Institute in Taiwan; or
 - (ii) Resides at an involuntary separate maintenance allowance (ISMA) location authorized under 3 FAM 3232.2. If residing at an ISMA location, the individual will not be listed on the sponsoring officer's travel orders, but will have a Form SF-1190, *Foreign Allowances Application, Grant and Report*, processed authorizing ISMA.
3. Member of Household: A MOH is a person who: 1) Has accompanied, but is not/not on the travel orders of a U.S. citizen Foreign or Civil Service employee or uniform service member permanently assigned to or stationed at a U.S. Foreign service post or establishment abroad; 2) Has been declared by the sponsoring employee to the Chief of Mission as part of his/her household; and 3) Resides at post with the sponsoring employee.
4. Ordinarily Resident (OR): A citizen of the host country or a citizen of another country who has shifted the main residency focus to the host country and has the required work and/or residency permits for employment in country.
5. Not Ordinarily Resident (NOR): Typically NORs are US Citizen EFM's and EFM's of FS, GS, and uniformed service members who are eligible for employment under an American USG pay plan, on the travel orders and under Chief of Mission authority, or other personnel having diplomatic privileges and immunities.
