QUALIFICATION REQUIREMENTS

NOTE: All applicants are instructed to address each selection criterion detailed below with specific and comprehensive information supporting each item.

1. Completion of secondary school is required in addition to vocational training or a recognized plumbing apprenticeship.
2. Two years of work experience as a plumber is required.
3. Must have a thorough knowledge of plumbing trade.
4. Must be able to use and operate all tools and equipment for the plumbing trade. Must be able to perform preventive maintenance as well as repairs.
5. Must have a valid local driver's license for motor bike.
6. Level 2 (Limited knowledge) Speaking/Reading/Writing English is required (this will be tested). Level 4 (Fluent) Speaking/Reading/Writing Vietnamese is required.
