



**NOTICE
ON VISA APPLICATION FEE COLLECTION
IN VIETNAM DONG
AND ADDITIONAL COLLECTION SITES
FOR VISA RENEWAL**

In an effort to improve customer service to Non-Immigrant Visa applicants, effective **August 8, 2013** there will be two major improvements with the U.S. visa application fees collection:

- I. The visa application fee will be collected in local currency, Vietnam Dong.
- II. Applicants for visa renewal can pay the fee for non-petition-based visas at seven (7) additional sites besides Citibank offices in Hanoi and Ho Chi Minh City.

I. LOCAL CURRENCY COLLECTION:

The visa application fee will be collected in Vietnam Dong per the following schedule. Citibank will no longer accept U.S. dollars.

1. Applicants for most nonimmigrant visas pay a fee of **VND3,440,000** (subject to change in the exchange rate). These include:
 - B-1/B-2 visa for tourist and short-term business/conference
 - C1/D visa for crew/transit aliens
 - I visa for media
 - F/M/J visa for student/exchange
2. Applicants for petition-based visas pay a fee of **VND4,085,000** (subject to change in the exchange rate). Petition-based visa categories include:
 - H visa for temporary workers and trainees
 - L visa for intra-company transferees
 - O visa for aliens with extraordinary ability
 - P visa for athletes, artists and entertainers
 - Q visa for international cultural exchange visitors
 - R visa for religious occupationsIf you are uncertain about your visa category and which fee you should pay, please pay the lower fee of **VND3,440,000** at Citibank and an additional \$30 (in U.S. dollar cash or by credit card) at the U.S. Embassy Hanoi or Consulate General HCMC on the day of your visa interview, if required. The Embassy and Consulate General do not accept VND.
3. Applicants for K – Fiancé(e) or Spouse of U.S. citizen category visas pay a fee of **VND5,160,000** (subject to change in the exchange rate). **This fee is only payable at Citibank Ho Chi Minh City, in VND only.**
4. The fee for E visas for treaty-traders and treaty-investors is \$270. Citibank does not currently accept the \$270 fee. Applicants should pay this fee in U.S. dollar cash or by credit card at the U.S. Embassy Hanoi or Consulate General HCMC on the day of visa interview. The Embassy and Consulate General do not accept VND.

A copy of the bio page of a valid passport must be presented at the time of payment.

Upon collection of the application fee, Citibank will provide applicant with a two-part receipt. Both parts must be presented at the Embassy/Consulate General at the time of the interview. Each applicant including children must pay the fee and have a separate fee receipt. The application fee is a one-time, non-refundable fee.

II. ADDITIONAL COLLECTION SITES:

Applicants qualified for the visa renewal program will have additional options for the VND3,440,000 fee (fee for non-petition-based visas) collection sites. This fee will be payable at Eximbank branches at seven (7) cities and provinces besides Citibank offices in Hanoi and Ho Chi Minh City.
