If you would like to submit a quotation, follow the instructions in Section 3 of the solicitation, complete the required portions of the attached document, and submit it to the address shown on the Standard Form 1449 that follows this letter.

The Embassy intends to conduct a site visit on May 12, 2015 in following order:

- 11:00 hours – Gate-C, American Embassy, Chandragupta Marg, New Delhi, India.

Prospective offerors who desire to participate in the site visit should send their interest at vedij@state.gov no later than 1200 hours on or before May 11, 2015 for arranging entry of their participants into the building. No substitutions will be permitted later. Complete names and contact numbers of the individuals participating in the site visit should be provided, and the participants must carry a valid ID proof like driving license or passport or voter ID card during the site visit.

Questions after the site visit may be sent at vedij@state.gov on or before May 14, 2015 by 1200 hours. Responses will be sent in writing to all prospective bidders.

Your quotation must be submitted electronically by email with the subject line “Solicitation for supply of chemicals & providing professional services for HVAC water treatment” to newdelhibids@state.gov on or before 1300 hours (New Delhi time) on May 19, 2015. Please do not forward your quotations via courier. Quotations received after the due date and time shall be dealt with in accordance with the procedures in FAR provision 52.212-1(f).

In order for a quotation to be considered, you must also complete and submit the following:

1. The covering SF-1449 form (Blocks 12, 17, 24 and 30). Blocks 23 and 24 should list the total value of the quote.
2. Section 1, Block 23
3. All additional information as required in Section 3 – Solicitation Provisions. Instructions to Offeror.
4. Section 5, Representations and Certifications; complete the appropriate certifications and representations.


Please note that the Government shall reject proposals that do not contain the above information, or are otherwise incomplete.
