**Payment terms:**

Partial payment is authorized, based on actual expenses incurred for the services provided during performance of the contract, duly certified by the COR. Vendor can submit one invoice per month on the last day of that month for the services provided during that particular month. Partial payments are only authorized for up to 75 percent of the total contract cost. Please note that USG does not make advance payments.

The remainder of the balance due will be paid upon successful completion of the workshop for the services provided during performance of the contract, duly certified by the COR.

The American Embassy, New Delhi is exempt from payment of Service Tax per Ministry of External Affairs Notification No. D-II/451/12(43)/2007(II) dated July 18, 2012 and Ministry of Finance, CBEC Notification No.27/2012-Service Tax dated June 20, 2012. If requested, the Embassy will submit an undertaking, in original and bearing a running serial number and date, stating that the service rendered is for official use of the Mission along with a copy of this Certificate to the vendor/service provider for availing the exemption.

***QUALITY ASSURANCE PLAN (QAP).***

This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2 STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection

clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

### 3 PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

**Administrative/Logistics Support for Joint India-U.S. Workshop on  
Disease Surveillance and Health Security in South Asia**

**Background**

The Global Disease Detection Program in India (GDD-India) established a GDD India Center at the National Center for Disease Control in 2010 through a Memorandum of Understanding (MOU) between the U.S. Department of Health and Human Services (HHS) and the Indian Ministry of Health and Family Welfare (MoHFW). One of the goals of GDD-India Center is to strengthen the public health capacity in India and within the region as it relates to the International Health Regulations (IHR). One aspect of IHR is disease surveillance and ensuring health security at both the national and regional level.

The GDD India Program would like to hold a workshop between US, India and regional partners highlighting the importance of public health security and disease detection in April 2013.

**Purpose**

This contract is designed to provide administrative and logistical support for the workshop scheduled to take place in April 2013. In order to ensure proper planning and implementation of a workshop representing both the US and Indian government in a regional setting, the workshop planning needs to be initiated 8-9 months in advance in order to invite international speakers, reserve a venue, and ensure participants are notified in advance for scheduling purposes.

**Terms of Reference**

This contract is designed to provide administrative and logistical support for a regional workshop, featuring international speakers and approximately 100-150 participants from the United States, India, and the South Asia region.

- 1.) Create and maintain a contact database with names, titles, e-mail addresses, phone numbers, mailing addresses of potential participants from the regional Ministries of Health and key public health universities and institutes. (Deadline: within 30 working days of contract award)
  - a. Maintain RSVP's for workshop utilizing contact database.
  - b. Provide the final contact database to GDD-India, ensuring all contacts are correct and updated. **(Estimated Deadline May 2013)**
- 2.) Create a marketing plan to advertise the workshop based on initial conversations with conference committee. (Deadline: within 20 working days of contract award)
  - a. Create a theme (coordinated colors, designs, and logo) for the workshop. (Deadline: within 20 working day of contract award)
  - b. Create HTML e-mails with pertinent information and send to potential participants. (Deadline: within 20 working days of contract award)

  - a. Design and print large banner for the workshop venue. (Deadline: March 2013)

  - c. Hang banner and signs; maintain signage for the duration of the workshop.

- 4.) Conduct registration for the workshop
  - a. Send e-mail to all identified potential participants related to the workshop.  
(Deadline: within 40 working days of contract award)
  - b. Send e-mail reminders to all identified participants to request registration forms. (Deadline: January 2013)
  - c. Collect all registration forms and compile workshop participant list.  
(Deadline: March 2013)
  - d. Collect information re: hotels and negotiate a group rate (including ground transportation to/from airport) for workshop participants; provide information to potential participants. (Deadline: within 30 working days of contract award)
  - e. Provide invitation letters to regional/international participants, if needed for visas. (Deadline: within 40 working days of contract award)
  - f. Provide support for India visas for regional/international participants, facilitating the visa process, if needed. (Deadline: January 2013)
  - g. Provide a registration table at the workshop; provide a full-time person to conduct registration during the workshop. This full-time person will be available to answer general questions and provide logistics support.

It automatically qualifies as a women-owned small business eligible under the WOSB Program.

“Forced or indentured child labor” means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

“Inverted domestic corporation”, as used in this section, means a foreign incorporated entity which is treated as an inverted domestic corporation under [6 U.S.C. 395\(b\)](#), *i.e.*, a corporation that used to be incorporated in the United States, or used to be a partnership in the United States, but now is incorporated in a foreign country, or is a subsidiary whose parent corporation is incorporated in a foreign country, that meets the criteria specified in [6 U.S.C. 395\(b\)](#), applied in accordance with the rules and definitions of [6 U.S.C. 395\(c\)](#). “Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. - (6) Have been voluntarily suspended.

“Sensitive technology”—

  - (i) To restrict the free flow of unbiased information in Iran; or
  - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and
- (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act ([50 U.S.C. 1702\(b\)\(3\)](#)).

“Service-disabled veteran-owned small business concern”—
