1. PRICE AND PAYMENT

NOTIFICATION OF OPTION(S)

This purchase order includes an option(s) as addressed in the Schedule, Section II and attached Purchase Order Terms and Conditions. Contractor performance under this order constitutes acceptance of the order and all terms and conditions, including all options.

MINIMUM AND MAXIMUM AMOUNTS

During this contract period, the Government shall place orders totaling a minimum of **Rp5,000,000**. This reflects the contract minimum for this period of performance. The amount **of all orders** shall not exceed **Rp.1,650,000,000**. This reflects the contract maximum for unscheduled services for this period of performance.

1.2 Payment

Definitions

"COR" means Contracting Officer's Representative; see FAR 52.212-4 Contract Terms and Conditions – Commercial Items, in Section 2.

"Government" means the United States Government unless otherwise stated.

2. PERFORMANCE WORK STATEMENT

The Contractor shall provide Indonesian language instruction to adult students that focuses on the various professional topics including politics, economics, management, and areas of general interest, etc. This instruction shall also provide cultural lessons, and develop the conversational skills typically found in mass-media publications for the foreign language speaking public. The Contractor shall develop the instruction to include the development of speaking, listening, and reading, and writing skills. All instruction shall also include job relevant language terminology and usage of the designated field of interest.

Instruction shall be based on proficiency, communication, and academic principles as used in foreign language learning institutions identified below.

-Department of State, Foreign Service Institute;

All students shall be measured on their language proficiency levels in accordance with the Foreign Service Instituted Language Proficiency Test or the provider's own proficiency standards, if approved by the COR upon award of this contract.

3. PERIOD OF PERFORMANCE

Class shall be given according to schedules given in the Delivery Orders on Monday through Friday inside U.S. Embassy Facilities, unless mutually agreed upon by the Contractor and the Government. The period of performance of this contract is one year with one option year.

4. CONTRACTOR FURNISHED PROPERTY

4.1 The Contractor shall provide qualified instructor(s), who are well versed in all topics to be covered, capable of answering in-depth questions on each topic, will provide the required training in a classroom setting, based on the schedule of training modules or lessons and the objectives and goals for that training.

4.2 The Contractor shall provide instructor supervisor and administrator who will supervise the overall performance of work under the contract, and who will perform quality assurance in meeting the objectives and goals for that training.

4.3 The Contractor shall provide all instructional materials including texts, class exercises, handouts, tests, and audio-visual media.

4.4 The Contractor shall provide other required classroom materials such as newspapers, magazines, dictionaries, or photocopied materials, written in the designated language for use by students in exercises or testing.

5. GOALS OF FOREIGN LANGUAGE TRAINING

The goal of training is to provide the students with the Bahasa Indonesia skills and knowledge necessary to reach desired levels of performance for true beginner, basic, intermediate and advance students, for speaking, reading and writing.

6. STUDENT COUNSELLING, TEST AND EVALUATION

The Contractor's instructor(s) shall be responsible for monitoring student attendance, counseling each student on the student's performance, and preparing and discussing with the student any corrective actions which may assist the student in the improvement of their performance. The Contractor shall provide counseling to all students regarding performance as needed or desired.

Placement tests may be provided for new students as necessary to establish a baseline for measurement of knowledge and proficiency obtained, and may be used in a predictive manner to facilitate personal training planning.

Periodic tests or evaluations may be administered for following purposes:

- determine the student's progress in training;
- identify areas of weakness where supplemental training may be needed; and,

- quantify the student's then-current level of knowledge and proficiency.

7.1. Quality Assurance and Surveillance Plan (QASP). This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

7.1.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

7.1.2 STANDARD. The performance standard is that the Government receives no more than five (5) customer complaints per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

7.1.3 PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

“Economically disadvantaged women-owned small business (EDWOSB) concern” means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

“Forced or indentured child labor” means all work or service—

- (2) Federal Supply Group (FSG) 87, Agricultural Supplies;
- (3) FSG 88, Live Animals;
- (4) FSG 89, Food and Related Consumables;
- (5) FSC 9410, Crude Grades of Plant Materials;
- (6) FSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
