CONTINUATION OF SF1449 – SCHEDULE OF SUPPLIES/SERVICES (BLOCK 20): DESCRIPTION/SPECIFICATION OF WORK

This solicitation is to provide the function room and meeting services for the period of August 11 - 22, 2014. The provider should be at least a five-star hotel (or equivalent) which is located in Jakarta. There must be no construction or renovation on its premises during the above period. It must be able to provide the facilities and equipment needed as described below.

Meeting package:

1. Meeting Session for the period of August 11 - 22, 2014, to accommodate approximately up to 26 people a day. Below are detail specifications:
 - b. One (1) function room which can accommodate approximately twenty one (21) participants, three (3) instructors, two (2) interpreters and one (1) interpreter booth for the period of August 11 – 22, 2014 (10 days, excluding Saturday and Sunday) from 09.00 – 17.00. Room should allow unobstructed view of screen from all tables, there must be no structural support columns; there must be no sound permeating from other adjoining function rooms or other areas. Room to be set up in modified classroom arrangement (fishbone arrangement) as described in Appendix 1 & 2. A registration area with one (1) desk and two (2) chairs should be set up outside the function room. Free flow of water must always be provided during the training session. Markers, Flip Chart, Screen, and Sound System must be provided.
 - c. Two (2) times coffee break for twenty five (25) persons to be served in the morning and in the afternoon at 10.30 and 15.00 for the period of August 11 - 22, 2014 (10 days). It should be served at the foyer. Menu should include coffee, tea, and two kinds of snacks.
 - d. Lunch buffet for twenty five (25) persons for the period of August 11 - 22, 2014 (10 days), to be served at 12.00 noon – 01.00 pm. It should be served at the hotel restaurant. Menu should be mix local and western food with free flow of water.
 - e. Equipment and supplies required in Function Room
One (1) podium with one (1) standing microphone, one (1) LCD projector, one (1) projection screen, one (1) flipchart or erasable white board, markers, one (1) table for speakers and one (1) table for three (3) instructors, extension cord and one (1) power strip with at least three (3) connectors, bottled water and delegate amenities (pens, notes, candies) for attendees.

A concierge to support any problems related to conference equipment is required.
 - f. Photographer service to take group photo for the thirty (30) attendees on August 11th and 18th, 2014. It will be one (1) pose and it will be printed into twenty five (25) copies. Presentation folders will be provided for proper print size.

Rooms and other required facilities/services:

2. Parking access for at least 10 hrs./day for ten (10) motorbikes and twelve (12) cars for the period of August 11 – 18, 2014 (8 days)
3. Provider should have Business Center facilities with facsimile, secretarial and mailing services. All cost for the business center must be charged on the actual basis. Only charges made by the seminar coordinator will be paid by the Embassy.
4. Provider should be able to provide sleeping rooms with internet service (in-room) and access to executive floor or lounge.

SECTION IV. EVALUATION FACTORS

The Government intends to award a contract/purchase order resulting from this solicitation to the lowest priced, technically acceptable offeror/quoter who is a responsible contractor. The evaluation process shall include the following:

(a) **COMPLIANCE REVIEW.** The Government will perform an initial review of proposals/quotations received to determine compliance with the terms of the solicitation. The Government may reject as unacceptable proposals/quotations that do not conform to the solicitation.

(b) **TECHNICAL ACCEPTABILITY.** Technical acceptability will include a review of past performance and experience as defined in Section 3, along with any technical information provided by the offeror with its proposal/quotation.

(c) **PRICE EVALUATION.** The lowest price will be determined by multiplying the offered prices times the estimated quantities in "Prices - Continuation of SF-1449, block 23", and arriving at a grand total, including all options. The Government reserves the right to reject proposals that are unreasonably low or high in price.

(d) **RESPONSIBILITY DETERMINATION.** The Government will determine contractor responsibility by analyzing whether the apparent successful offeror complies with the requirements of FAR 9.1, including:

- Adequate financial resources or the ability to obtain them;
- Ability to comply with the required performance period, taking into consideration all existing commercial and governmental business commitments;
- Satisfactory record of integrity and business ethics;
- Necessary organization, experience, and skills or the ability to obtain them;
- Necessary equipment and facilities or the ability to obtain them; and
- Otherwise qualified and eligible to receive an award under applicable laws and regulations.
