

The purpose of this amendment is to clarify the following: : 1. During the site visit, the relocation of the eastern side of the consular CAC fence was discussed, the western side of the fence relocation was not discussed. However, the SOW clearly requires all 156 meters of fence to be relocated. The work includes the demolition of existing concrete pad, installation of concrete footing and resurfacing of the damaged area. Continued on page 2

2. The contractor is responsible to install required concrete base. The electrical drawing shows a field light to be installed attached to an existing container. Line item 17 on drawing (REC5 E101) is deleted. All six (6) light poles are to be erected in concrete footing. No light poles shall be mounted on a container.
3. BAS wires shall be ran using existing manholes outside. A core drilling through the outside wall is not required.
4. The revised drawing will be distributed in hard copy to all interested parties.
