WORK HOURS: Full-time; 40 hours/week

SALARY: \$13,040 per annum (Plus 35% Differential of basic salary; 15% of basic salary for Unique Conditions of Work Allowance) **Paid in US Dollars.**

LENGTH OF HIRE: 1 - 5 years (1 year with 4 optional years)

U.S. Embassy in Baghdad is seeking an individual for the position of Chauffeur in the General Services Office of U.S. Embassy Baghdad.

BASIC FUNCTION OF POSITION

The primary purpose of this Position is to provide support by driving, transporting and loading and unloading baggage, supplies and other miscellaneous duties as required to over 1,500 clients. Incumbent is responsible for the safe transport of passengers and/or cargo within the International Zone. Area of responsibility for driving could be expanded or further restricted per security considerations. Incumbent provides driver support 24 hours a day, seven days a week. Work hours are based on a 40-hour work-week; chauffeurs must be prepared to work substantial overtime.

QUALIFICATIONS REQUIRED

All applicants must address each selection criterion detailed below with specific and

comprehensive information supporting each item.

1. Completion of secondary education up to the 10th grade is required.
2. Prior work experience of no less than two years of professional driving experience is required.
3. Language requirements include level II (Limited knowledge) of both English and Arabic.
4. Thorough knowledge in the operation of light duty passenger and/or cargo vehicles, either gasoline or diesel to include automatic and standard (manual) shift transmissions. Must have knowledge in passenger safety, including the use of passenger seatbelts and safe driving.
5. Other requirements include: possession of a valid driver's license from home country; skills in defensive driving techniques and recognizing developing hazardous road and traffic conditions including having good judgment to adjust driving methods to the practices of surrounding traffic; skilled in customer service methods and practices (based on past experience and recommendations); basic office technology skills such as computer, phone, scanner, printer and photocopier use.

DEFINITION

A third-country national (TCN) is an individual who meets the following criteria.

- (1) Is neither a citizen of the United States nor of the country to which assigned for duty.
- (2) If employed, is eligible for return travel to the TCN's home country or country from which recruited at U.S. Government expense.
- (3) Is on a limited appointment for a specific period of time.
- (4) Encumbers a direct-hire, personal service agreement (PSA) FSN position covered under the TCN local compensation plan. Such an employee normally is recruited from outside the host country and relocated from the point of recruitment to the host country. The return travel obligation assumed by the U.S. Government may have been the obligation of another employer in the area of assignment if the employee has been in substantially continuous employment which provided for the TCN's return to home country or country from which recruited.

Hired TCN Staff are considered separate from the Locally Employed Staff (LES) because they have separate Local Compensation Plan and nationalities. Candidates are expected to be employed at the U.S. Mission in Iraq from one to five years.

Chauffeur Capsule Position Description FSN - 3

The incumbent drives numerous types of vehicles in an extremely high security threat environment to include light-duty fully-armored, light-armored, and unarmored passenger and/or cargo vehicles. These vehicles may include: sedans, mini-buses, utility trucks, passenger vehicles, all terrain vehicles (“Gators”), vans, etc. The incumbent must also operate golf carts to transport passengers or cargo for multiple purposes such as regular scheduled runs, specific assignments, and various assorted requests. The incumbent must perform or oversee the loading and unloading of vehicles. Additionally, the employee must ensure that any and all passengers are adhering to U.S Government laws of motor vehicle safety by using all safety practices and procedures. The driver must be able to evaluate road situations and execute maneuvers appropriately. The incumbent is expected to be knowledgeable on common locations out of the Embassy compound. Furthermore, the employee may be responsible for the basic condition of the vehicle, to include cleanliness, as well as some dispatching duties and record keeping.
