**1. SCOPE OF SERVICES**

- A. The contractor shall furnish various cleaning services for real property owned and leased by the U.S. Government at *Embassy Tel Aviv* in accordance with Attachment 1 (Scope of Services).
- B. The Government will order all work by issuing task orders.
- C. This is an indefinite-delivery indefinite-quantity type contract under which may be placed firm-fixed price task orders.

**2. CONTRACT PRICE - GENERAL**

- A. The Contractor shall complete all work, including furnishing all labor, material, equipment and services, required under this contract, for cleaning services. This price listed below shall include all labor, materials, overhead (including cost of Workers' Compensation and War-Hazard Insurance, which shall not be a direct reimbursement) and profit.
- B. All prices are in local currency and the Government will make payment in local currency.
- C. VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to VAT; this percentage is multiplied only against that portion. It is reflected for each performance period

**7. QUALITY ASSURANCE PLAN (QAP)**

**This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.**

**8.1SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

**8.2. STANDARD.** The performance standard is that the Government receives no more than two (2) [customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

**8.3. PROCEDURES.**

- (a) **If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.**
- (b) **The COR will complete appropriate documentation to record the complaint.**
- (c) **If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.**
- (d) **If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.**
- (e) **The COR shall, as a minimum, orally notify the Contractor of any valid complaints.**
- (f) **If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.**
- (g) **The COR will consider complaints as resolved unless notified otherwise by the complainant.**
- (h) **Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the *Inspection clause*.**

**ATTACHMENT 1 – PERFORMANCE WORK SCHEDULE**

1. **SCOPE OF WORK**

**1.1 General.** The contractor shall provide services for the U.S. Embassy Tel Aviv as described herein. Residential cleaning services refer to cleaning performed in Government-owned and -leased residences in accordance with the Light and Standard Services as outlined in section 3 below. Performance requirements for required work items are defined below.

**1.2 Personnel.** The contractor shall provide a qualified work force meeting the requirements set forth in the paragraphs below.

**2. General Requirements.**

**2.1 Definitions.**

"General Instructions" mean those instructions, directives and guidelines that apply to all contractor personnel.

“Standard Services-House” means those cleaning services required to be executed when accomplishing a full clean on any one villa or house.

“Standard Services—Apartment” means those cleaning services required to be executed when accomplishing a full clean on any one apartment.

“Light Services” means those cleaning services required to be executed when accomplishing a light clean on a house or apartment.

“Deluxe Clean” means performing all of the Standard Services plus shampooing carpets and cleaning upholstery (a wet clean). This is reserved for houses and apartments identified as requiring cleaning service above and beyond what would normally be needed in a cleaning due to neglect, or mistreatment of the premises by tenants, catastrophic damage, break in, or natural disaster. The additional difficulty and requirement for more time on site are reflected in the compensation for this level of service.

“Full Clean” means performing all of the Standard Services on any one house or apartment unit.

“Light Clean” means performing all of the Light Services on any one housing unit.

“Additional Services” means those cleaning services requested in addition to the Light or Standard Services on any one housing unit.

“Housing Unit” means a villa, house, apartment or cottage apartment, including any garage, car park, porch, patio, and/or storage area.

The contractor shall prepare general instructions for the work force. These general instructions must be approved by the Contracting Officer's Representative (COR) prior to issuance. The contractor shall provide these drafts to the COR for review within thirty days after award of the contract.

### **3.0 Types of Services**

#### **3.1 LIGHT SERVICES**

Light Services, as defined above, shall include:

##### **SWITCH PLATES**

All electric light switch plates will be cleaned of dust, grime, fingerprints, and paint marks.

##### **FLOORS**

Floors will be swept and then wet mopped so they are free of dust, dirt, and marks, no debris can be left in any corner, or behind any furniture or appliance.

##### **FURNITURE**

All wood surfaces must be dusted and polished with a spray wax cleaner. All drawers should be cleaned inside with a mild soap and cleared of dust and debris. Formica/tile surfaces shall be cleaned with a mild soap and wiped dry free of streaks. Glass surfaces should be wiped with a glass cleaner and dried so they are streak free.

##### **APPLIANCES**

All appliances will be cleaned inside and out with a non-toxic, non-abrasive cleanser. All residual food materials must be removed. Appliances include washer, dryer, refrigerator, freezer, range or gas top, oven, dishwasher, and air conditioning units.

##### **BATHROOMS**

All bathroom fixtures will be thoroughly cleaned using a non-abrasive cleanser. Metal fixtures will be free of water spots and hard water build-up, and lightly polished. Sinks, tubs, shower stalls, and commodes will be cleaned and disinfected, and any hard watermarks or rust will be removed. All watermarks will be removed from tile surfaces and mirrors. Grout will be cleaned with bleach, if necessary, to remove any stains or mildew. Shower stalls, including doors and their tracks, will be cleaned of hard water build-up, debris and mildew. Shower stall door slots must be cleaned of all dirt, debris, grime, and mildew. Mirrors should be wiped with a glass cleaner and dried so they are streak free.

## DOORS

All doors, doorframes, door handles, and glass panes shall be cleaned of dirt, grime, scuffs, fingerprints, marks, and water spots.

## LIGHT FIXTURES/CEILING FANS (Inside and Out)

Glass fixtures will be removed, cleaned inside and out and replaced. Bulbs will be dusted. Spotlights shall be cleaned and dusted. Fans will be cleaned of all dirt and dust, top and bottom, on both sides of the blades.

## GARAGES/CAR PARKS/UTILITY ROOMS

Garages and/or carports and driveways will be swept. Utility rooms must be cleaned, including swept, mopped, and dusted. All rubbish and debris will be removed from all shelves, cabinets, under the sink, and behind any appliances..

## PATIOS, PORCHES, AND ENTRYWAYS

Patios, porches, and entryways will be swept clean and all debris removed. All debris shall be removed from these areas including pigeon droppings, which should be scraped off and then the area should be washed clean.

## DEBRIS REMOVAL

The contractor will remove all debris and trash from the premises and insure that no cleaning residue remains.

### **3.2 STANDARD SERVICES (FULL CLEAN)--HOUSE**

Standard Services—House, as defined above, shall include all services listed under 3.1 Light Clean and the following:

#### WALLS

All walls will be free of dirt and marks. Walls will be cleaned with general-purpose detergent solution, including the baseboards. Baseboards and trim should be cleaned free of paint marks and scuffs. Large pieces of furniture will be moved and the walls behind them thoroughly cleaned. Electric outlet and light switch covers will be cleaned of all dust, grime, fingerprints, and paint marks.

#### FLOORS

Floors will be free of all dirt, grease, and black marks. After thorough cleaning all tile floors will be buffed. Appliances and furniture and area rugs or carpets will be moved to clean the flooring under them. Carpets should be vacuumed,

#### FURNITURE

All wood surfaces must be dusted and polished with a spray wax cleaner. All drawers should be cleaned inside. Glass surfaces should be wiped with a glass cleaner and dried so they are streak free. Formica/tile surfaces shall be cleaned with a mild soap and wiped dry free of streaks.

Upholstered furniture must be vacuumed to removed dust and lint, including the undersides of cushions. All drawers should be cleaned inside with a mild soap and cleared of dust and debris.

#### APPLIANCES

All appliances will be cleaned inside and out with a non-toxic, non-abrasive cleanser. All residual food materials must be removed. Air conditioner filters must be removed, the lint and dust cleaned off, and washed in mild soap and water. Allow drying briefly before reinstalling. Appliances include washer, dryer, refrigerator, freezer, range or gas top, oven, dishwasher, and air conditioning units.

#### CABINETS and CLOSETS

All cabinets and closets will be thoroughly cleaned both inside and outside, top and bottom. All shelf paper and residual adhesive removed. (Cabinets include those in the kitchen and bathrooms, as well as wardrobes, storage units, and any other cabinets in the housing unit). Electricity/breaker boxes will be cleaned of dust and loose dirt. If there are carpets or tile in closets they should be vacuumed and/or washed as appropriate.

#### BATHROOMS

All bathroom fixtures will be thoroughly cleaned using a non-abrasive cleanser. Metal fixtures will be free of water spots and hard water build-up, and lightly polished. Sinks, tubs, shower stalls, and commodes will be cleaned and disinfected, and any hard watermarks or rust will be removed. All watermarks will be removed from tile surfaces and mirrors. Grout will be cleaned with bleach, if necessary, to remove any stains or mildew. Shower stalls, including doors and their tracks, will be cleaned of hard water build-up and mildew. Shower stall door slots must be cleaned of all dirt, grime, and mildew. Mirrors should be wiped with a glass cleaner and dried so they are streak free.

#### WINDOWS AND SHUTTERS

All windows will be cleaned inside and out (when accessible) to remove all dirt and watermarks using commercial window cleaner. Shutters will be cleaned and all dirt and dust removed from individual slats and moving parts. Windowsills including tracks and slots will be cleaned and free of dirt and debris.

#### DOORS

All doors, doorframes, door handles, and glass panes shall be cleaned of dirt, grime, scuffs, fingerprints, marks, and water spots.

#### STAIRWELLS AND BANISTERS (Indoors and Out)

Stairwells will be thoroughly cleaned of cobwebs, dirt and dust. Banisters and railings will be cleaned and polished and all dust and fingerprints removed. Stairs shall be cleaned as per section C.2.2.2, FLOORS, above.

#### LIGHT FIXTURES/CEILING FANS (Inside and Out)

Glass fixtures will be removed, cleaned inside and out and replaced. Bulbs will be dusted. Spotlights shall be cleaned and dusted. Fans will be cleaned of all dirt and dust, top and bottom, on both sides of the blades.

#### GARAGES/CAR PARKS/STORAGE AREAS/UTILITY ROOMS

Garages and/or carports and driveways will be swept, tiled floors will be scrubbed. Any storage areas and/or utility rooms shall be cleaned, including swept, mopped, dusted, windows, walls, and doors washed. All rubbish and debris will be removed from all shelves, cabinets, under the sink, and behind any appliances.

#### PATIOS, PORCHES, AND ENTRYWAYS

Patios, porches, and entryways will be swept clean of debris and washed down with a cleaning solution and water. All debris shall be removed from these areas including pigeon droppings, which should be scraped off and then the area should be washed clean with cleanser.

#### DEBRIS REMOVAL

The contractor will remove all debris and trash from the premises and ensure that no cleaning residue remains.

### **3.3 STANDARD SERVICE (FULL CLEAN)—APARTMENT**

Standard Services—Apartment, as defined above shall include:

#### WALLS

All walls will be free of dirt and marks. Walls will be cleaned with general-purpose detergent solution, including the baseboards. Baseboards should be cleaned free of paint marks and scuffs. Large pieces of furniture will be moved and the walls behind them thoroughly cleaned. Electric outlet and light switch covers will be cleaned of all dust, grime, fingerprints, and paint marks.

#### FLOORS

Floors will be free of all dirt, grease, and black marks. After thorough cleaning all tile floors will be buffed. Appliances and furniture and area rugs or carpets will be moved to clean the flooring under them. Carpets should be vacuumed.

#### FURNITURE

All wood surfaces must be dusted and polished with a spray wax cleaner. All drawers should be cleaned inside. Glass surfaces should be wiped with a glass cleaner and dried so they are streak free. All cabinets and closets will be thoroughly cleaned both inside and outside, top and bottom. All shelf paper and residual adhesive removed. (Cabinets include those in the kitchen and bathrooms, as well as wardrobes, storage units, and any other cabinets in the housing unit).

Electricity/breaker boxes will be cleaned of dust and loose dirt.

If there are carpets or tile in closets they should be vacuumed and/or washed as appropriate.

#### BATHROOMS

All bathroom fixtures will be thoroughly cleaned using a non-abrasive cleanser. Metal fixtures will be free of water spots and hard water build-up, and lightly polished. Sinks, tubs, shower stalls, and commodes will be cleaned and disinfected, and any hard watermarks or rust will be removed. All watermarks will be removed from tile surfaces and mirrors. Shutters will be cleaned and all dirt and dust removed from individual slats and moving parts.. Windowsills including tracks and slots will be cleaned and free of dirt and debris.

#### DOORS

All doors, doorframes, door handles, and glass panes shall be cleaned of dirt, grime, scuffs, fingerprints, marks, and water spots.

#### STAIRWELLS AND BANISTERS (Indoors and Out)

Stairwells will be thoroughly cleaned of cobwebs, dirt and dust. Banisters and railings will be cleaned and polished and all dust and fingerprints removed. Stairs shall be cleaned as per section 3.3 FLOORS, above.

#### LIGHT FIXTURES/CEILING FANS (Inside and Out)

Glass fixtures will be removed, cleaned inside and out and replaced. Bulbs will be dusted. Spotlights shall be cleaned and dusted. Fans will be cleaned of all dirt and dust, top and bottom, on both sides of the blades.

#### STORAGE AREAS/UTILITY ROOMS

Any storage area belonging to the apartment, even if it is not attached to the apartment, shall be cleaned, including swept, mopped, dusted, windows, walls, and doors washed. All rubbish and debris will be removed from all shelves, cabinets, under the sink, and behind any appliances.

### PATIOS, BALCONIES, AND PORCHES

Patios, balconies, and porches will be swept clean of debris and washed down with a cleaning solution and water. All debris shall be removed from these areas including pigeon droppings, which should be scraped off and then the area should be washed clean.

### DEBRIS REMOVAL

The contractor will remove all debris and trash from the premises and insure that no cleaning residue remains.

### **3.4 DELUXE CLEAN**

Deluxe Clean shall include all of the above services that are included in a Standard service (Full Clean), as well as the additional service;

### SHAMPOOING OF CARPETS

All area rugs and wall-to-wall carpets must be shampooed using either a standard water-shampoo method or a dry shampoo machine. Stains must be pretreated.

### CLEANING OF UPHOLSTERY

Wet clean and shampoo the upholstery and treat the wooden parts with non-abrasive wood cleanser.

### EVERYTHING RETURNED TO SALEABLE CONDITION

Make every effort to find all possible dirt and debris, ensuring the next tenant will find a clean home inspite of the best efforts of previous tenants to leave a mess.

## **4.0 ADDITIONAL SERVICES**

Services, as defined above, shall include:

### **4.1 CLEANING OF ADDITIONAL ROOMS**

Cleaning of additional Rooms shall include all of the services for Standard Services stated above, but only for single rooms.

### **4.2 WINDOW TREATMENTS**

All mini-blinds will be taken down, cleaned thoroughly with mild soap and water, and replaced.

### **4.3 CLEANING RESIDENTIAL FURNITURE/UPHOLSTRY**

Wet clean and shampoo the upholstery and treat the wooden parts with non-abrasive wood cleanser.

## **5.0 Management and Supervision.**

### **5.1 Contractor Management.**

**Supervision.** The contractor shall designate a representative who shall be responsible for supervision of the contractor's workforce during all times that services are being delivered under this contract. This supervisor shall be the focal point for the contractor and shall act as liaison with U.S. Embassy personnel. The supervisor shall have sufficient English language skills to be able to communicate with members of the U.S. Embassy staff.

**Quality Control.** Quality control shall be the responsibility of the contractor. The contractor shall perform inspection visits to the work sites on a regular basis. On some of these visits, which shall be a surprise to those working on the contract, the contractor shall be accompanied by the COR. Should the COR at any time determine that the quality of the work is not adequate on a particular job, the contractor shall redo the work as directed by the COR for no additional charge, even if another day is required.

## **6.0 LOCATIONS FOR SERVICES**

All services shall be performed at residential properties in the Tel Aviv, Herzelia Pituach, Herzelia Bet, Kohavit Safon, and Kfar Shemaryahu areas. The Government reserves the right to add additional areas to this contract if the need arises.

The Contractor shall furnish to the Government, when and if ordered, the supplies or services specified in the Schedule up to and including the quantity designated in the Schedule as the “maximum.” The Government shall order at least the quantity of supplies or services designated in the Schedule as the “minimum.”

(c) Except for any limitations on quantities in the Order Limitations clause or in the Schedule, there is no limit on the number of orders that may be issued. The Government may issue orders requiring delivery to multiple destinations or performance at multiple locations.

(d) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. (5) Furnishing information about whether any person is a member of, has made contributions to, or is otherwise associated with or involved in the activities of any charitable or fraternal organization which supports the State of Israel; and,

(6) Paying, honoring, confirming, or otherwise implementing a letter of credit which contains any condition or requirement against doing business with the State of Israel.

An inverted domestic corporation as herein defined does not meet the definition of an inverted domestic corporation as defined by the Internal Revenue Code at 26 U.S.C. 7874.

“Manufactured end product” means any end product in Federal Supply Classes (FSC) 1000-9999, except—

- (1) FSC 5510, Lumber and Related Basic Wood Materials;
- (2) Federal Supply Group (FSG) 87, Agricultural Supplies;

- (4) FSG 89, Food and Related Consumables;

- (5) FSC 9410, Crude Grades of Plant Materials;
- (6) FSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). (m) *Restricted business operations in Sudan*. By submission of its offer, the offeror certifies that the offeror does not conduct any restricted business operations in Sudan.

(n) *Prohibition on Contracting with Inverted Domestic Corporations*.

(1) *Relation to Internal Revenue Code.* An inverted domestic corporation as herein defined does not meet the definition of an inverted domestic corporation as defined by the Internal Revenue Code 25 U.S.C. 7874.

(2) *Representation.* By submission of its offer, the offeror represents that—

- (i) It is not an inverted domestic corporation; and
- (ii) It is not a subsidiary of an inverted domestic corporation.

(o) Prohibition on contracting with entities engaging in certain activities or transactions relating to Iran.

(1) The offeror shall e-mail questions concerning sensitive technology to the Department of State at CISADA106@state.gov.

(2) *Representation and Certifications.* Unless a waiver is granted or an exception applies as provided in paragraph (o)(3) of this provision, by submission of its offer, the offeror—

(i) Represents, to the best of its knowledge and belief, that the offeror does not export any sensitive technology to the government of Iran or any entities or individuals owned or controlled by, or acting on behalf or at the direction of, the government of Iran;

(ii) Certifies that the offeror, or any person owned or controlled by the offeror, does not engage in any activities for which sanctions may be imposed under section 5 of the Iran Sanctions Act; and

(iii) Certifies that the offeror, and any person owned or controlled by the offeror, does not knowingly engage in any transaction that exceeds \$3,000 with Iran's Revolutionary Guard Corps or any of its officials, agents, or affiliates, the property and interests in property of which are blocked pursuant to the International Emergency Economic Powers Act (50 U.S.C. 1701 et seq.) (See OFAC's Department of Treasury, Office of Foreign Assets Control's (OFAC) Specially Designated Nationals and Blocked Persons List at <http://www.treasury.gov/ofac/downloads/t11sdn.pdf>.)

(3) The representation and certification requirements of paragraph (o)(2) of this provision do not apply if—

(i) This solicitation includes a trade agreements certification (*e.g.*, 52.212-3(g) or a comparable agency provision); and

(ii) The offeror has certified that all the offered products to be supplied are designated country end products.

**ADDENDUM TO REPRESENTATIONS AND CERTIFICATIONS  
FAR AND DOSAR PROVISION(S) NOT PRESCRIBED IN PART 12**

**The following DOSAR provision is provided in full text:**

**652.225-70 ARAB LEAGUE BOYCOTT OF ISRAEL (AUG 1999)**

(a) Definitions. As used in this provision:

Foreign person means any person other than a United States person as defined below.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
