DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

- I. The items to be purchased through this purchase order is the translation system which must meet the below technical specifications, warranty and other terms as stated.

High quality indoor wireless translation system of well-known brand, utilizing IR digital technology, to be used with 200 audiences, with body packs wireless receivers, and detachable lightweight stereo headsets. System includes two 4-channels digital interpreter consoles, and two interpreter lights and microphone for floor speaker.

The system can work as a standalone, or can be integrated with discussion microphone and conference camera system if desired.

At least six Infrared panels of medium power with wall mounts are needed to be distributed in two separate halls.

The halls where the system is installed are ever-changing in terms of space and functionality. This has to be considered in the system design for mobility and easy setup.

II. Warranty

The translation system shall come with a minimum 1-year warranty.

III. Delivery Location and Time

- A. The Contractor shall deliver all ordered items to the US Embassy located at Al Amawiyeen street, Amman 11118, Jordan.
- B. The Contractor shall deliver all items not later than 60 days after date of order award.
- C. Any Contractor personnel involved with the delivery of the items shall comply with standard U.S. Embassy regulations for receiving supplies. The Contracting Officer will be responsible for instructing contractor personnel at the time deliveries are made. Prior notice of at least 2 (two) working days is required.
- D. Delivery shall be made between the hours of 09:00 and 16:00 on regular workdays, Sunday through Thursday.
