The U.S. Embassy in Amman is seeking an individual for the full-time Program Management Assistant position in the Southern Syria Assistance Platform Office (SSAP).

### BASIC FUNCTION OF POSITION

The Southern Syria Assistance Platform (SSAP) Program Management Assistant is responsible for providing broad support to the SSAP. The incumbent will work under the direction of the team lead designated by the SSAP Coordinator to support SSAP programming and coordinate the efforts of the SSAP with the Embassy and Mission, USG officials, and other key partners, and to identify emerging issues stemming from the Syria crisis, as well as funding and programmatic opportunities. The ability to obtain and maintain a Secret level security clearance is required.

### QUALIFICATIONS REQUIRED

**Note: Items 1-5 are ALL REQUIRED. All applicants must address each selection criterion detailed with specific and comprehensive information supporting each item.**

- Education:** Bachelor's degree in international relations or development, political science, economics, journalism, business, or other relevant degree is required.  
**Supporting documents (diploma) must be included in the application for eligibility purposes.**
- Experience:** At least three to five years of professional experience in international affairs, business, program management, international development, journalism or research is required.
- Language:** Level 4 (fluent) English, reading, written and spoken, including the ability to draft in English using proper grammar and spelling is required.

4. **Knowledge:** Knowledge of international development processes, including but not limited to: policy, budgeting, program design and development, and donor coordination is required. Understanding and awareness of basic U.S. foreign policy in the Middle East is required.
5. **Abilities & Skills:** Strong analytical and interpersonal/teamwork skills, and excellent written and oral communication skills are required. Good computer skills, including Word, Power Point, and the development of spreadsheets/tracking systems are required. The ability to comprehend and synthesize a vast array of documentation (e.g., strategies, project documents, data and foreign assistance information, etc.) is required. Ability to interpret, analyze, and present data to a variety of audiences is required. Ability to work in teams is required.

## **SELECTION PROCESS**

When equally qualified, U.S. Citizen Eligible Family Members (USEFMs) and U.S. Veterans will be given preference. Therefore, it is essential that the candidate address the required qualifications above in the application.

## **ADDITIONAL SELECTION CRITERIA**

1. Only U.S. citizen EFM\*s as defined by 3 FAM 8200 of U.S. Government employees assigned to post under Chief of Mission authority are eligible for consideration.
2. Management will consider nepotism/conflict of interest, budget, and residency status in determining successful candidacy.
3. Current employees serving a probationary period are not eligible to apply.
4. Currently employed U.S. Citizen EFM\*s who hold an FMA appointment are ineligible to apply for advertised positions within the first 90 calendar days of their employment.
5. Currently employed NOR\*s hired under a Personal Services Agreement are ineligible to apply for advertised positions within the first 90 calendar days of their employment, unless currently hired into a position with a When Actually Employed (WAE) work schedule.
6. EFM\*s candidates must have at least nine months remaining at post from the closing date or they will not be considered.
7. EFM\*s not yet at post must be within 90 days of their arrival in order to be considered.
8. The candidate must be able to obtain and hold a SECRET security clearance.

## **TO APPLY**

All application packages must include:

1. Submit the Application for U.S. Federal Employment [DS-174](#).
2. A current resume or curriculum vitae.
3. Any other documentation (e.g. certificates, awards, copies of degrees earned) that addresses the required qualifications for this position. (**Education certificates must be included or the application will not be considered**).
4. Driver's license copy if applying for a position that requires driving a vehicle.
5. EFM, USEFM, and AEFM\*s applicants must clearly indicate their status in the text or subject line of their application.
6. Candidates who claim U.S. Veterans preference must provide a copy of their Form DD-214 with their application. For more information on Veteran's Preference go to <http://www.opm.gov/veterans/>.

7. List any relatives or members of your household that work for the U.S. Government (include their name, relationship, agency, position and location). Any omission in this area, either intentional or unintentional, is cause for dismissal.

## **\*DEFINITIONS**

1. **Eligible Family Member (EFM)**: For employment purposes, an EFM is a spouse, domestic partner (DP- as defined in 3 FAM 1610), or unmarried child at least 18 years of age of a US direct-hire FS, CS, or uniformed service member who is:
- Listed on the travel orders or approved OF-126 of a direct-hire FS, CS, or uniformed service member assigned to the Mission under COM authority; and,
  - Residing at the sponsoring employee's post of assignment abroad.
2. **U.S. Citizen Eligible Family Member (USEFM)**: For purposes of receiving a preference in hiring for a qualified position, a USEFM is an individual who meets the following criteria:
- US citizen; and
  - The spouse or domestic partner (as defined in 3 FAM 1610) of the sponsoring employee, or a child of the sponsoring employee, who is an unmarried child 18 to 20 years old; and
  - Listed on the travel orders or approved Form OF-126 of the sponsoring employee, (i.e., a direct-hire FS, CS, or uniformed service member who is permanently assigned to or stationed abroad at a US mission, and is under COM authority) and either:
    - a) Resides at the sponsoring employee's post of assignment abroad; or
    - b) Resides at an involuntary separate maintenance allowance (ISMA) location (the individual will not be listed on the sponsoring officer's travel orders, but will have a processed Form SF-1190 authorizing ISMA).

*Other family members or dependents on direct-hire FS, CS, or uniformed service member's travel orders who do not meet all of these criteria are not USEFMs or AEFMs for employment purposes.*

3. **Appointment Eligible Family Member (AEFM)**: To be eligible for a Family Member Appointment or a TEMP appointment, an AEFM is:
- US citizen; and
  - The spouse or a domestic partner (as defined 3 FAM 1610) of the sponsoring employee, or a child of the sponsoring employee who is an unmarried child 18-20 years old; and
  - Listed on the travel orders or approved Form OF-126 of the sponsoring employee, (i.e., a direct-hire FS, CS, or uniformed service member who is permanently assigned to or stationed abroad at a US Mission who is under COM authority); and
  - Residing at the sponsoring employee's post of assignment abroad; and
  - Does not receive a USG retirement annuity or pension from a career in the Foreign Service or Civil Service. US citizen military annuitant EFM's are FMA eligible.

*Other family members or dependents on direct-hire FS, CS, or uniformed service member's travel orders or approved Form OF-126 who do not meet all of the criteria are not AEFMs or US citizen EFM's for employment purposes.*

4. **Member of Household (MOH)**: An individual who accompanies a direct-hire Foreign, Civil, or uniformed service member permanently assigned or stationed at a U.S. Foreign Service post or establishment abroad. An MOH is:
- Not an EFM; and,
  - Not on the travel orders of the sponsoring employee; and,
  - Has been officially declared by the sponsoring USG employee to the COM as part of his/her household.

*A MOH is under COM authority and may include a parent, unmarried partner, other relative or adult child who falls outside the Department's current legal and statutory definition of family member. A MOH does not have to be a U.S. Citizen.*

5. **Not Ordinarily Resident (NOR)** – An individual who:
- Is not a citizen of the host country; and,
  - Does not ordinarily reside (OR, see below) in the host country; and,
  - Is not subject to host country employment and tax laws; and,
  - Has a U.S. Social Security Number (SSN).

*NOR employees are compensated under a GS or FS salary schedule, not under the LCP.*

6. **Ordinarily Resident (OR)** – A Foreign National or U.S. citizen who:
- Is locally resident; and,
  - Has legal, permanent resident status within the host country; and,

- Is subject to host country employment and tax laws.

*EFM's without U.S. Social Security Numbers are also OR. All OR employees, including U.S. citizens, are compensated in accordance with the Local Compensation Plan (LCP).*
