1. TITLE AND COMMENCEMENT:

This Order shall be cited as "The Republican Order No.03/2013 for the **Withdrawal of all duly Delegated Powers Assigned to the Vice President of the Republic by the President of the Republic, 2013 A.D.**" and shall come into force on the date of its signature by the President of the Republic.


2. THE ORDER:

In exercise of the powers conferred upon me under Article 105(d) of the Transitional Constitution of the Republic of South Sudan, 2011 A.D., I,

General Salva Kiir Mayardit, President of the Republic of South Sudan, do hereby issue this Republican Order as hereunder:-

- (a) **withdrawal of all duly Delegated Powers Assigned to the Vice President of the Republic by the President of the Republic.**
- (b) **The Vice President of the Republic shall be restricted to exercise and discharge only his powers as stipulated in accordance with the Provisions of Article 105 (a), (b) and (c) of the Transitional Constitution of the Republic of South Sudan, 2011 A.D.**



2. THE ORDER:


In exercise of the powers conferred upon me under Article 97(3) of the Transitional Constitution of the Republic of South Sudan, 2011 A.D., read
