**PERFORMANCE WORK STATEMENT  
ANTI-PIRACY RADIO BROADCAST SERVICE  
COMBINED JOINT TASK FORCE-HORN OF AFRICA**

**1.0 GENERAL INFORMATION**

- 1.1 Introduction. This Combined Joint Task Force – Horn of Africa (CJTF-HOA) requirement is for media airtime to translate and broadcast CJTF-HOA messages and gather feedback/polling information from the Somalia public.
- 1.2 Scope. This Performance Work Statement (PWS) defines the tasks and performance characteristics of contract broadcast station to support US Government policies and objectives in Somalia.
- 1.3 Objectives. The objective is to translate and broadcast radio messages supplied by CJTF-HOA. In addition, use polling questions and garner feedback from written communication, phone calls, and SMS texts related to CJTF-HOA messages.

**2.0 DEFINITIONS**

- 2.1 "Broadcast" shall mean the distribution of audio and/or video signals, which transmit programs to a radio audience. The audience may be the general public or a relatively large sub-audience, such as children or young adults.
- 2.2 "CJTF-HOA", shall mean Combined Joint Task Force – Horn of Africa.
- 2.3 "Commercial" shall mean a pre-recorded ready for broadcast audio message (radio) of varying themes and durations.
- 2.4 "Contractor" shall mean any media vendor that responds to this solicitation and submits a quote or in the event of contract award, the media vendor awarded the contract.

2.5 "Conversations" shall mean any form of correspondence such as electronic messages, telephone or in person.

2.6 "TPOC" shall mean the Technical Point of Contact. The person, who has been designated by the Contracting Officer (CO) to monitor the awarded contractor's compliance within this related SOW. The TPOC further monitors contractor performance and reports directly to the CO. The TPOC can direct the contractor to perform duties within the scope of this PWS, but only the Contracting Officer (not the TPOC) shall authorize additional work outside the scope.

2.7 "Counter-Piracy" shall mean the purpose of creating community awareness on the activities and the scourge of piracy to the local community, to the country, and to the international community and commerce.

2.8 "Customer" shall mean CJTF-HOA.

2.9 "Delivery" shall mean, the contractor, by his own means, airing CJTF-HOA delivered messages (live or pre-recorded).

2.10 "Government" shall mean the United States of America.

### **3.0 TECHNICAL REQUIREMENTS.**

3.1 The contractor's desired experience is two years experience with radio broadcasting. The desired experience may include broadcasting anti-piracy messages over FM channels within the coverage areas of the semi-autonomous region of Puntland, to include the Bari, Nugal, and Mudug regions, Eastern Somaliland, and Somali areas of eastern Ethiopia.

3.2 Contractor's radio station, at a minimum must be able to broadcast on FM radio signals at frequencies from 88 to 90 megahertz in order to reach coverage areas of the semi-autonomous region of Puntland, to include the Bari, Nugal, and Mudug regions, Eastern Somaliland, and Somali areas of eastern Ethiopia.

### **4.0 TASKS.**

4.1 Contractor shall translate messages received from the TPOC from English to Somali. Contractor will translate an average of (1) message per week for not more than (3) messages per month. See Deliverables section for format and time requirements.

4.2 Contractor will broadcast Somali translated messages, approved and provided by the TPOC (3) times a day (morning, afternoon, and evening). Contractor will only broadcast TPOC approved messages. Messages on average will be (1) minute in duration for a total of (3) minutes per day. Broadcasted messages must reach local populations throughout the Puntland region. The TPOC will direct which messages to be played. Contractor shall ensure that all

broadcasted messages have a phone number to encourage listener response with phone call or SMS texting. See Deliverables section for format and time requirements.

4.3 Contractor shall conduct weekly polling from broadcasted messages. Polling questions will be provided by the TPOC. Contractor shall broadcast polling questions bi-weekly. See Deliverables section for format and time requirements.

4.4 Contractor will provide original and translated content of feedback from polling questions to the TPOC. Polling data submitted may be from phone calls and SMS texting responses. Contractor will also provide basic demographics (gender, general location, age), with detailed data regarding the answers provided by local populations. Polling data will be submitted to the TPOC in the format and time as required by the Deliverables section.

4.5 Contractor will provide monthly broadcasting schedules, to include the time and messages broadcasted as well as polling questions broadcasted. See Deliverables section for format and time requirements.

4.6 Contractor shall provide all CJTF-HOA produced messages in MP3 format audio file/recordings to the TPOC with the following sequence: one minute of radio station air time coverage before the CJTF-HOA message, the CJTF-HOA message and one minute of radio station air time coverage after the CJTF-HOA message. See Deliverables for format and time requirements.

## 5.0 IDENTIFICATION OF TECHNICAL POINT OF CONTACT

Upon contract award, TPOC will be identified in writing to the winning contractor.

## 6.0 VENDOR SURVEILLANCE.

6.1. Vendor surveillance will be accomplished through the use of Cubic monthly anti-piracy reports. Cubic compiles and monitors radio broadcasts throughout Puntland & Somaliland and tabulates positive, neutral and negative anti-piracy messages. In addition, they will specifically monitor the contractor for anti-piracy messages and translate the messages into English. The Government is able to verify that the contractor is broadcasting the required messages and the correct frequency of messages, and meeting the requirements of the PWS.

6.2 Vendor surveillance will also be conducted by the task in paragraph 3.7.

## 7.0 DELIVERABLES.

The following table depicts deliverables required by this PWS. All deliverables may be submitted earlier than the specified due dates, but the below is the standard to which the contractor will be held for successful accomplishment of the contract.

## 8.0 PERIOD OF PERFORMANCE.

Period of performance will be for (12) months from date of award. The desired start date of the POP is 28 May 2013.

## 9.0 SECURITY

9.1 The contractor shall be required to have a background check / security vetting under this contract which can include iris scanning, finger printing, and presentation of other personal information by CJTF-HOA J2X. The U.S. Government has the right to require additional background / security checks if deemed necessary by the U.S. Government. If it is determined at any time during the performance of this contract that the Contractor is a risk to U.S. Government personnel or property, this determination shall be grounds for immediate termination for default of this contract.

9.2 The Contractor may be required to work with business sensitive information in the performance of this contract. The contractor must comply with all provisions that are prescribed

in DFARS 252.204-7000 (Disclosure of Information) and DFARS 252.204-7003 (Control of Government Personnel Work Product)

9.3 The Contractor shall advise U.S. Government personnel if situations arise during conversations that could reflect adversely upon the U.S. Government.

9.4 All information to which the Contractor is exposed while in the presence of U.S. Government Officials shall be considered confidential in nature and shall not be disclosed to other parties.

Contractor shall not discuss U.S. Government business outside of official duties.

9.5 In certain cases the contractor may be required to continue their services during a level of heightened state of threat. The contractor shall continue to provide services to the best of their ability.

#### **10.0 CONTRACTOR IDENTIFICATION**

10.1 Contractor employees shall be clearly identified while on U.S. Government property by wearing appropriate badges or other visible identification methods.

10.2 Contractor personnel must identify themselves as contractors during meetings, telephone conversations, in electronic messages, or correspondence related to this order.

Price will be evaluated but not rated on an adjectival scale. Each Offeror's quote shall be evaluated to determine if it is complete, reasonable, and consistent with the Offeror's technical approach, whether it reflects a clear understanding of the solicitation requirements, and whether it contains any material imbalances. A quote may be deemed unbalanced if the pricing methodology illustrates unreasonable variances in the establishment of the unit or quantity price ranges. An offer may be deemed unbalanced if the mathematical approach is unreasonable. As such, a quote (inclusive of all CLINs) may have the lowest evaluated price; however, the offeror's methodology used to arrive at the price may not be in the best interest of the Government. Quotes that are materially unbalanced, unrealistically high or low, or otherwise not in the Government's best interest may be rejected.

#### **Past Performance**

Past performance will be evaluated in order to satisfy FAR Part 9 Responsibility Determinations. However, for purposes of this procurement, past performance will not be evaluated as a formal evaluation factor, used to differentiate between offerors. A lack of past performance is simply a [neutral] rating, and does not impact a responsibility determination.

#### **Other Considerations**

The Offerors shall submit their proposals based on the most favorable terms in order to reflect their best possible potential. The Government will view unrealistic proposals – e.g., impractical technical or schedule commitments, or lack of price realism – as indicative of a lack of understanding of the complexity and risk of the contract requirements.

(b) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.
