I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price Contract is to perform a thorough performance assessment of the financial and program systems currently in place for the past five years from October 1, 2009 to September 30, 2014 to quantify the losses of commodities incurred, and to drive continuous improvements in the Kenya HIV supply chain system. A subset of this assessment will be to verify the effectiveness of financial and system internal controls and to recommend process and control improvements; thereby ensuring commodities reach the people in need and mitigate the risk of local and/or transcontinental diversion in accordance with Performance/ Specifications/ Work statement of this contract.

- B. The contract will be for 6 months (180 days) beginning from the date of award.

- C. At the end of each two month period and upon delivery of an interim report accepted by the COR as per section 3.1.3 below, payment equivalent to 30% of the contract amount will be made to the contractor after each two months. At the conclusion of the project and delivery of the final report and accepted by the COR as per section 3.1.4 below, the final payment of 40% of the amount of the contract will be made.

1. BACKGROUND

The United States Government (USG) President's Emergency Plan for AIDS Relief (PEPFAR) team comprising of the PEPFAR Coordination Office, the United States Agency for International Development (USAID), the Centers for Disease Control and Prevention (CDC), the Department of Defense through the United States Army Institute of Research - Kenya and the Peace Corps in Kenya work with several host government agencies including the Ministry of Health, other local and international non – governmental organizations, academic institutions as well as private sector entities to implement PEPFAR activities. These efforts include interaction through various acquisition and assistance funding mechanisms with such organizations throughout the Republic of Kenya.

PEPFAR Kenya must exercise proper oversight in the business services area of acquisition, assistance and financial management. In doing so, must ensure delivery of HIV commodities to those areas most affected by HIV/AIDS, and through implementing partners, report out on the number of people tested for HIV and placed on treatment. In recent years, PEPFAR Kenya, has had challenges in accounting for a significant number of rapid test kits (RTK) – received in country, distributed to the various hospitals/health clinics and reported on by implementing partners. Please note that PEPFAR has been providing kits to approximately 6,000 locations throughout Kenya.

The Supply Chain Management System (SCMS) operates a supply chain to procure and distribute pharmaceuticals and other commodities needed to provide care and treatment of persons with HIV/AIDS. SCMS is an IOC (Indefinite Quantity Contract) managed from Washington and USAID Kenya bought into the contract in September 2005. SCMS' Kenya office closed in September 30th 2013 though SCMS made a few purchases for Kenya thereafter. The PEPFAR program transitioned supply chain management to the Kenya Medical Supply Authority (KEMSA) in December 2012. It took several months for this transition to occur and for KEMSA to become operational. In Fiscal Year 2012, SCMS procured and distributed over 11 million RTKs in Kenya. However, according to the Annual Program Report 2012, only seven million tests were conducted, with many stock-out reports from across the country. Several internal assessments conducted by PEPFAR Kenya have yielded little results in determining why the country continues to experience stock out of RTK's and under reporting of test administered.

2. SCOPE OF WORK

- a. Contractor shall perform a comprehensive assessment of Kenya's public sector HIV commodity supply chain, to include their financial and internal systems controls. The 4 commodities to be reviewed include:
 - 1) Rapid Test Kits (RTKs)
 - 2) Fluconazole
 - 3) Cotrimazole

4) Methadone

- b. Contractor shall gauge internal control strength across a representative sample of 5% of supply chain locations (both central and facility based) for each focus area (human resources, quantification processes, monitoring and evaluation, port clearing and customs, transportation, receiving, storage and distribution from facilities (this is to include both KEMSA and Kenya Pharma warehouses from the Port of Mombasa). Attached is a list of all PEPFAR supported sites for sampling consideration in Exhibit A
- c. Contractor shall provide a written report on their findings and recommendation for improvements to the supply chain processes, internal controls and financial systems. These recommendations should be categorized as high, medium, low – to help prioritize corrective and preventative actions. Recommendations should also include high level implementation plans. Further the contractor should recommend near term versus medium and longer term corrective actions.
- d. Contractor shall estimate the quantity of commodities (the 4 listed above) lost across all supply chain locations and for each step in the supply chain. Any loss identified shall be characterized/identified in one of the following areas: central warehouse facility and/or stage in the supply chain location, down to and including the facility level, and by geography and by commodity type.
- e. Contractor shall identify any fraud, waste, abuse and the mishandling or misconduct in procurement procedures and supply chain processes.
- f. Contractor shall perform a financial review of funding allocated to purchase commodities, expenditures on commodities and products procured.
- g. Contractor shall report on the status and reliability of the contractors/agencies managing PEPFAR commodities (these include Kenya Pharma, KEMSA and SCMS).
- h. Contractor shall clearly identify any sources of weaknesses, at all levels within the supply chain management system including recommendations for improvement.
- i. Contractor shall quantify level of commodity diversion, or product unaccounted for, from PEPFAR supported integrated prevention, care and treatment programs implemented by partners on the ground.
- j. Contractor shall collaborate and coordinate with PEPFAR Kenya team, Kenya public Health officials and other implementing partners. Contractor shall not conduct themselves or convey information that will give the appearance that the Contractor is a U.S. Government representative or is authorized to make decisions on behalf of the U.S. Government.
- k. Contractor shall travel locally within the borders of Kenya for the purpose of conducting the audit.
- l. Contractor shall furnish all the necessary personnel, facility to base and work, supplies, equipment (laptops, flash drives, blackberries, local cell phone and minutes) required to perform these services and in accordance with U.S. Government and the Government of Kenya labor and tax laws.

- m. PEPFAR/ the US Government will not provide office space.
- n. Contractor's staff shall have the language capability (Kiswahili and regional dialects) to conduct research in all of the targeted geographies and PEPFAR supported sites.

3. CONTRACT MANAGEMENT AND ADMINISTRATION

3.1. The Contractor shall be responsible for the effective management and administration of all efforts undertaken under this contract. The Contractor shall be responsible for ensuring that all work activities are performed in a timely and cost effective manner while maintaining the highest quality of performance.

3.1.1 Project Plan

The Contractor shall develop a Project Plan for the assessment and shall as a minimum:

- a. Provide a detailed list of team composition, roles and expertise (including CVs detailing similar experience).
- b. Describe the approach, organizational resources and management controls to be employed to meet desired outcome;
- c. List the specific tasks to be accomplished;
- d. Document planning assumptions and recommendations;
- e. Document the project timeline for each task activity;
- f. Identify the task deliverables and the deliverable dates for Government review and acceptance;
- g. Provide the Project Plan within ten (10) business days of receipt of contract.

3.1.2 Contract Performance Reports

The Contractor shall develop and deliver a timely, complete and accurate biweekly Contract Performance Report (CPR) to the Contracting Officer's Representative (COR) no later than the second (2nd) business day of every other week. The CPR shall include but not be limited to the following:

- a. Work performed during the reporting period including: accomplishments, real and anticipated problems/issues and recommendations for corrections (this should be aligned with 3.1.1 b and 3.1.1 d);
- b. Work to be accomplished during the next reporting period (this should be aligned with 3.2 b and 3.2 d);
- c. Communication of the real progress of the program, taking into account the work completed, the time taken, the cost incurred to complete the work, and funding status;

- d. Immediate action required of the USG for the continued on-time and on-cost performance of the contract;
- e. Ad hoc information on project status on an as-needed basis and as directed by the COR;
- f. Highlight any issues that may occur during project implementation;
- g. Performance as measured against the Project Plan; and
- h. Lessons learned to date, with performance improvement recommendations.

3.1.3 The contractor shall develop and deliver interim reports at the end of every two months of work which will address interim progress on the areas included in the objective and scope. Value-added findings and recommendations outside of objective and scope are also welcomed. The interim reports should be prepared in hard and soft copy and reviewed during a working session with relevant representatives from the contractor, from PEPFAR and from the USG and should include: Key activities completed and key findings, interim recommendations for improvement, proposed action plan(s), preparation of suggested new Standard Operating Procedures (SOPs), implementation timelines and contractor POC for each recommendation.

3.1.4 Order Final Report/Evaluation

The Contractor shall develop and deliver a final report/evaluation specifically addressing those areas as stated in the objective and scope. Findings outside of objective and scope are also welcomed. The final report should be delivered in hard and soft copy and reviewed during a working session with relevant representatives from the contractor, from PEPFAR and from the USG and should include: a Corrective Action Preventive Action (CAPA) plan tracker. The tracker should include at the very least:

- a. Summary of key activities,
- b. Findings,
- c. Recommendations and proposed Action Plans,
- d. Associated SOPs,
- e. Timelines to address findings and implement improvements and
- f. Contractor Point of Contact for each key recommendation.

4. PLACE AND TIME OF PERFORMANCE.

Work under this contract shall be performed throughout Kenya.

6. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

6.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

6.2 STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

6.3 PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they shall immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(5) Furnishing information about whether any person is a member of, has made contributions to, or is otherwise associated with or involved in the activities of any charitable or fraternal organization which supports the State of Israel; and,

(6) Paying, honoring, confirming, or otherwise implementing letter of credit which contains any condition or requirement against doing business with the State of Israel.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
