

OREGON TO HOLD A SPECIAL ELECTION FOR CONGRESS – NOVEMBER 8

On Tuesday, November 8, 2011, Oregon will hold a special primary election for the 1st Congressional District, to fill the seat vacated by Representative David Wu. The 1st Congressional District includes parts of northwestern Oregon. This is a Special Primary election applicable only to those registered with the Democratic and Republican Parties. The General election will be held on Tuesday, January 31, 2012. In Oregon, the 1st District includes Clatsop County, Columbia County, Washington County, Yamhill County and part of Multnomah County which includes some of the Portland metropolitan area.

Register to Vote and Request Your Ballot Now!

If you are not already registered to vote, you may do so online at oregonvotes.org, or by submitting a Federal Post Card Application (FPCA). Your FPCA must be received by your local Oregon Elections Office by October 18, 2011. **Go to FVAP.gov and get started.** Alternatively, you may obtain an FPCA from the U.S. Embassy; you must still follow the Oregon instructions given at FVAP.gov. Indicate on the FPCA how you would like to receive your absentee ballot, by mail, email, or fax. You **will not** receive a ballot automatically, even if you voted in the November 2, 2010 general election. If you are already registered to vote, the deadline for submitting an FPCA to request a ballot is November 8, 2011.

Send the FPCA by Email, Fax or Mail

If you choose to **email** your FPCA, you should send the form to the email address listed below for the correct county office where you reside in the 1st Congressional District. If you choose to **fax** your FPCA, fax the form to the fax number listed below for the correct county office where you reside.

Receive Your Ballot

Ballots will be mailed and emailed to you starting on **September 24, 2011**. Your voted ballot must be **received by 8:00pm on November 8, 2011**, in order to be counted. You must return your voted ballot and signed affidavit by regular mail or fax, or you can send it via a licensed motor carrier such as Federal Express, UPS or DSL. Civilians in Malaysia can contact the U.S. Embassy for specific instructions on how voted ballots, with proper domestic postage attached, can be returned to the United States.

If a voter is concerned about not receiving their ballot in time to vote, they may use the Federal Write-In Absentee Ballot (FWAB, SF-186). The FWAB instructions are available at www.FVAP.gov. The FWAB is also available in embassies and consulates and military installations around the world. To check the status of your absentee ballot visit: <http://www.oregonvotes.org>.
