1. Performance Work Statement

This contract is for the Preventive Maintenance Services of Heidelberg SM102 Press Machine located at U.S. Embassy, GPS Building, Seafront Compound, Roxas Boulevard, Pasay City.

2. Period of Performance/ Schedule

The contract will be for a one-year period from the date of the contract award, with four (4) one-year options.

3. Pricing

The price shall be a firm-fixed price and shall include unlimited repair services (emergency service calls and preventive maintenance) and services of competent technicians(s), to be provided during the normal Embassy working hours and demonstrating to Government employees the procedures to follow in operating the machines and training them in the proper care of the machine.

The contractor shall be paid on a monthly basis at the firm fixed rate provided.

4. Deliveries

Preventive Maintenance Schedule. The Contractor shall perform the major services twice a year. The schedule of the services shall be six (6) months after the award of the contract and at the end of the contract. The exact dates shall be determined by the U.S. Government and shall be advised to the Contractor at least one week before the commencement of the bi-annual services.

5. Invoices and Payment

a) Preventive Maintenance Service- The Contractor shall submit a proper invoice to the COR on a monthly basis and shall be paid upon satisfactory completion of the services. The invoice shall be submitted to the address shown in paragraph (d) below. A proper invoice must include the following information and be certified (by an appropriate company officer)

- (1) Contractor's name and bank account information (for payments by Electronic Fund Transfer, EFT)
- (2) Invoice date.
- (3) Contract number.
- (4) This detailed invoice shall list a description of services provided during the time period involved.
- (5) The following signed statement:

“I certify that the services described in this invoices have been performed in accordance with the contract and that the price are true, correct and have not been previously billed.”

(6) Name, title, phone number, and address of person to contact in case of defective invoice.

b) If an invoice does not contain the above information, the Government reserves the right to reject the invoice as improper and return it to the Contractor within 7 calendar days. The Contractor must then submit a proper invoice.

c) It shall be the COR who will interact with the Contractor on any invoice problems.

d) The contractor shall send invoices to the following address:

e) The designated Government payment office for this contract is the Financial Management Center (FMC), Chancery Compound, 1201 Roxas Boulevard, Ermita, Manila.

f) Payment shall be made in local currency.

6. Government Approval and Acceptance of Contractor Employees

The Contractor shall subject its personnel to the Government's approval. The Government reserves the right to deny access to U.S. - owned and U.S. - operated facilities to any individual. All employees must pass a suitable investigation conducted by the Contractor, including recommendation(s) from their respective supervisor(s). The Contractor shall not use any employees under this contract without Government approval.

7. Key Personnel

The Contractor shall provide qualified, security-cleared, technically and physically fit personnel who shall keep the Press Machine in good working condition, perform inspection, adjustments, machine parts replacement and repairs as needed ,and as provided under this contract.

8. Personal Injury, Property Loss or Damage (Liability)

The Contractor hereby assumes absolute responsibility and liability for any and all personal injuries or death and/or property damage or losses suffered due to negligence of the Contractor's personnel in the performance of the services required under this contract.

9. Permits

Without additional cost to the Government, the Contractor shall obtain all permits, licenses, and appointments required for the work under this contract. The Contractor shall obtain these permits, licenses, and appointments in compliance with applicable host country laws.

ATTACHMENT I PERFORMANCE WORK STATEMENT

A. Performance Work Statement

The Contractor shall provide the following Preventive Maintenance Services to ensure that the machine is maintained in good working condition.

- The Contractor shall perform the Preventive Maintenance twice a year. The maintenance shall be scheduled six (6) months after the contract award and before the contract ends. The exact dates shall be determined by the U.S. Government (U.S.G.) and shall be advised to the Contractor at least one week before the commencement of the bi-annual maintenance.

The Preventive Maintenance covers the following Scope of Work:

- (1) Inspection, adjustment and lubrication of parts/components according to the Maintenance Check List.
 - (2) Comprehensive inspection and assessment of the technical condition and the operative capability of the press.
 - (3) Submission of a detailed report and recommendations.
 - (4) Cleaning of Automatic Blanket Wash Up Device twice a year.
 - (4.1) Pull-out of individual Blanket Wash Up Devie for all PU's using special tools.
 - (4.2) Dismantling of Blanket Wash-up Device in preparation for cleaning.
 - (4.3) Actual cleaning of the device, with the assistance of the GPS operators.
 - (4.4) Assembly of the device.
 - (4.5) Installation of Wash Up Device Assemblies for all PU's.
- The Contractor shall not replace any parts of the machine without prior approval from U.S.G. The replacement of the parts is not included in this contract. The Contractor shall identify and recommend all replacement parts necessary to maintain the equipment in operation according to the manufacturer's specification and provide an estimate for repair works to be performed. The USG shall make a determination as to the appropriate next course of action.
 - The Contractor shall replace worn parts according to the maintenance check list. All replacement parts shall be supplied by the USG.
 - In the event that the USG cannot supply the required parts, the Contractor may be required to submit a price quotation for these parts for review by the COR and approval by the CO.
 - The Contractor shall provide unlimited service calls for repairs and adjustments that require non-replacement of parts at no additional cost to the USG.

- Unlimited “on-call services” and “minor repairs”, excluding overhauling of press components and other major repairs, shall be verified by the assigned Contractor representative.
- The Contractor shall provide advice regarding optimal machine care.
- The Contractor shall conduct inspection, adjustment and lubrication, according to the maintenance check list, twice a year.
- The Contractor shall provide sample prints to check print quality, twice a year.
- The Contractor shall provide a comprehensive examination and assessment of the technical condition and the operative capability of printing presses, twice a year.
- The Contractor shall submit a detailed service report Heidelberg Certificate outlining the results and entries into the Heidelberg Logbook., after every Preventive Maintenance services. The service report shall be provided on the same day the PM is completed.
- The Contractor shall respond promptly within 4 working hours to oral service calls placed by the COR for the required services, during normal Embassy working hours (see Section D).
- The Contractor shall be provided full access to the Equipment, only after coordinating with the COR or his designated representative. However, the Contractor’s personnel must stay within the working site.

B. Operational Requirements

(1) **Equipment Demonstrations** – After the maintenance services, the Contractor must demonstrate to the COR that machine is in proper operating condition. The USG operators will print sample prints to verify the Contractor’s work.

(2) **Machine Movements**

The machine movement, on as needed basis, to any location within the GPS Building, other than its current location, shall be coordinated with the Contractor prior to the movement.

C. Quality Assurance Plan (QAP)

This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract.

The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

3. PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

D. Normal Business Hours for Government

The contractor shall provide all required types of maintenance services, installations, equipment demonstrations, replacement services from Monday to Friday, excluding holidays, during Embassy normal working hours of 7:30 AM. to 12:00 noon and 1:00 P.M. to 4:30 P.M.

- The lowest price will be determined by multiplying the offered prices times the estimated quantities in “Prices - Continuation of SF-1449, block 23”, and arriving at a grand total, including all options.
- The Government will determine acceptability by assessing the offeror's compliance with the terms of the RFQ to **include the technical information required by Section 3.**
- The Government will determine contractor responsibility by analyzing whether the apparent successful offeror complies with the requirements of FAR 9.1, including:
 - adequate financial resources or the ability to obtain them;
 - ability to comply with the required performance period, taking into consideration all existing commercial and governmental business commitments;
 - satisfactory record of integrity and business ethics;
 - necessary organization, experience, and skills or the ability to obtain them;
 - necessary equipment and facilities or the ability to obtain them; and
 - be otherwise qualified and eligible to receive an award under applicable laws and regulations.

- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.
