**SECTION 15641
OPEN-CIRCUIT, MECHANICAL DRAFT COOLING TOWERS**

PART 1 - GENERAL

1.1. WORK INCLUDED

- A. This Section specifies the requirements necessary to furnish complete prefabricated induced draft cooling towers for the Philippine site.

1.2. DESIGN CRITERIA

- A. Factory Mutual approved for operation without the requirement for fire protection sprinkling.
- B. Cooling tower thermal performance shall be certified by the Cooling Tower Institute in accordance with CTI Certification Standards STD-201 or, lacking such certification, a field acceptance test shall be conducted on a tower within the warranty period in accordance with CTI Acceptance Test Code ATC-105 by the Cooling Tower Institute or other qualified, independent agencies.
- C. Should the field performance test prove the tower's performance deficient, the cooling tower manufacturer shall bear all costs necessary to correct the deficiency, within a reasonable schedule, and shall reimburse the purchaser for any power increase required to meet the performance specification. The tower shall be re-tested and certified after all deficiencies are corrected.
- D. Tower shall be designed to ambient wetbulb temperature at specified temperature range, approach, and flow rates indicated on the equipment schedule.

1.3. SUBMITTALS

- A. Provide the following in addition to the standard requirements :
1. Structural steel support including dimensions, sizes, and locations for mounting bolt holes. Include weight distribution drawings showing point loadings.
 2. Total fan BHP (driver output).
 3. Motor Type, Manufacturer, efficiency, RPM.
 4. Motor Starter Manufacturer, type, Power Factor correction.
 5. Drift loss (percent of circulating flow).
 6. Evaporation loss (at design).
 7. Tower cells (to be provided).
 8. The cooling tower submittal shall include performance curves in accordance with Section 11 of ATC-105. A manufacturer's guarantee, performance bond, or test by the manufacturer will not be accepted as an alternative to CTI certification or an independent field test.

PART 2 - PRODUCTS

2.1 INDUCED DRAFT COOLING TOWERS

- A. Acceptable Manufacturers:
1. Baltimore Air Coil.
 2. Marley

- or Approved Equal
- B. Description: factory assembled, induced draft cross flow cooling tower with vertical air discharge.
- C. Casing: Type 304 stainless steel.
- D. Air Inlet Louvers and Fill: Fill shall be film type, thermoformed of 15 mil thick PVC, with Fiberglass Reinforced Polyester louver.
- E. Collection Basin:
1. Materials: Stainless steel Type 304.
 2. Provide suction configuration with debris screen and antivortexing device. Provide one float valve in each basin to automatically add makeup water. Provide stainless steel flumes for flow equalization between cells.
- F. Access:
1. Provide stainless steel sliding access doors on each end wall, operable from both sides, for access to eliminators and the fan plenum section. Where the cell arrangement requires access to interior cells through end cells, arrange access doors to allow access through abutted end walls and provide sump walkway.
 2. Where motors, drives, or other components are regularly maintained from the plenum, provide internal walkways. Provide access platforms to maintain equipment.
 3. Where motors, drives, or other components are regularly maintained from the top of the tower, provide cage ladders, handrails, and perimeter guardrail.
 4. All holes to be drilled prior to galvanizing.
 5. Provide a ladder to access door.
- G. Wet Deck and Drift Eliminators: integrally formed from PVC with eliminators designed to effectively strip entrained moisture from the leaving airstream with minimum air resistance. Materials shall be impervious to rot, decay, and fungus or biological attack.
- H. Water Distribution System: Construct open gravity type basins of galvanized steel. Provide distribution weirs and plastic metering orifices to assure even distribution of water over the wet-deck surfaces, and factory-installed integral lockable flow balancing valves to distribute flow evenly between distribution basins. Provide sliding sheet metal covers over the basin with a live-load capacity of 250 pounds. Provide Class 150 RF flanges for pipe connections over 2 inches in diameter.
- I. Fan Assembly: fixed pitch, heavy-duty, cast aluminum, axial flow fan(s), with a heavy-gauge galvanized wire guard over each. Spacing on wire guard must not exceed 4 inches and guard must support 250-pound weight in the center.

- J. Fan Shaft, Bearings, and Drive:
1. Right-angle gear drive with drive shaft, equipped with nonlubricated flexible couplings. Gear drive shall be a high quality and dependable product from a reputable manufacturer (U.S or German made).
 2. Support the fan and fan shaft with heavy duty, self-aligning, grease-packed relubricatable ball bearings with dust and moisture seals and integral slinger rings, minimum L10 life of 100,000 hours.
 3. Provide extended fill drain on gear drive units, and on either drive configuration when scheduled.
- K. Motor: totally enclosed, air-over (TEAO), squirrel cage, ball bearing type motor with lubricatable bearings, designed specifically for cooling tower service, with special moisture protection on windings, shafts, and bearings. Furnish two speed motors, unless specified otherwise on Data Sheets.
- L. Motor Starter: Provide combination type motor starter with 3P-250AT/400AF, 480v circuit breaker in Nema 4X Enclosure for each fan motor. Starters to be across the line type for motors 60 HP and below. For greater than 60 HP starters to be reduced voltage type. Provide two sets of extra contacts (dry type relay, 250 volt) for auxiliary start/stop and run status. Integrate vibration switch assembly into starter to shut down unit in case of excessive vibration.
- M. Corrosion Protection: All steel panels and structural elements, including the structural frames, louver supports, cold water basin, hot water distribution basins, fan duct and mechanical equipment supports are constructed of type 304 stainless steel. Air inlet louvers are non-corroding fiberglass reinforced polyester (FRP)
- N. Provide vibration switch for each fan to stop the fan on high vibration alarm. Maintain closed contacts will be wired to the motor starter, resettable from outside the unit.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

“Sensitive technology”—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—
 - (i) To restrict the free flow of unbiased information in Iran; or
 - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and
- (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—
