SECTION 1 - THE SCHEDULE

I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price contract is for the Contractor to provide all personnel, labor, expertise, supervision, supply of replacement parts and consumables (except copy paper), repair and maintenance services for U.S. Government-owned Fuji Xerox copiers, in accordance with Attachment 1. Copy paper shall be provided by the U.S. Government. Contractor-furnished services and supplies are to be provided on an indefinite quantity basis with delivery to U.S. Embassy Manila.
- B. This is an indefinite-delivery indefinite-quantity contract. The Government plans to issue task orders with a firm-fixed price per copy and a ceiling price based on estimated quantities.
- C. The contract will be for a one-year period from the date of the contract award.
- D. All prices shall be in Philippine currency.

II. PRICING

The Contractor shall be paid at the firm-fixed prices set forth below for all services satisfactorily performed under the contract. Payment for services rendered shall be made per month based on the number of actual copies made multiplied by the rate per copy. In the event that copies are not reproduced due to machine malfunction or other causes, the number of spoiled and test copies each month shall be accounted for by the Officer-in-Charge and will be deducted from the monthly meter charge. The locations of machines to be maintained under this contract are provided under Attachment 2.

MINIMUM AND MAXIMUM AMOUNTS

During this contract period, the Government shall place orders totaling a minimum of *35,000 copies*. This reflects the contract minimum for this period of performance. The amount of all orders shall not exceed *865,000 copies*. This reflects the contract maximum for this period of performance.

IV. PROVISION ON VALUE ADDED TAX (VAT)

The U.S. Government is exempt from payment of taxes as a qualifying entity under Section 3(b)(3) of Revenue Regulations No. 6-97 dated January 2, 1997. In accordance with this regulation, all sales made by contractors or suppliers to the U.S. Government are subject to zero percent (0%) rate and are, therefore, not subject to value added tax.

V. OFFICER-IN-CHARGE (OIC)

The Contracting Officer will provide the Contractor a list of Officer(s)-in-Charge for each machine to be maintained upon award of the contract.

The Officer(s)-in-Charge will be the Contractor's point of contact on issues relating to the machine. Should there be an issue that cannot be resolved at the Officer-in-Charge level, the Contractor shall elevate the issue to the Contracting officer for resolution. The Officer-in-Charge is responsible for reviewing and certifying invoices for payment.

ATTACHMENT 1

A. PERFORMANCE WORK STATEMENT

The services to be provided by the Contractor under this contract include the following requirements:

1. Preventive Maintenance Inspection (PMI)

(a) Preventive maintenance service shall include all cleaning, lubrication, necessary adjustments and replacement of parts deemed necessary by the Contractor to ensure operable condition of the machines. Preventive maintenance inspection of the machines shall be performed *once per month*. Upon completion of the maintenance service, a report certified by the Officer-In-Charge of the machine must be submitted to the Contracting Officer. Such report shall contain the following:

- 1) Contract Number
- 2) Model and Serial Number of all machines serviced during the period
- 3) Location of the machine
- 4) Signature of the Responsible Officer
- 5) Replaced/Repaired Parts

(b) Replacement/Repair Parts

Preventive maintenance and repair services to be provided under this contract shall include the supply of all parts and consumables at no additional cost to the Government.

2. Service Calls

(a) In addition to preventive maintenance inspections, the Contractor shall make unlimited number of service calls at no additional cost to the Government, when called for by the Contracting Officer or the Officer-in-Charge for each machine for the purpose of correcting equipment malfunctions.

(b) The Contractor shall furnish a malfunction incident report to the responsible officer of each machine with a copy furnished to the Contracting Officer upon completion of each service call. The report shall include the following:

- (1) date and time notified
- (2) date and time of arrival of service
- (3) type and serial number of equipment worked on
- (4) description of work accomplished/malfunction
- (5) list of parts replaced

- (c) Service calls shall include but not be limited to the following:
- (1) Removal of all foreign matter to include dirt, dust, rust, paper & lint.
 - (2) Removal of excess of accumulated amount of machine oil or other lubricants.
 - (3) Lubrication of equipment parts/components as necessary.
 - (4) Adjustments or calibration of equipment/parts as necessary.
 - (5) Replacement of worn, broken or failing parts/components.
 - (6) Cleaning of unit after each service.
 - (7) All other maintenance actions necessary to ensure proper operation and maintenance.
- (d) The Contractor shall respond to all service call requests within two (2) working hours of the date and time the Contractor is notified. Repairs must be completed within four (4) working hours. In the event that the service is not completed within four (4) working hours, the number of copies reproduced using other copying machines shall be accounted for by the Officer-in-Charge until the machine is returned to its operational condition. The total number of copies made multiplied by the rate per copy for the given year will be used in computing the total deduction and will be deducted from the Contractor's monthly billing.
- (e) When a service call requires replacement of parts not readily available, the Contractor shall complete the repair within forty eight (48) hours. In the event that the service is not completed within the time specified, the number of copies reproduced using other copying machines shall be accounted for by the Officer-in-Charge until the machine is returned to its operational condition. The total number of copies made multiplied by the rate per copy for the given year will be used in computing the total deduction and will be deducted from the Contractor's monthly billing. The Contractor shall take necessary action to avoid delay in the completion of a service call.
- (f) The Contractor shall replace all worn and/or inoperable parts to restore the machine in good operating condition. All parts/components furnished and installed by the Contractor in the performance of this contract shall be genuine replacement parts/components of a quality equal or superior to those originally installed by the machine manufacturer. The original design of the machine shall not be changed nor its functional capabilities altered in any way without the written approval of the Contracting Officer. Parts/components which are customarily rebuilt/remanufactured and recognized by the equipment manufacturer as suitable may be used, provided that the rebuilt/remanufactured parts/components are of quality equal to or exceeding new parts/components.

- (g) When the installation of replacement parts and/or repair parts is completed, the technician shall obtain a written certification from the Officer-in-Charge or his representative that the equipment is in good operating condition. A copy of the certification shall be submitted to the Contracting Officer.
3. This contract does not include the following:
 - (a) Services to copying machines not currently covered in the contract; and
 - (b) Furnishing or installing additional accessories (Optional Features), painting or refinishing the machine without the written approval of the Contracting Officer.
 4. Required Standard of Workmanship
 Unless otherwise specifically provided in this contract, the quality of all services rendered hereunder shall conform to the highest standards in the relevant profession, trade or field of endeavor. All services shall be rendered by or supervised directly by individuals duly qualified in the relevant profession, trade or field.
 5. On-Site Maintenance/Repair
 The Government will provide an adequate working space for the Contractor to perform on-site maintenance/repair.

QUALITY ASSURANCE PLAN (QAP).

This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QAP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

1. **SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2. **STANDARD.** The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

3. **PROCEDURES.**

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

"Data Universal Numbering System (DUNS) number" means the 9-digit number assigned by Dun and Bradstreet, Inc. (D&B) to identify unique business entities.

"Data Universal Numbering System+4 (DUNS+4) number" means the DUNS number assigned by D&B plus a 4-character suffix that may be assigned by a business concern. (D&B has no affiliation with this 4-character suffix.) This 4-character suffix may be assigned at the discretion of the business concern to establish additional **SAM** records for identifying alternative Electronic Funds Transfer (EFT) accounts (see the FAR at Subpart 32.111) for the same concern.

(b) (1) The Contractor shall be registered in the **SAM** database prior to submitting an invoice and through final payment of any contract, basic agreement, basic ordering agreement, or blanket purchasing agreement resulting from this solicitation.

(2) The **SAM** registration shall be for the same name and address identified on the contract, with its associated CAGE code and DUNS or DUNS+4.

(3) If indicated by the Government during performance, registration in an alternate system may be required in lieu of SAM.

(c) If the Contractor does not have a DUNS number, it should contact Dun and Bradstreet directly to obtain one.

(f) The Contractor is responsible for the accuracy and completeness of the data within the **SAM** database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the **SAM** database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the **SAM** database to ensure it is current, accurate and complete. Updating information in the **SAM** does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the **SAM** record to reflect an assignee for the purpose of assignment of claims

(see FAR Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

52.216-18 ORDERING (OCT 1995)

(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from date of award through base period or option periods if exercised.

(b) All delivery orders or task orders are subject to the terms and conditions of this contract. In the event of conflict between a delivery order or task order and this contract, the contract shall control.

(c) If mailed, a delivery order or task order is considered "issued" when the Government deposits the order in the mail. Orders may be issued orally, by facsimile, or by electronic commerce methods only if authorized in the Schedule.

52.216-19 ORDER LIMITATIONS. (OCT 1995)

(a) Minimum order. When the Government requires supplies or services covered by this contract in an amount of less than 100 copies per month, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.

(3) That it shall comply fully with all laws, decrees, labor standards, and regulations of said country or countries during the performance of this contract.

(b) If the party actually performing the work will be a subcontractor or joint venture partner, then such subcontractor or joint venture partner agrees to the requirements of paragraph (a) of this clause.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
