WORK HOURS: Full-time; 40 hours/week
LENGTH OF HIRE: Indefinite

The U.S. Embassy in Nouakchott is seeking one individual for the position of **Supply (Expendable) Assistant, FSN-5 or FP-9***, in the Supply Section of the General Services Office.

BASIC FUNCTION OF POSITION

Incumbent is responsible for expendable supplies stock control management, to include: monitoring stock, ordering supplies through the procurement office, assisting the Property Management Supervisor and General Services Officer with management controls, overseeing the conduct of expendable supplies inventories, managing and publishing the expendables stock catalogue, responding to requests for information from Department of State, and ensuring quality customer service.

QUALIFICATIONS REQUIRED:

NOTE: All applicants must address each selection criterion detailed below with specific and comprehensive information supporting each item.

1. Secondary School Degree required;
2. Two years of clerical experience is required. At least Two years of stock management and record keeping or related job experience is required;
3. Level II fluency in English and French is required and Level II in a local language is required
4. Good knowledge of products consumed by Americans and other Embassy Staffs in residences and on Embassy compound;
5. Working knowledge of other sections, particularly procurement needs, is also very important. Must be able to use GSO-related software, especially ILMS;
6. Must have the ability to use Microsoft Word and Excel; must be flexible when dealing with urgent /non-standard situations. Must have good communication skills, customer-service oriented and able to solve problems independently.

SELECTION PROCESS

When equally qualified, US Citizen Eligible Family Members (AEFMs) and U.S. Veterans will be given preference. Therefore, it is essential that the candidate address the required qualifications above in the application.

ADDITIONAL SELECTION CRITERIA

1. Management will consider nepotism/conflict of interest, budget, and residency status in determining successful candidacy.
2. Current employees serving a probationary period are not eligible to apply.
3. Currently employed US Citizen EFM's who hold a FMA appointment are ineligible to apply for advertised positions within the first 90 calendar days of their employment.
4. Currently employed NORs hired under a Personal Services Agreement (PSA) are ineligible to apply for advertised positions within the first 90 calendar days of their employment, unless currently hired into a position with a When Actually Employed (WAE) work schedule.

4. Candidates who claim U.S. Veterans preference must provide a copy of their Form DD-214 with their application.

DEFINITIONS

1. AEFM: A type of EFM that is eligible for direct hire employment on either a Family Member Appointment (FMA) or Temporary Appointment (TEMP) provided s/he meets all of the following criteria:

- US citizen
 - Spouse or child who is at least 18 years of age;
 - Listed on the travel orders of a Foreign or Civil Service or uniformed service member permanently assigned to or stationed at a US Foreign Service post or establishment abroad with a USG agency that is under COM authority;
 - Is resident at the sponsoring employee's or uniform service member's post of assignment abroad, approved safehaven abroad, or alternate safehaven abroad; and
 - Does not receive a USG annuity or pension based on a career in the US Civil or Foreign services.
2. EFM: Family Members at least 18 years of age listed on the travel orders of a Foreign of Civil Service or uniformed service member permanently assigned to or stationed to a US Foreign Service post or establishment abroad with a USG agency that is under COM authority who do not meet the definition of AEFM above.
 3. Member of Household (MOH): A MOH is a person who: 1) Has accompanied, but is not/not on the travel orders of a U.S. citizen Foreign or Civil Service employee or uniform service member permanently assigned to or stationed at a US Foreign Service post or establishment abroad; 2) Has been declared by the sponsoring employee to the Chief of Mission as part of his/her household; and 3) Resides at post with the sponsoring employee.
 4. Ordinarily Resident (OR): A citizen of the host country or a citizen of another country who has shifted the main residency focus to the host country and has the required work and/or residency permits for employment in country.
 5. Not-Ordinarily Resident (NOR): Typically NORs are US Citizen EFMs and EFMs of Foreign Service, Civil Service and uniformed service members who are eligible for employment under an American USG pay plan, on the travel orders and under Chief of Mission authority, or other personnel having diplomatic privileges and immunities.
