

THE SCHEDULE

1. REQUIREMENT

The U.S. Government requires the factory-new right-hand drive, EURO-III , Water Tanker Truck specified in Section 4, Description/Specifications of Vehicles, of this Request for Quotations (RFQ). The subject vehicles will be purchased for the American Embassy in Kathmandu, Nepal.

2. TYPE OF CONTRACT

The U.S. Government will award a firm fixed price contract resulting from this RFQ. No additional sums will be payable on account of any escalation in the cost of materials, equipment or labor, or because of the Contractor's failure to properly estimate or accurately predict the prices or difficulty of achieving the results required by this contract. Nor will the contract prices be adjusted on account of fluctuations in the F

3. BASIS FOR PRICES

The prices of the vehicles shall include their transportation on C.I.F. basis to the designated facility of the American Embassy in Kathmandu, Nepal, in accordance with Section 13, FAR52.247-42 C.I.F. Destination (APR 1984), of this RFQ.

NOTE: The offerors shall quote prices for the proposed vehicles without the customs duties and/or taxes normally charged by the Government of Nepal. The General Services Office (GSO) at the American Embassy in Kathmandu, Nepal, will assist the Contractor in obtaining the necessary tax exemption certificates and documentation, and arranging the duty and tax free clearance of the vehicles imported in to Nepal.

5. COMPLIANCE WITH SPECIFICATIONS

The offerors shall prepare and submit with their offer, for the proposed vehicles, detailed matrixes indicating that the specifications of the vehicles offered are in compliance with the required minimum specifications set forth in Section 4, Description/Specifications of Vehicles, of this RFQ. Any deviations to the required minimum specifications shall be clearly stated in the remarks column of the matrixes. Product literature and/or catalogs shall be provided as supplement to the specification data of the proposed vehicles.

6. WARRANTY

The offered shall provide a one-year warranty on parts, which starts from the date the equipment is commissioned on-site. This requirement shall not modify or change the standard contract warranty agreement.

7. DELIVERY SCHEDULE

Delivery should be done within 150 days from the date of PO issue. The goods will be considered delivered once received and inspected by the Receiving Officer at the United States Embassy, Kathmandu, Nepal.

8. PLACE OF DELIVERY

The subject vehicles shall be delivered on C.I.F. basis to the designated facility of the American Embassy in Kathmandu, Nepal, in accordance with Section 13, FAR 52.247-42 C.I.F. Destination (APR 1984), of this RFQ.

9. INSPECTION AND ACCEPTANCE OF VEHICLES

The inspection and acceptance of the vehicles shall be performed by the U.S. Government upon their arrival at the designated facility of the American Embassy in Kathmandu, Nepal. The payment(s) to the Contractor shall be made following satisfactory inspection and acceptance of the vehicles by the U.S. Government, and upon presentation of the certificates of origin to the GSO at the American Embassy in Kathmandu, Nepal.

10. PAYMENT

Per U. S. Government regulations the payment shall be made through Electronic Fund Transfer (EFT) within 30 days from the date of acceptance of vehicle as per section 9 and receipt of clear invoice.

11. ACQUISITION METHOD

The Government is conducting this acquisition using the simplified acquisition procedures in Part 13 of the Federal Acquisition Regulation (FAR). If the dollar amount exceeds the simplified acquisition threshold, then the Government will be using the test program for commercial items authorized by Subpart 13.5 of the FAR.

18. 52.212-2 EVALUATION - COMMERCIAL ITEMS (OCT 2014)

Basis for Award

The proposed vehicles shall meet all of the technical specifications and the delivery terms contained herein. The offerors shall provide with their proposal, at a minimum,

existing product literature to substantiate the acceptability of their offered products in accordance with the Section 4, Description/Specifications of Vehicles, and Section 5, Compliance with Specifications, of this RFQ. In addition, the offerors shall provide for the proposed vehicles the following documentation for technical evaluation of their proposal:

(A) If applicable, provide details of warranty provisions available for the proposed vehicles in India, and complete contact information of the dealership(s) in New Delhi and/or other parts of India, where the manufacturer's warranty of the vehicles can be claimed;

(B) Certification of the offeror's supplier or manufacturer to deliver the subject vehicles within the time frame specified in Section 7, Delivery Schedule, of this RFQ.

Technical capability is equal to the price.

(b) Options. The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (2) Does not include information or informational materials the export of which the

President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—

(1) Means a small business concern—

- (i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and
- (ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

“Small business concern” means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

“Small disadvantaged business concern, consistent with 13 CFR 124.1002,” means a small business concern under the size standard applicable to the acquisition, that--

(2) Through another subsidiary of a parent corporation.

“Successor” means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

FAR AND DOSAR PROVISION(S) NOT PRESCRIBED IN PART 12

The following DOSAR provision is provided in full text:

21. 652.225-70 ARAB LEAGUE BOYCOTT OF ISRAEL (AUG 1999)

(a) Definitions. As used in this provision:

Foreign person means any person other than a United States person as defined below. United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

(1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,

(2) Discriminating in the award of subcontracts on the basis of religion.

22. 652.209-79 REPRESENTATION BY CORPORATION REGARDING AN UNPAID DELINQUENT TAX LIABILITY OR A FELONY CRIMINAL CONVICTION UNDER ANY FEDERAL LAW (SEPT 2014) (DEVIATION per PIB 2014-21)

(a) In accordance with section 7073 of Division K of the Consolidated Appropriations Act, 2014 (Public Law 113-76) none of the funds made available by that Act may be used to enter into a contract with any corporation that –

(1) Was convicted of a felony criminal violation under any Federal law within the preceding 24 months, where the awarding agency has direct knowledge of the conviction, unless the agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government; or

(2) Has any unpaid Federal tax liability that has been assessed for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability, where the awarding agency has direct knowledge of the unpaid tax liability, unless the Federal agency has considered, in accordance with its

procedures, that this further action is not necessary to protect the interests of the Government.

For the purposes of section 7073, it is the Department of State's policy that no award may be made to any corporation covered by (1) or (2) above, unless the Procurement Executive has made a written determination that suspension or debarment is not necessary to protect the interests of the Government.

(b) Offeror represents that—

(1) It is is not a corporation that was convicted of a felony criminal violation under a Federal law within the preceding 24 months.

(2) It is is not a corporation that has any unpaid Federal tax liability that has been assessed for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability.
