The purpose of this procurement is to Supplying, Installation and Testing & Commissioning of Solar Hot water collectors at U.S. Embassy with electrical control & all other accessories American Embassy Kathmandu.

A) Objective: U.S Embassy intends to get service of professional solar hot water designer cum contractor to supply and installation of hot water solar collectors at MSGQ based on attached schematic drawing and specification of material specified in this document. All material and labor needed to complete the project will be provided by contractor including final testing & commissioning.

B) Scope of Work: Contractors are requested to supply and install all labor, material necessary to complete the work. Following major items needs to be supplied, installed & commissioned by contractor:

F) CONTENT OF PROPOSAL FROM CONTRACTORS

The proposal from contractor should contain at least following documentation:

- i) Documentation on Prior Experience for supply and installation of large scale hot water solar system.
- ii) Detailed Bill of Quantities containing Cost Estimate with quantities for all the material used.
- iii) Type, Brand & technical specifications of major material to be used but in minimum it should contains documentation on:
 - Solar collector

- Hot water tank
 - Motorized valve
 - Air relief, pressure relief and safety valve
 - Details of stainless steel support/hardware to be used.
- iv) A single line diagram & calculation of the system if it differs from attached schematic diagram, specification and reference Bill of Quantities.
 - v) Work schedule – Outlining activities that justify that entire work in completed within 30 working days.
 - vi) Working Methodology

G) GENERAL SPECIFICATION OF WORKS:

The contractor shall furnish the construction materials and labor to perform all the work as proposed under Section C – Scope of Work. The contractor shall be responsible for removal and disposal of all construction debris and for the restoration of site in a neat and presentable condition, at his own cost. The contractor will assign a full time technical supervisor, who will be on the project site during the working hours. The supervisor must be capable of interpreting drawings and specifications. The contractor will be required to complete the work within the specified date, set by The Embassy. The contractor will be responsible to submit bi - weekly report, regarding the progress of the work. The contractor must get a written approval, from the Embassy designated Officer, regarding the quality of the materials provided, prior to its use, at site. The materials used in the renovation must be according to the specifications outlined. The contractor must visit the site personally, and prepare technical specifications and drawings for all the renovation works that are included in the project.

H) WARRANTY OF CONSTRUCTION

The warranty of this work shall continue for a period of five year from the date of final acceptance of the work. The contractor shall be responsible to correct any and all defects which may occur within a year from the date of final acceptance of the work. The contractor shall bear all the cost to fix the repairing work during the warranty period.

I) MILESTONES

- a. The single line working drawing of the system with site dimensions and approval of technical details of all equipment/system must be approved prior to the contractor proceeding to the next phase of work.
- b. Approval of Contractor Work Phase Plan
- c. Contractor material submittals
- d. Approval of Materials
- e. Site Inspection & Approval by COR.

J) QUALITY CONTROL

- a. All patched concrete should match existing concrete paving.
- b. A field Supervisor that has a minimal knowledge of English must be present at all times

- c. COR will ensure the material is not damaged prior to or during installation and that standard industry practices as defined by local Building Codes, are followed at all times.
- d. Proper joints of the pipes with approved adhesives are required.
- e. A final inspection will be held with the COR and the site supervisor to inspect for quality of completed piping line prior to cover with the concrete.

K) SAFETY

- a. Facility Supervisor will ensure that all equipment used during the project is in safe operating condition.
- b. All personnel on the job site shall have the appropriate job safety equipment and Personal Protective Equipment (PPE).
- c. Embassy reserves the right to stop the work if any unsafe contractor conditions are observed or encountered.
- d. All electrical equipment such as drills, saws and electrical extension cords must be properly grounded and be free from any defect in the insulation cover
- e. All ladders will be in good condition and used in a proper manner.

L) SECURITY

- a. A list of all personnel working on the project along with Identification numbers must be submitted to the embassy no later than 2 weeks prior to the beginning of actual construction
- b. While on the Embassy property, all personnel must be escorted at all times. Any personnel found unescorted will be removed from the project immediately
- c. Job site personnel will be issued a visitors badge by the Security staff and this badge must be worn at all times.
