The International Dialing Code for the Netherlands is 31.

Dutch law requires that attorneys comply with specific and stringent advertising rules. Since the publication of names of attorneys together with any data concerning their qualifications and professional experience may be considered a contravention of these rules, this list is provided only on condition that it not be published.

Most attorneys listed are capable of corresponding in the English language.

The rate of first class mail from the United States to the Netherlands is \$.98 per half ounce. Registered mail can be sent through the Netherlands Postal Services. International reply coupons should be used prepayment is necessary for a reply. Several courier companies, including Airborne Express, DHL, Federal Express, and UPS, also offer services to the Netherlands.

Credit reports can be obtained from commercial banks or credit reporting agencies. Several major U.S. financial institutions are represented locally as are their Dutch counterparts in the United States.

**Notaries:**

Notaries in the Netherlands, unlike attorneys or legal advisors, do not represent or act in the interest of any one party, but are legally bound to act impartially. They are appointed by the monarch for life and governed by the statutes of [Koninklijke Notariële Beroepsorganisatie](#). Their functions include, but are not limited to, probating estates, preparing wills, articles of incorporation, agreements between individuals, and transferring title in real property transactions. Notaries are required to establish the veracity of information presented to them and their functions have the force of law.

At the end of the List of Attorneys is a partial listing of notary offices in the three major cities in the Netherlands. These offices were selected at random and are being provided under the same disclaimer as that of the List of Attorneys.
