

STUDENT VISAS

First Time Student Applicants (F-1 and M-1 visas)

If you are going to the U.S. primarily for tourism, but want to take a short course of study of less than 18 hours per week, you may do so on a tourist visa. Otherwise, please read this message for general information on how to apply for an F1 or M1 student visa. To the extent possible, students should bring the documents suggested below, as well as any other documents that might help establish their ties to the local community.

To allow time to overcome any unforeseen problems that might arise, students are encouraged to apply for their visas several weeks before they plan to travel.

We Can issue a visa 12 days prior to the program but F, J or M student or exchange visitors cannot be admitted to the United States until a date 30 days or less prior to the beginning of the program date, or start date, as given on your Form I-20 (for F and M visas) or DS 2019 (for J Visas). An Immigration Inspector may deny you entry into the United States earlier than the 30 days.

What is Needed to Apply for a Student Visa?

All applicants for a student visa **must** provide:

- A Form I-20 obtained from a U.S. college, school or university. Please be sure to give all four pages of the I-20 form. The form must also be signed by you and by a school official in the appropriate places;
- An EVAF (electronic visa application form) Form DS-156 to be filled out electronically – website: <http://newzealand.usembassy.gov> and then print all 3 pages, together with a Form DS-158. Both forms must be completed and signed. All male applicants between the ages of 16 – 45 years will also be required to complete and sign Form DS-157.
- A passport valid for at least six months after your proposed date of entry into the United States;
- A receipt for visa processing fee.
- A receipt for the SEVIS fee of US \$100. This fee can be paid through the education institution in the US or can be paid using a credit card by logging on to <http://www.fmjfee.com>
- One recent passport photo with a clear background

Public School

There are certain restrictions on attending public school in the U.S. Persons who violate these restrictions may not receive another visa for a period of five years.

The restrictions apply only to students holding F-1 visas. They do not apply to students attending public school on derivative visas, such as F-2, J-2 or H-4 visas. The restrictions also do not apply to students attending private schools on F-1 visas.

The restrictions are:

- Students who attend public high schools in the U.S. are limited to twelve months of study.
- F-1 visas can no longer be issued to attend public elementary or middle schools (Kindergarten - 8th grade) or publicly-funded adult education programs.
- Before an F-1 visa for a public school can be issued, the student must show that the public school in the U.S. has been reimbursed for the full, unsubsidized per capita cost of the education as calculated by the school. Reimbursement may be indicated on the I-20. Consular officers may request copies of canceled checks and/or receipts confirming the payment as needed.
