WHAT WE DO

OABC provides a variety of activities and forums to promote the exchange of information, advice, and ideas for the US business community in Oman. Activities such as panel discussions, advocacy meetings, white paper development, and public forums have been used to further discussions within the business community and with the Omani government and other stakeholders.

Networking opportunities are regularly scheduled to allow for a more casual exchange between member companies. Information pertinent to doing business in Oman is also regularly circulated to member companies. Our Corporate Social Responsibility sub-committee also supports the development of entrepreneurship in Oman.

Working with the American Embassy, the OABC interacts with the Ambassador and other official dignitaries or visiting trade delegations to promote trade between the U.S. and Oman and further the business ties and friendly relations between the countries.

OABC membership is open to any US National, any employee of an entity with significant US origin or affiliation, or any resident in Oman with a significant interest in the activities of the OABC.

YOUR MEMBERSHIP

OABC offers three categories of membership.

Premium Access 1000 OMR

Membership in this category is reserved for corporations, partnerships, agencies, distributorships, franchises, associations and other businesses registered and licensed in Oman.

Premium Access members enjoy exclusive invitations to official Embassy and private events (for the Principle Member) such as quarterly round tables with the American Ambassador, receptions for visiting dignitaries, and exclusive luncheons or coffees with high-level executives.

Special corporate recognition is given at each large event and all OABC publications will be branded with the Premium Members corporate logo.

Premium Access includes one "Principle Member", usually the GM or CEO, plus up to four individuals from the same company or entity. Seating at all OABC events is included and guaranteed.

Corporate Standard 300 OMR

Corporate Standard memberships are for corporations, partnerships, agencies, distributorships, franchises, associations and other businesses registered and licensed in Oman.

Corporate Standard members are welcome to attend all non-exclusive OABC events (entrance free to one company representative). Active participation in panel discussions, social events and other public forums are enjoyed by our Corporate Standard members on a regular basis, and Corporate members are invited to most broad-based Embassy and American community events

Corporate Standard membership includes one Principle Member. Additional individuals from the same entity may join OABC for an additional fee.

SME Membership 150 OMR

An SME must be an Omani registered company whose total annual revenue, including subsidiaries and parent company revenue, does not exceed 500,000 OMR, and which in total does not employ more than 25 employees.

An SME member must be registered and licensed to operate in Oman. SME membership includes one Principle Member only. An SME member may change its authorized representative by letter addressed to the Secretary of the OABC and such change shall become effective thirty (30) days after the Secretary receives such letter.

By paying the Annual Membership Fee for SME Member shall be entitled to attend all regular meetings sponsored by the OABC.

Applicants may have to prove SME status with audited annual financial statements and MOCI registration certificate.

Individual Membership 100 OMR

Any individual working as a sole proprietor, or working for a company not yet licensed in Oman may join the OABC.
