The U.S. Consulate General in Karachi is seeking an individual for the position of Storekeeper in the General Services Office.

BASIC FUNCTION OF POSITION:

Responsible for storage, issuance, and disposal of expendable property. Recommends purchase and inventory changes and identifies obsolete or defective items for disposal. Performs physical inventory for annual reconciliation. Replaces inventory as needed, per restock levels or replacement cycle. Inspects and supervises furnishing expendable inventory to all USG offices. Responsible for organization, cleanliness, and inventory levels of expendable property. Performs other related duties as assigned by the supervisor.

A copy of the complete position description listing all duties and responsibilities is available in the Human Resources Office.

QUALIFICATIONS REQUIRED

NOTE: *All applicants must address each selection criterion detailed below with specific and comprehensive information supporting each item.*

- 1. EDUCATION:** Completion of ten years of education is required.
- 2. EXPERIENCE:** Three years of clerical experience of which one year should be supply related is required.
- 3. LANGUAGE:** Level III (Good Working Knowledge) Speaking/Reading/Writing English and Urdu are required. This may be tested.
- 4. KNOWLEDGE:** Must have through knowledge of property control procedures and principals. Familiarity with 6 FAM and post policies is required.
- 5. ABILITIES & SKILLS:** Must be comfortable using web-based software, such as ILMS and MS Office with typing speed. Must have sufficient math skills to be able to perform inventory, as required by the position.

SELECTION PROCESS:

When equally qualified, U.S. Veterans will be given preference. Therefore, it is essential that the candidate address the required qualifications above in the application.

ADDITIONAL SELECTION CRITERIA:

1. Management will consider nepotism/conflict of interest, budget and residency status in determining successful candidacy.
2. Current employees serving a probationary period are not eligible to apply.
3. Current employees with an Overall Summary Rating of Needs Improvement or Unsatisfactory on their most recent Employee Performance Report are not eligible to apply.
4. Applicants for the position must meet the **required** qualifications as advertised in the vacancy announcement. Trainee level(s) may be established below the full performance grade level listed if not fully qualified.
5. Current employees who have voluntarily reassigned/promoted from one position to another are not eligible to apply for **six months** from the effective date of the reassignment/promotion.
6. Current employees who have received any job-related training are not eligible to apply in another section/agency for **six months** from the effective date of the training.
7. Candidates need to indicate on the Application for Employment if any family member is working in the U.S. Mission, Pakistan and, if so, in which section.
8. U. S. Mission Pakistan will not bear any travel expenses for testing, interviews, pre-employments clearances (if selected) or relocating for joining.
