The U.S. Embassy in Islamabad is seeking an individual for the position of Security Investigator in the Regional Security Office.

### **BASIC FUNCTION OF POSITION:**

Incumbent under the supervision of Assistant Regional Security Officer provides detailed reports on security situation in Pakistan while also generating reports from interviews and investigations. Initiating, analyzing, and managing detailed complex reports in response to leads. Liaisons with host government law enforcement officials. Provides security support and personal protection for visiting delegations. Assists RSOs in complex investigations. Performs other related duties as assigned by RSO/ARSO.

### **REQUIRED QUALIFICATIONS:**

NOTE: *All applicants must address each selection criterion detailed below with specific and comprehensive information supporting each item.*

- 1. EDUCATION:** Completion of twelve years of education is required.
- 2. EXPERIENCE:** Two years of security related experience with military, police or other organization is required.
- 3. LANGUAGE:** Level III (Good Working Knowledge) Reading/Writing/Speaking English, Urdu and Pashtu are required. This may be tested.
- 4. KNOWLEDGE:** Incumbent must have good knowledge of office operations. Must have knowledge of hierarchy and operations of host country law enforcement authorities.
- 5. SKILLS & ABILITIES:** Incumbent must have good interpersonal skills to easily communicate with strangers elicit information and comprehend non-verbal signs. Must be proficient in MS Office with 30 WPM typing speed. This may be tested. A valid Pakistani driving license for Motor Car/Jeep is required.

**SELECTION PROCESS:**

When equally qualified, U.S. Veterans will be given preference. Therefore, it is essential that the candidate address the required qualifications above in the application.

**ADDITIONAL SELECTION CRITERIA:**

1. Management will consider nepotism/conflict of interest, budget and residency status in determining successful candidacy.
2. Current employees serving a probationary period are not eligible to apply.
3. Current employees with an Overall Summary Rating of Needs Improvement or Unsatisfactory on their most recent Employee Performance Report are not eligible to apply.
4. Applicants for the position must meet the **required** qualifications as advertised in the vacancy announcement.
5. Current employees who have voluntarily reassigned/promoted from one position to another are not eligible to apply for **six months** from the effective date of the reassignment/promotion.
6. Current employees who have received any job-related training are not eligible to apply in another section/agency for **six months** from the effective date of the training.
7. Candidates need to indicate on the Application for Employment if any family member is working in the U.S. Mission, Pakistan and, if so, in which section.
8. U. S. Mission Pakistan will not bear any travel expenses for testing, interviews, pre-employments clearances (if selected) or relocating for joining.

2. Not-Ordinarily Resident (NOR): Typically NORs are U.S. citizen EFMs (Eligible Family Members) and family members of United States Government personnel who are on the travel orders and under Chief of Mission authority, or other personnel having diplomatic privileges and immunities.
