1.6.1 Service Days: The Contractor shall provide full trash and recycling services seven (7) days a week. The days of service shall be Monday through Sunday, including all legal holidays. This service is required at Embassy compound diplomatic enclave, I-9 and I-10 warehouses.

1.2.7 Collection of Regular Refuse: Regular refuse means the refuse other than materials specified in Para. 1.2.13. The Contractor shall use appropriate containers to minimize the risk of spillage. The Contractor is responsible for the collection of containers regardless of their weight or volume. The Contractor shall also collect refuse contained in tied bags or boxes that are left alongside or against the containers. Costs shall be listed per month of service, regardless of weight or volume.
