 The solicitation Number SPK400-12-R-5004 is hereby amended to include attached revised scope of works of Lincoln Corners, Khairpur and Larkana. The scope of work for Hyderabad Lincoln Corner has been removed from the solicitation. The proposal will be requested separately for Hyderabad.
