The U.S. Mission in Panama is seeking one eligible and qualified applicant for the position of General Services Specialist in the General Services Office.

Due to the high volume of applications received, we will only contact applicants who are being considered. Thank you for your understanding.

BASIC FUNCTION OF POSITION

Responsible for management of the General Service Office (GSO) under the general supervision of the General Services Officer. Serves as the Senior LE Staff in the GSO Office. Directly supervises 2 employees and indirectly supervises 4 additional employees. Serve as COR for multiple contracts. Serves as the troubleshooter and point of contact for special projects and also as coordinator for official VIP travel to Panama. Incumbent also serves as Post Quality Coordinator. Has substantial management responsibility for the continuing operation of the General Services office, including independent planning, organization and assignment of work, preparation of schedules, participation in the selection of subordinates, provision of technical and policy guidance, coordination of activities among the different GSO units, etc. Receives

general policy/program guidance from the SGSO and AGSO, but carries out supervisory duties independently.

QUALIFICATIONS REQUIRED

NOTE: Although some of the information below has been provided in your application, all applicants must still address each qualification/requirement listed below with specific and comprehensive information supporting each item, on a separate sheet of paper. Failure to do so may result in a determination that the applicant is not qualified.

1. **Education:** University degree in Management, Business Administration or Industrial Engineering is required.
2. **Experience:** Five (5) years of progressively responsible experience in professional, technical or administrative management is required. Three (3) years of supervisory experience is required.
3. **Language:** Level IV (Fluent) Speaking/Reading/Writing Spanish language is required. Level IV (Fluent) Speaking/Reading/Writing English language is required. (Testing will be conducted to determine the qualifications)
4. **Job Knowledge:** Position requires qualified knowledge for interpreting local legislation, procedures and practices. Must have high level of knowledge of local economy, business customs, and commercial practices and customs (e.g. bargaining practices, cultivating relationships with important contacts) is required. Knowledge of host government organization to properly address the different issues in which the position is involved. Knowledge of the Mission's Management Section, including all GSO-related sections is required. Knowledge of all Department of State regulations pertaining to GSO activities including Federal/Department of State Acquisition Regulations, Federal Travel Regulations, Foreign Affairs Manual and Handbook is required. Knowledge of the general structure of local Administrative Offices and Ministries (Ministry of Foreign Relations, Diplomatic Service Bureau, Customs, etc.) is required. Basic knowledge of reading blue prints is required. (Testing may be conducted to determine the qualifications)
5. **Computer Skills:** Good knowledge of Microsoft Office Suite is required. (Testing may be conducted to determine the qualifications)
6. **Skills and Abilities:** Must have proficient skills and capacity to assist the Embassy in researching, interpreting and applying local legislation in matters such as taxes, immunity, real estate, acquisition, etc. Ability to implement USG regulations in a market governed by rules and practices not fully compatible with USG regulations. Employee

must possess managerial skill to ensure operational effectiveness and adequacy of internal controls and procedures. Critical thinking skills to analyze and define complex matters clearly, in terms that permit them to be dealt with in a practical way. Negotiation skills to negotiate effectively on a wide range of issues in order to resolve conflicts and disagreements in the most efficient manner. Must have the capacity to plan, prioritize and carry out/manage complex tasks independently of direct supervision. Must possess be able to provide good follow-up. Must be able to organize projects once general instructions are given. (Testing may be conducted to determine the qualifications)

HIRING PREFERENCE SELECTION PROCESS

When qualified, applicants in the following hiring preference categories are extended a hiring preference in the order listed below. Therefore, it is essential that these applicants accurately describe their status on the application. Failure to do so may result in a determination that the applicant is not eligible for a hiring preference.

HIRING PREFERENCE ORDER:

- 1) AEFM/USEFM who is a preference-eligible U.S. Veteran*
- 2) AEFM/USEFM
- 3) FS on LWOP**

* **IMPORTANT:** Applicants who claim status as a preference-eligible U.S. Veteran must submit a copy of the most recent Member Copy Four (4) of the DD-214, Certificate of Release or Discharge from Active Duty, and, if applicable, a letter from the U.S. Department of Veterans Affairs. If claiming conditional eligibility for U.S. Veterans' preference, applicants must submit proof of conditional eligibility. If the written documentation confirming eligibility is not received in the HR office by the closing date of the vacancy announcement, the U.S. Veterans' preference will not be considered in the application process. Mission HR's decision on eligibility for U.S. Veterans' preference after reviewing all required documentation is final.

** This level of preference applies to all Foreign Service employees on LWOP.

ADDITIONAL SELECTION CRITERIA

1. Management may consider the following when determining successful candidacy: nepotism, conflict of interest, budget, and residency status.
2. Current OR employees serving a probationary period are not eligible to apply.
3. Current OR employees with an Overall Summary Rating of Needs Improvement or Unsatisfactory on their most recent Employee Performance Report (EPR) are not eligible to apply.

4. Current NOR employees hired on a Family Member Appointment (FMA) or a Personal Service Agreement (PSA) are not eligible to apply within the first 90 calendar days of their employment, unless they have a When Actually Employed (WAE) work schedule.

HOW TO APPLY: Applicants must submit the following documents to be considered. Failure to do so may result in a determination that the applicant is not eligible or qualified.

1. Universal Application for Employment (UAE) (Form DS-174), which is available on our website or by contacting Human Resources.
2. All Ordinarily Residents (OR) must provide **work and residency permits**.
3. Any additional documentation (e.g., resumes, essays, certificates, awards, copies of degrees earned) that addresses the qualification requirements of the position as listed above.

APPENDIX DEFINITIONS

1) Eligible Family Member (EFM): An EFM for employment purposes is an individual who meets **all** of the following criteria:

- U.S. Citizen or not a U.S. Citizen; **and**
- Spouse or same-sex domestic partner (as defined in [3 FAM 1610](#)); **or**
- Child, who is unmarried and under 21 years of age or, regardless of age, is incapable of self-support; **or**
- Parent (including stepparents and legally adoptive parents) of employee, spouse, or same-sex domestic partner, when such parent is at least 51 percent dependent on the employee for support; **or**
- Sister or brother (including stepsisters and stepbrothers, or adoptive sisters or brothers) of the employee, spouse, or same-sex domestic partner when such sibling is at least 51 percent dependent on the employee for support, unmarried, and under 21 years of age, or regardless of age, incapable of self-support; **and**
- Listed on the travel orders or approved Form OF-126 of a sponsoring employee, i.e., a direct-hire Foreign Service, Civil Service, or uniformed service member who is permanently assigned to or stationed abroad or, as appropriate, at an office of the American Institute in Taiwan; **and**
- Is under chief of mission authority.

2) U.S. Citizen Eligible Family Member (USEFM): A USEFM for employment purposes is an individual who meets **all** of the following criteria:

- U.S. Citizen; **and**
- Spouse or same-sex domestic partner (as defined in 3 FAM 1610) of the sponsoring employee; **or**
- Child of the sponsoring employee who is unmarried and at least 18 years old; **and**
- Listed on the travel orders or approved Form OF-126 of a sponsoring employee, i.e., a direct-hire Foreign Service, Civil Service, or uniformed service member who is permanently assigned to or stationed abroad or, as appropriate, at an office of the American Institute in Taiwan; and resides at the sponsoring employee's post of assignment abroad, or as appropriate, at an office of the American Institute in Taiwan; and is under chief of mission authority; **or**
- Resides at an Involuntary Separate Maintenance Allowance (ISMA) location authorized under 3 FAM 3232.2; **or**
- Currently receives a U.S. Government retirement annuity or pension from a career in the U.S. Foreign Service or Civil Service.

3) Appointment Eligible Family Member (AEFM): An AEFM for employment purposes is an individual who meets **all** of the following criteria:

- U.S. citizen; **and**

Spouse or same-sex domestic partner (as defined in [3 FAM 1610](#)) of the sponsoring

employee; **or**

Child of the sponsoring employee who is unmarried and at least 18 years old; **and**

Is listed on the travel orders or approved Form [OF-126](#) of a sponsoring employee, i.e., a direct-hire Foreign Service, Civil Service, or uniformed service member who is permanently assigned to or stationed abroad or, as appropriate, at an office of the American Institute in Taiwan (AIT); **and**

Is under chief of mission authority; **and**

Is residing at the sponsoring employee's post of assignment abroad or, as appropriate, at an office of the American Institute in Taiwan; **and**

Does NOT currently receive a U.S. Government retirement annuity or pension from a career in the U.S. Foreign Service or Civil Service.

4) Member of Household (MOH): An individual who accompanies or joins a sponsoring employee, i.e., sponsor is a direct hire employee under Chief of Mission authority, either Foreign Service, Civil Service, or uniformed service member who is permanently assigned to or stationed abroad at a U.S. mission, or at an office of the American Institute in Taiwan. A MOH is an individual who meets **all** of the following criteria:

- Not an EFM and therefore not on the travel orders or approved through form OF-126 Foreign Service Residence and Dependency Report of the sponsoring employee; **and**
- Officially declared by the sponsoring U.S. Government employee to the Chief of Mission (COM) as part of his or her household and approved by the COM; **and**
- Is a parent, grandparent, grandchild, unmarried partner, adult child, foreign born child in the process of being adopted, father, mother, brother, sister, father-in-law, mother-in-law, son-in-law, daughter-in-law, brother-in-law, sister-in-law, stepfather, stepmother, stepson, stepdaughter, stepbrother, stepsister, half-brother, or half-sister who falls outside the Department's current definition of Eligible Family Member 14 FAM 511.3. A MOH may or may not be a U.S. Citizen.

5) Not Ordinarily Resident (NOR) – An individual who meets the following criteria:

- An EFM, USEFM or AEFM of a direct-hire Foreign Service, Civil Service, or uniformed service member permanently assigned or stationed abroad, or as appropriate, at an office of the American Institute in Taiwan; **or**
- Has diplomatic privileges and immunities; **and**
- Is eligible for compensation under the FS or GS salary schedule; **and**
- Is **not** a citizen of the host country; **and**
- Does **not** ordinarily reside in the host country; **and**
- Is **not** subject to host country employment and tax laws; **and**
- Has a U.S. Social Security Number (SSN).

6) Ordinarily Resident (OR) – An individual who meets the following criteria:

- A citizen of the host country; **or**

- A non-citizen of the host country (including a U.S. citizen or a third-country national) who is locally resident and has legal and/or permanent resident status within the host country and/or who is a holder of a non-diplomatic visa/work and/or residency permit; **and/or**
- Is subject to host country employment and tax laws.
