SECTION 1 - THE SCHEDULE

Phone Lines and Service – U.S. Embassy Compound

1. GENERAL REQUIREMENT:

Installation of Primary Service: The Contractor shall provide all labor, materials and equipment for the installation of telephone lines from the street to the Embassy Compound's Service Compound Access Control (SCAC). Installation services shall include the following: 1) Three Primary-Rate ISDN lines with EURO signaling via single-mode fiber to the Embassy Compound SCAC. The lines shall be able to handle "Random Hunting" offering full portability across the E-1 lines to ensure that if a failure occurs in one of the E-1 lines, the telephone trunks associated with the failed E-1 line will automatically route to the other E-1 lines; 2) A Block of 600 DID numbers; and 3) Sixty analog telephone lines which provide 9VDC from the carrier. If the analog services will be provided via fiber, installation of these lines shall include the equipment required to convert the lines to analog/9VDC. (The numbers of these analog lines should be private and should not appear in the public telephone directory)

The purpose of this firm fixed price contract is to monitor, provide maintenance service support of digital telephone links, analog telephone lines and Internet service at the American Embassy, Panama. Contractor shall provide 24 hours a day, seven days a week, immediate maintenance and service support within two hours as requested by the Information Resource Management in accordance with Descriptions/Specification/Work Statement.

The contractor shall complete all work, including furnishing all labor, material, equipment, and services, unless otherwise specified herein, required under this contract for stated services within the time specified herein. The price listed below shall include all labor, materials, overhead, profit and taxes. In consideration of satisfactory performance of all scheduled services required under this contract, the contractor shall be paid a firm fixed-price for all services

The installation shall be completed as follows: All ISDN lines via one single-mode (24 strands) fiber

Installation of Off Premise Extension (OPX) Lines: The contractor shall install OPX lines between the Embassy and the following locations:

- a) Installation of three (3) lines for the Ambassador's Residence located in La Cresta.
- b) Installation of two (2) lines for the Deputy Chief of Mission's residence located in Albrook, Gato Solo.

In addition to the OPX lines, the Embassy will require the installation of the following lines:

- a) Installation of Analog Lines of 60 analog lines with Private numbers for the Embassy building located at Clayton.
- b) Installation of five (5) Residential direct Lines with Private numbers for the Ambassador's Residence located in La Cresta.
- c) Installation of one (1) Residential direct line with private number and one (1) 4MB Internet for the Deputy Chief of Mission's residence located in Albrook, Gato Solo.

2. PERIOD OF PERFORMANCE:

The contract will be for a one-year period from the date of the contract award and a notice to proceed with four option years.

- The Contractor shall furnish all engineering, labor, tools, equipment, materials, supplies and services to provide the required circuit as specified under Section 1.
- In consideration of satisfactory performance of the services required under this contract, the Contractor shall be paid a firm fixed-price (FFP) per month as stated in the schedule below in U. S. dollars. Carrier shall be responsible for payment end-to-end circuit billing.
- The firm fixed-prices are in U.S. Dollars

3. PRICES:

a) Installation of Lines:

The price below for the installation of the primary service and the OPX lines shall be a firm-fixed price. The price is FOB destination, Panama, and includes all shipping and other costs for delivery to Panama City & Pacora.

Cellular: 746 minutes

Directory (102): 70 minutes

The maximum for these services shall be 100% more than the monthly estimates above.

1. PERFORMANCE WORK STATEMENT

This solicitation is for *phone lines and services* for the *US Embassy Panama*. Services provided shall include:

- Calls within *Panama City*
- National calls
- International calls
- 24 hour Customer service
- Detailed Billing of calls made

The Contractor shall ensure that the connection through its network is of the highest quality possible and shall be uninterrupted, clear and with no static. Network problems shall be remedied immediately, and the COR must be immediately informed of any problems, and their resolution.

2. INTERNATIONAL CALLS

The Contractor shall ensure on a 24-hour basis international connectivity with the USA, all European and Latin American countries and all other worldwide countries that telephone services are available.

3. CUSTOMER SERVICE

The contractor shall provide technical support on all matters concerning the phone services through the Contractor's Project Manager. Contract Project Manager should be fluent in Spanish and English.

4. DETAILED BILLING

A. The Contractor shall provide monthly breakdown of calls made by individual number. The Contractor shall submit monthly invoices by original paper copy invoice and an electronic copy (MS Word or Excel format) via email to the COR at the address shown in paragraph D below. A proper invoice must include the following information:

- Contractor's name and bank account information for payments by wire transfers
- Invoice Date
- Contract number
- All invoices should begin the first day of each month and finish on the last day of each month (e.g. July 1 through July 31, 2013. Invoices should not be split between months (e.g. November 5 through December 5.)
- A summary showing a listing of each line with total monthly price in local currency for that line. A detailed invoice for each agency has to be attached to each summary invoice and should include the cost breakdown by each telephone line according to the pricing schedule and shall clearly show:
 1. Embassy Account Number

2. Account Phone Number
3. Called Number
4. The Time and Date of the Call
5. The Duration of the Call
6. Cost of each call
7. Total Price

- Prompt payment discount if any
- Credit payments if any
- Name, title, phone number, and address of person to contact in case of defective invoice

- B. If an invoice does not contain the above information, the Government reserves the right to reject the invoice as improper and return it to the Contractor within 7 calendar days. The Contractor must then submit a proper invoice.
- C. The COR will take each summary invoice and furnish the detailed invoice to the appropriate official in each individual Government agency. That agency representative will review the detailed invoice and either approve for payment or advise the COR of the inaccuracies found. It shall be the COR who will interact with the Contractor on any invoice problems.
- D. The contractor will send all invoices to the following address:

- E. Payment shall be made in local currency by Electronic Funds Transfer (EFT) within 30 days after receipt of the proper invoice
- F. The Government will provide annual direct exemption of Value Added Tax (VAT) (i.e. ITBMS); according to host country VAT laws.

5. CONTRACTOR KEY PERSONNEL

- A. The Project Manager must be able to converse in English and Spanish. The Contractor shall assign to this contract the following key person:

- B. During the first 90 days of performance, the Contractor shall make no substitutions of key personnel unless the substitution is required due to illness, death, or termination of employment. The Contractor shall notify the Contracting Officer within 15 calendar days after the occurrence of any of these events and provide the information required below to the Contracting Officer at least 15 days before making any permanent substitutions.
- C. After the first 90 days of performance, the Contractor may substitute a key person if the contractor determines that it is necessary. The Contractor shall notify the Contracting Officer of the proposed action immediately. Prior to making the substitution, the Contractor will provide the information required below to the Contracting Officer.
- D. The Contractor shall provide a detailed explanation of the circumstances requiring the proposed substitution, a complete resume for the proposed substitute. The proposed substitute shall possess qualifications comparable to the original key person. The Contracting Officer will notify the Contractor of its approval or disapproval of the substitution within 15 calendar days after receiving the required information. The Government will modify the contract to reflect any changes in key personnel.

6. PERMITS

Without additional cost to the Government, the Contractor shall obtain all permits, licenses, and appointments required for the work under this contract. The contractor shall obtain these permits, licenses, and appointments in compliance with applicable **Panama** country laws.

7. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan is designed to provide an effective surveillance method to promote effective contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor contractor performance, advise the contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

- A. Surveillance
 The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor in writing for corrective action.

B. Standard

The performance standard is that the Government receives no more than **one (1)** customer complaint per month. The COR shall notify the Contracting Officer of the complaints in writing so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

C. Procedures

- If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- The COR will complete appropriate documentation to record the complaint.
- If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- If the COR determines the complaint is valid, the COR will inform the Contractor in writing and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- The COR shall, as a minimum, orally notify the Contractor of any valid complaints, followed by written notification.
- If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- The COR as Quality Assurance Representative (QA), will consider complaints as resolved unless notified otherwise by the complainant.
- Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

- G. Acceptance of Quotations. The Government reserves the right to reject, as unacceptable, quotations deleting or altering technical requirements which are considered by the Government to be beyond the state of the art or impossible of attainment.

- The lowest price will be determined by multiplying the offered prices times the estimated quantities in "Prices - Continuation of SF-1449, block 23", and arriving at a grand total, including all options.
- The Government will determine acceptability by assessing the offeror's compliance with the terms of the RFQ to include the technical information required by Section 3.
- The Government will determine contractor responsibility by analyzing whether the apparent successful offeror complies with the requirements of FAR 9.1, including:
 - Adequate financial resources or the ability to obtain them;
 - ability to comply with the required performance period, taking into consideration all existing commercial and governmental business commitments;
 - satisfactory record of integrity and business ethics;
 - necessary organization, experience, and skills or the ability to obtain them;
 - necessary equipment and facilities or the ability to obtain them; and
