**Vehicle Specifications:** Supplying fuel tank under aluminum material cover, for fiberglass boat from the PNP UTOA, details: 1 – Supplying 2 fuel tanks, under aluminum material cover with cap. Approach 450 GL., 2 – Supplying 2 fuel tanks, under aluminum material cover with cap. Approach 350 GL.

Deliver F.O.B. destination to *SENAN Cocolí after “El Puente de Las Americas”*, the port **before to the SENAN base**, no later than **45 days** after contract award or requested. FAR 52.212-1, Instructions to Offerors-Commercial Items, applies to this acquisition. Award will be made to the lowest priced, technically acceptable offeror.
