

### Introduction

The Bureau of International Narcotics and Law Enforcement Affairs (INL) advises the President, Secretary of State, other bureaus in the Department of State, and other departments and agencies within the U.S. Government on the development of policies and programs to combat international narcotics and crime. INL programs support two of the Department's strategic goals: (1) to reduce the entry of illegal drugs into the United States; and (2) to minimize the impact of international crime on the United States and its citizens. Counternarcotics and anticrime programs also complement counterterrorism efforts, both directly and indirectly, by promoting modernization of and supporting operations by foreign criminal justice systems and law enforcement agencies charged with the counter-terrorism mission.

### INL - Peru Background

The International Narcotic and Law Enforcement (INL) section, American Embassy, Lima, Peru, operates one Beech B1900D aircraft based in Lima, Peru. The purpose of this effort is to overhaul two propeller assemblies on the INL B1900D aircraft. This will be accomplished by zero-time overhaul/exchanges for both propeller assemblies to eliminate costly downtime. Both propellers are due overhaul in July, 2014.

#### I. Scope of Services

- A. The Contractor Shall deliver two (02 EA) Exchange (Overhauled FAA Certified) Propellers for INL Lima Beech B1900D Aircraft, to the U.S. Embassy Lima, INL.
- B. This is a "firm-fixed price" type of purchase order/contract.
- C. The price listed below shall include all labor, materials, overhead, profit, and transportation necessary to deliver the required items to the, INL Lima Freight Forwarder, Just in Time (JIT), located in 11380 NW 34th Street, Doral, FL.
- D. All prices are in USD.

#### I.1 Mandatory Directives

- **Zero-time Overhaul / Exchange Program** - The contractor shall have an established zero-time overhaul / exchange program. The contractor shall provide two (02) newly zero-time overhauled propellers by the manufacture or with FAA form 8130-3. Overhaul shall be completed no more than 30 days before delivery.
- **Airworthiness Directives and Mandatory Service Bulletins** - Overhauled propellers shall have all airworthiness directives and mandatory service bulletins complied with. Also, other service bulletins as recommended by the manufacture shall be complied with.

- **Life Limited Components** - Scheduled and unscheduled replacement of life limited components. Any life-limited components shall have 72 months and 4000 hrs remaining on the overhauled propellers.
- **Applicable Standards** - Every aspect of this contract shall comply with all current US Federal Aviation Administration regulations
- **Eligibility, Quality, and Identification of Aeronautical Replacement Parts** - All parts and materials intended for installation on any INL aircraft must comply with the information and guidance as provided with the latest release of US DOT FAA Advisory Circular 20-62 "Eligibility, Quality, and Identification of Aeronautical Replacement Parts". Any suspected unapproved part will be rejected and will not be installed on any INL aircraft.
- **Miscellaneous** - The Beech B1900D aircraft, N85516 has two Hartzell propellers installed, model # HC-E4A-3J.

## I.2 Inspection and Acceptance

Receiving, inspection and acceptance of furnished parts, materials, engines, and components shall be performed at place of performance or destination, by the COR or his designated representative, in accordance with FAR Clause 52.246-2, as applicable, and any other provisions specified in this contract.

The Government reserves the right to investigate and conduct any inspection it deems necessary to assure compliance with DOT FAA Advisory Circular 20-62 "Eligibility, Quality, and Identification of Aeronautical Replacement Parts". Parts, materials, engines, components, found not to be in conformance with AC 20-62 shall be rejected. The Government reserves the right to report any suspected unapproved parts to the Federal Aviation Administration.

## I.3 Place of Inspection and Acceptance

Inspection and acceptance will primarily occur in Lima, Peru.

## I.4 Deliveries or Performance

Work under this contract will primarily be performed at contractor designated facilities.

I.5 Time of Delivery

Overhauled propellers shall be delivered between 01 June 2014 and 15 June 2014.

I.6 Core Charges

Propeller core charges: No core charges may be applied for propeller core returns made within 60 days of delivery of overhauled propeller. Every effort will be made to return the propellers in a timely manner.

I.7 Notice Regarding Late Delivery

The Contractor shall notify the Contracting Officer's Representative, Program Officer, or other authorized representative designated in each task order as soon as it becomes apparent to the Contractor that a scheduled delivery will be late. The Contractor shall include in the notification the rationale for late delivery, the expected date for the delivery and the project impact of the late delivery. Such notification in no way limits the Government's right to any and all rights and remedies but not limited to termination.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (6) Have been voluntarily suspended.

“Sensitive technology”—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—
  - (i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

"Service-disabled veteran-owned small business concern"—
