

IV. DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

The contractor shall write, prepare, and edit in final form for publication, an electronic issue of the U.S. Embassy Newsletter, "Humboldt Current". This newsletter is a weekly publication aimed at the official American community and their families. The newsletter's length varies depending upon material available. The minimum length is 10 pages and the maximum is 24 pages.

The contractor is required to deliver a weekly electronic newsletter with an average length of 18 pages. The software that must be used is Microsoft Publisher on a windows based platform and it must be of a legitimate copy. The contractor shall provide the worksite and equipment necessary to produce the newsletter.

The contractor shall email the finished newsletter to the Community Liaison Office (CLO) no later than 16:00 on Tuesday of each week. The CLO shall review it and notify the editor by noon on Wednesday that the newsletter, as submitted, is acceptable or provide feedback for revision, as required. Required revisions must be completed and the final newsletter re-submitted to the CLO no later than 16:00 on Wednesday of each week.

The newsletter editor must solicit articles and find content for each newsletter. The CLO may assist by publicizing calls for content and forwarding content to the editor. The editor is responsible for providing the front page article which shall be pertinent to the Embassy community (i.e. hail and farewells or articles of interest about travel or customs in Peru). The CLO has overall control over the newsletter content and will give final approval before publication. The types of articles normally contained in the newsletter are listed below, but the editor may include other content that are deem appropriate for publication with the CLO's approval:

- CLO events/activities/calendar
- Flyers used in the newsletter
- Hail and Farewell notices
- Employment announcements
- Employee recognition
- Security Notices and articles
- Health unit articles
- DPO articles and announcements
- Articles of general interests
- Green initiatives
- Restaurant recommendations
- Travel opportunities
- Classified advertisements

- Events in and around Lima
- Family Liaison Office news
- Marine Security Guard events/activities
- Other miscellaneous articles such as those mentioned in FLO Communication

V. INVOICING
