## SCOPE OF WORK (SOW)

### Social-Crime Survey

The American Embassy in Lima-Peru through its agency INL-Police Program and under the Three Year Model Police Station project is seeking a qualified local Consulting Firm to conduct a public opinion survey and establishing a baseline will allow measuring the impact for a period of 36 months. There will be three Social-Crime Survey in three different dates:

First survey prior to the initiation of Police Station Project

Second Social-Crime Survey after 18 months of initiation the project

Third survey after Police Station Project is completed

Additionally is required a Comparative Chart Report of the first and third survey. The three Social-Crime surveys will be conducted among the population/citizen/residents of the neighborhoods of Urbanizacion VIPOL-Callao, areas of San Martin de Porres district: Chinmabanba, Praderas del Sol, Virgen del Carmen, Los Libertadores (*total estimated population 160,000 habitants*) and in Pachacutec Asentamiento Humano, (*total estimated population 280,000 habitants*). Surveys should also include questions to police personnel of each police station under this project: Juan Ingunza Police Station located in Urb. VIPOL, and Pachacutec Police Station located in Avenida 225, No number, in Hiroshima Asentamiento Humano of Pachacutec, both police stations are located in Ventanilla district, province of Callao, department of Lima.

The questionnaires should be conducted three (3) times during the 3 years length of the Model Police Station Project: One survey before the project starts (now), a second survey after eighteen (18) months that the project has started, and a third survey after the project is finished or completed. Additionally after project is completed a comparative chart of the first and third survey to analyze social crime statistics and improvements of the Public Police Service to the citizens. All Interviews should conduct in Spanish language.

The calculation of the sample size will be based on the results of a power analysis, which indicates the minimum sample size required to detect the desired effect. The minimum value for each one of these will be established by technical results of data submitted by municipality of Ventanilla and the Commanders of the two selected Police Stations Juan Ingunza and Pachacutec.

## **Services**

### ***1. FINALIZE SCOPE OF PROJECT AND EXPECTATIONS***

During this first phase, the research team will hold a meeting with Police Program Advisors to finalize the needs, requirements, research plan and institutional work expectations. Similarly, this meeting will serve to clarify any questions, refine the scope of the project and agree on the specific phases that will be carried out during the course of the project. This will include a discussion of the questions to be used in the community survey instrument. Any other aspects pertaining to the execution of the project will also be discussed at this time.

### ***2. PREPARE SURVEY AND COLLECT DATA***

**Selecting the Community Samples:** For practical reasons, it will be assumed that only one family lives in each of the households of the community, unless there is a case where the exact breakdown information is readily available. Therefore, the calculation base to determine the sample will come from data and maps managed by the Municipality of Ventanilla district province of Callao and submitted official information provided by commander of Police Stations Juan Ingunza and Pachacutec. A site visit will be scheduled to the communities in question in order to corroborate the exactness and reliability of the data.

**Develop the Survey Instrument:** A paper and pencil survey instrument will be designed to capture information on community resident's trust in the police, perceptions of police response and activity, victimization experiences, and fear of crime. In the questionnaire should also include the follow questions:

1. Level of school/university/superior institute education of most of residents
2. Number and percentage of genders (feminine, masculine)
3. Number and percentage of residents' age (adults, adolescent and young children 0-10 years old)
4. Number and percentage of Domestic Violence
5. Number and percentage of criminality (rate criminality % zones)
6. Type of crime (s)
7. Number and percentage of type of crime (s)
8. Number of gangs and juvenile delinquent groups

9. Number and percentage of the perception of citizen insecurity in these neighborhoods
10. Number and percentage of the negative and positive perception of the citizens towards the police in getting fast response from the Police in emergency situations.

Questions to PNP Policemen of the Juan Ingunza and Pachacutec Police Stations:

1. Number and percentage of the satisfaction of the policemen assigned to work in the two Police Stations Juan Ingunza and Hiroshima Asentamiento HUmano of Pachacutec, Ventanilla district, province of Callao.
2. Number and percentage of assistance and absence of Policemen assigned to the two Police Stations.
3. Number and percentage of the perception of the quality of police services that they provide to the citizens of Urbanizacion VIPOL, Ventanilla district, Callao, Asentamiento Humano Pachacutec, Ventanilla district, Callao and Chinmabanba, Praderas del Sol, Virgen del Carmen, Los Libertadores in San Martin de Porres district, province of Lima.

***1. Develop Analysis Plan:***

During this sub-phase, and after having completed the design of the instrument, we will proceed to prepare and draft an analysis plan detailing how we will use the information obtained from the surveys. This will include a dissemination plan indicating how the results will be presented so that they are clear, easily understood, and of most use to INL-Police Program.

Survey Reports should submit in Spanish and in English language and provide a briefing in Spanish or English to Police Advisors of INL Police Program.

After each survey the company will present a report and one additional comparative chart report between the first and third survey.

**Proposals**

Proposal (s) Cost should include the length of the survey to complete each survey, a proposed questionnaire in English and Spanish language (called ficha tecnica) and how many interviewers will participate. Any other suggestion from the potential companies or contractor might be included in the proposal cost.

**52.212-1 Instructions to Offerors—Commercial Items.**

As prescribed in 12.301(b)(1), insert the following provision:

(b) *Submission of offers.* Submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation. Offers may be submitted on the SF 1449, letterhead stationery, or as otherwise specified in the solicitation. As a minimum, offers must show—

- (9) Acknowledgment of Solicitation Amendments;
- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Period for acceptance of offers.* The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(d) *Product samples.* When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during preaward testing.

(e) *Multiple offers.* Offerors are encouraged to submit multiple offers presenting alternative terms and conditions or commercial items for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.

(f) *Late submissions, modifications, revisions, and withdrawals of offers.*

(1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and—

(A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or

(B) There is acceptable evidence to establish that it was received at the Government installation designated for receipt of offers and was under the Government's control prior to the time set for receipt of offers; or

(C) If this solicitation is a request for proposals, it was the only proposal received.

(ii) However, a late modification of an otherwise successful offer, that makes its terms more favorable to the Government, will be considered at any time it is received and may be accepted.

(3) Acceptable evidence to establish the time of receipt at the Government installation includes the time/date stamp of that installation on the offer wrapper, other documentary evidence of receipt maintained by the installation, or oral testimony or statements of Government personnel.

(4) If an emergency or unanticipated event interrupts normal Government processes so that offers cannot be received at the Government office designated for receipt of offers by the exact time specified in the solicitation, and urgent Government requirements preclude amendment of the solicitation or other notice of an extension of the closing date, the time specified for receipt of offers will be deemed to be extended to the same time of day specified in the solicitation on the first work day on which normal Government processes resume.

(5) Offers may be withdrawn by written notice received at any time before the exact time set for receipt of offers. Oral offers in response to oral solicitations may be withdrawn orally. (g) *Contract award (not applicable to Invitation for Bids)*. The Government intends to evaluate offers and award a contract without discussions with offerors. Therefore, the offeror's initial offer should contain the offeror's best terms from a price and technical standpoint. However, the Government reserves the right to conduct discussions if later determined by the Contracting Officer to be necessary. The Government may reject any or all offers if such action is in the public interest; accept other than the lowest offer; and waive informalities and minor irregularities in offers received.

(h) *Multiple awards*. The Government may accept any item or group of items of an offer, unless the offeror qualifies the offer by specific limitations. Unless otherwise provided in the Schedule, offers may not be submitted for quantities less than those specified. The Government reserves the right to make an award on any item for a quantity less than the quantity offered, at the unit prices offered, unless the offeror specifies otherwise in the offer.
