INL Logistics section is looking for an "In-house program" for an English course. There is a group of two students with an intermediate level in the English language and 3 students with a basic level in the English language who need to improve their English skills up to advance level and intermediate level correspondingly.

The training will be delivery at the INL Logistics Offices at the Group 8 - Callao, American Hangar located within the Peruvian Air Force Base – Ala Aérea N° 2 (Av. Elmer Faucett cdra. 40 s/n).

The proposal should consider the following:

3 Classes per week for each group for 1 ½ hours each class (4.5 hours per week). Monday, Wednesday and Friday from 12:00 till 13:30 hours and 13:30 till 15:00 hours, plus a 5 minute break for each group.

652.204-70 Department of State Personal Identification Card Issuance Procedures (MAY 2011)

(a) The Contractor shall comply with the Department of State (DOS) Personal Identification Card Issuance Procedures for all employees performing under this contract who require frequent and continuing access to DOS facilities, or information systems. The Contractor shall insert this clause in all subcontracts when the subcontractor's employees will require frequent and continuing access to DOS facilities, or information systems.
