- Information demonstrating the quoter's ability to perform, including:
 - (1) Evidence that the quoter operates an established business with a permanent address and telephone listing.
 - (2) Evidence that the quoter can provide the necessary personnel, equipment, and financial resources needed to perform the work;
 - (3) Proof that quoter has been properly registered at the System for Award Management (SAM) website. Per FAR 4.1102, prospective contractors shall be registered in the SAM (System for Award Management) database prior to award of a contract or agreement. The registration is mandatory for all contracts exceeding \$30,000.

Evaluation Factors

Award will be made to the low price technically acceptable offer.

The evaluation process shall include the following:

- (a) **Compliance Review.** The Government will perform an initial review of quotations received to determine compliance with the terms of the solicitation. The Government may reject as unacceptable quotations that do not conform to the solicitation.
- (b) **Technical Acceptability.** Technical acceptability will include a review any technical information provided by the offeror with its quotation.
- (c) **Price Evaluation.** The lowest price will be determined by multiplying the offered prices times the estimated quantity. The Government reserves the right to reject quotes that are unreasonably low or high in price.

(a) The Contractor shall comply with the Department of State (DOS) Personal Identification Card Issuance Procedures for all employees performing under this contract who require frequent and continuing access to DOS facilities, or information systems. The Contractor shall insert this clause in all subcontracts when the subcontractor's employees will require frequent and continuing access to DOS facilities, or information systems.
