I. SCOPE OF SERVICES

The U.S. Embassy in Warsaw, Poland will hold the "**Consular Leadership Development Course**" **February, 22 - 26, 2016** in Warsaw.

The contractor shall provide hotel rooms, a conference room and miscellaneous services during this conference.

Contractor shall provide a minimum of **10 room nights** and a maximum of **240 room nights**.
Contract type will be indefinite quantity.

Lodging rooms shall include private bath, heating and air conditioning, and telephone in the hotel located in downtown Warsaw within proximity of the U.S. Embassy. Conference space shall be sufficient to accommodate 40 persons, with natural lighting, audio/visual equipment, coffee breaks, lunch and additional furnishing as stated under the conference package.

The Government shall be liable for the price of each room ordered but not used, unless the Contracting Officer gave the Contractor an oral or written cancellation no less than one day before the anticipated effective date.

The contract will be for the period of February 22, 2016 until February 26, 2016 and individual delivery orders shall be issued for a specified number of rooms and miscellaneous services within rates designated.

II. PRICES

A. VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to VAT; this percentage is multiplied only against that portion. It is reflected for each performance period.
