Day 1 started with a networking breakfast at the U.S. Embassy . The delegation met with Portuguese angel investors to share thoughts on how to evaluate and work with startups.

Then, the group spent most of their day at two of Lisbon’s premier business incubators, where they met with hundreds of local entrepreneurs. They led group discussions on marketing

and access to capital. They also participated in one-on-one mentoring sessions.

Feedback was overwhelmingly positive, with Portuguese participants enthusiastic about the “wise advice” and support they received from our team.

Manuel Curado de Sousa Mira, a Portuguese-American entrepreneur and member of the delega-

tion, said that he was so positively impressed by his interactions that he would definitely look to invest when some of the companies went public.

Stephan Morais, who manages one of Portugal’s largest venture capital funds, said that this visit was an important and exciting step to link our respective business communities.
