**1. DESCRIPTION**

A. The United States Embassy in Lisbon, Portugal requires the services of a qualified contractor to qualified contractor to replace the existing intercom and paging system described in the Scope of Work.

B. This is a firm fixed price contract payable in Euros.

**2. CONTRACT PRICE**

A. The Contractor shall complete all work, including furnishing all labor, material, equipment and services, required under this contract. This price listed below shall include all labor, materials, overhead (including cost of Workers' Compensation and War-Hazard Insurance, which shall not be a direct reimbursement) and profit.

B. All prices are in local currency and the Government will make payment in local currency.

**C. VALUE ADDED TAX**

Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the all portions of the contract price are subject to VAT.

**3. PRICING**

#### **4. EFFECTIVE ORDERING PERIOD**

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from date of contract award unless the Contractor agrees to an earlier date) on which performance shall start. The effective ordering period under this contract starts on date shown in the Notice to Proceed.

#### **5. ACCEPTANCE OF SCHEDULE**

When the Government has accepted any time schedule, this acceptance shall be binding on the Contractor. The completion date is fixed and may be extended only by a written contract modification signed by the Contracting Officer. Acceptance or approval of any schedule or revision by the Government shall not:

- (1) extend the completion date or obligate the Government to do so;
- (2) constitute acceptance or approval of any delay, or;
- (3) excuse or relieve the Contractor of its obligation to maintain the progress of the work and achieve final completion by the established completion date.

#### **6. WORKING HOURS**

The Contractor shall perform all work during week days from **Monday to Friday between 8:00 a.m. and 5:00 p.m.** except for the holidays in Section I, DOSAR 652.237-82, "Observance of Legal Holidays and Administrative Leave. The Contracting Officer may approve other hours, if the Contractor gives at least 24 hours advance notice. Contractor initiated changes in work hours will not be a cause for a price increase.

**8. INSURANCE**

A. Amount of Insurance

The Contractor is required to provide whatever insurance is legally necessary under 52.228-5, "Insurance - Work on a Government Installation." The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

  - (c) agents,
  - (d) servants,
  - (e) employees, or
  - (f) any other person,
- arising from an incident to the Contractor's performance of this contract.

The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

**B. Government as Additional Insured**

The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

**C. Insurance-Related Disputes**

Failure to agree to any adjustment contemplated under this contract regarding insurance shall be a dispute within the meaning of FAR 52.233-1, Alternate I, "Disputes". Nothing in this clause shall excuse the Contractor from proceeding with the work, including the repair and/or replacement as herein above provided.

**D. Time for Submission of Evidence of Insurance**

**1. CHARACTER AND SCOPE OF WORK**

The American Embassy in Lisbon requires the services of a qualified contractor to replace the existing intercom and paging system described in this Scope of Work.

**3. SURVEY**

The Contractor shall conduct a survey to verify the required work, to determine if any discrepancies exist. The Contractor shall be responsible for any errors or omissions that might have been avoided by such a survey/review. The Contractor shall immediately report any discrepancies to the COR or the Contracting Officer and shall not begin work until such matters are resolved.

**4. SCOPE OF WORK**

- a) Replace existing intercom and paging system with new equipment specified in the specification portion of the scope of works.
- b) Replace existing wiring, cables and speaker wire.
- c) New wire, cable and speaker wires shall pass through the existing route.
- d) No new wall penetrations will be allowed.

## **INSTALLATION**

### **General:**

Installation includes setting in place, fastening to walls, floors, ceilings, counters, or other

structures where required, interconnecting wiring of the system components, equipment alignment and adjustment, and all other work whether or not expressly required herein which is necessary to result in complete operational systems.

Installation shall be in accordance with, but not limited to, these specifications.

### **Physical Installation:**

Firmly secure equipment in place unless requirements of portability dictate otherwise.

Provide adequate fastenings and support to support load from system with a safety factor of at least three times total load.

Secure boxes, equipment, and similar components plumb and square.

Consider operational efficiency and overall aesthetic factors in the installation of equipment and cable.

### **Cable Installation:**

Mark cables, regardless of length, with wrap around number or letter cable markers at both ends. There shall be no unmarked cables at any place in the system. Marking codes used on cables shall correspond to codes shown on drawings and or wire run sheets.

Neatly strap, dress, and adequately support inter-rack cabling.

Furnish terminal blocks, boards, strips, or connectors for cables that interface with racks, cabinets, consoles, or equipment modules. Do not run audio cables directly to the audio patch panel jacks. Furnish audio patch panel with an audio terminal block; terminate audio cables to and from the audio patch panel on this block.

Group cables according to the signals being carried. To reduce signal contamination, form separate groups for the following cables:

Power cables

Control, data cables

Audio cables carrying signals less than 20 dBm

Audio cables carrying signals between 20 dBm and +20 dBm

Audio cables carrying signals above +20 dBm

Do not allow audio cables to run in the same raceway as video, computer video or power cables.

As a general practice, run power cables, control cables, and high level cables on the left side of an equipment rack as viewed from the rear. Run other cables on the right side of an equipment rack, as viewed from the rear.

Cut cables to the length dictated by the run. Splices in pull boxes are not permitted without prior permission of COR. For equipment mounted in drawers or on slides, provide interconnecting cables with a service loop of appropriate length.

No cable with a bend radius less than that recommended by the cable subcontractor.

Connection Plate Receptacles:

Unless otherwise detailed herein, use the following types of panel receptacles on connection boxes, panels, plates, and wire ways:

Audio (microphone or line level) XLR3 type

Loudspeakers (70 Volt or Low Impedance) - Neutrik "Speakon" type

Cut cables to the length dictated by the run, except video and pulse cables, which may need to be cut to an electrical length. Do not splice in pull boxes without prior permission of COR. For equipment mounted in drawers or on slides, provide interconnecting cables with a service loop of appropriate length.

**GROUNDING**

**Procedures:** To minimize problems resulting from improper grounding and to achieve maximum signal to noise ratios, adhere to the following grounding procedures:

**General:** Because of the great number of possible variations in grounding systems, it is the responsibility of the Contractor, to follow the practices below, and to deviate from these practices only when necessary to minimize cross talk and to maximize signal to noise ratios in the audio, video, and control systems.

**System Grounds:** Establish a single primary “system ground” for the systems in each particular area. Connect grounding conductors in that area to this primary system ground.

Provide the system ground in the audio equipment rack for the area consisting of a copper bar of sufficient size to accommodate secondary ground conductors. Connect the primary system ground bar to the nearest metallic electrical conduit of at least 50 mm in diameter using a copper conductor installed in a raceway, having a maximum of 0.1 □ total resistance.

The Contractor is responsible for determining if the metallic conduit is properly electrically bonded to the building ground system.

Provide secondary system grounding conductors from all racks, audio consoles, and ungrounded audio equipment in each area to the primary system grounding point for the area. Each of these grounding conductors shall have a maximum of 0.1 □ total resistance.

Do not use the AC neutral conductor, either in the power panel or in a receptacle outlet, be used for a system ground; there are no exceptions.

**Audio Cable Shields:** Ground audio cable shields at one point only; there are no exceptions. For inter and intra rack wiring, the shield be connected at one end only. For ungrounded portable equipment, such as microphones, connect the shield at both ends but grounded at only one end.

**General:** Because of the great number of possible variations in grounding systems, it shall be the responsibility of the Contractor, to follow good engineering practice, as outlined above, and to deviate from these practices only when necessary to minimize cross talk and to maximize signal to noise ratios in the audio, video, and control systems.

If the Contractor fails to do so after receipt of a written request to that effect, the Government may have such discrepancies remedied at the Contractor's expense.

(a) In accordance with section 7073 of Division K of the Consolidated Appropriations Act, 2014 (Public Law 113-76) none of the funds made available by that Act may be used to enter into a contract with any corporation that –

(1) Was convicted of a felony criminal violation under any Federal law within the preceding 24 months, where the awarding agency has direct knowledge of the conviction, unless the agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government; or

(2) Has any unpaid Federal tax liability that has been assessed for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability, where the awarding agency has direct knowledge of the unpaid tax liability, unless the Federal agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government.

For the purposes of section 7073, it is the Department of State's policy that no award may be made to any corporation covered by (1) or (2) above, unless the Procurement Executive has made a written determination that suspension or debarment is not necessary to protect the interests of the Government.
