

- E. Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the contract price that is subject to VAT. All items in the solicitation are subject to VAT.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT**

**I. CHARACTER AND SCOPE OF WORK**

The U.S. Embassy has a requirement to have a contractor provide two guard booths meeting the technical specifications in this Statement of Work.

**II. EXISTING CONDITIONS**

The U.S. Embassy is fully operational. The hours of normal operations are Monday – Friday 07:00 to 18:00 hrs.

**III. TECHNICAL SPECIFICATIONS**

- A. The dimensions of the booths shall be no more than 4 feet wide by 9 feet long by 8 feet high.
- B. The lower portion of the booths approximately 1 meter from the bottom edge shall be solid. The upper portion of the booths shall be glass.
- C. Provide sliding windows on both ends of each booth.
- D. The front glass shall be solid not have a window. Contractor shall provide the strength of the glass in their proposal.
- E. Provide a door measuring a minimum of 30 inches (76.3 CM) wide on the rear on the back of each booth swinging outward.
- F. The doors shall have a door knob with a latch.
- G. A formica countertop shall be installed and the length shall be from end to end on each booth at a height of 30 inches (76.2 CM) from the floor. The countertop shall be 3.8cm thick.
- H. The booths shall be water tight.
- I. Contractor shall provide one fluorescent light fixture on the ceilings.

J. Provide one wall switch in each booth to control the lighting.

K. Provide one electrical outlet in each booth.

**IV. PAYMENT**

The United State Government does not pay for goods or services in advance.

**V. INSURANCE**

A. Contractor shall carry liability insurance in the amount specified under Portugal law.

B. Contractor shall furnish proof of liability insurance prior to starting any work.

**VI. GOVERNMENT FURNISHED MATERIALS**

The USG will provide the concrete pad for each booth based on the vendor's requirements.

**VII. WARRANTY**

Contractor shall provide a one year warranty on each booth.
