

1. CHARACTER AND SCOPE OF WORK

The American Embassy in Lisbon requires the services of a qualified contractor to renovate two bathrooms in the Embassy Office Building located at Avenida das Forças Armadas, 131 in accordance with Section C.5 Specifications

2. EXISTING CONDITIONS

- a. The US Embassy is fully operational.
- b. Embassy working hours is 08:00 to 17:00 hrs Monday through Friday.
- c. Materials brought in by contractor will be screened.
- d. Contractor's employees will be escorted, therefore additional time for c. and d. task will be required.

3. SURVEY

- a. The Contractor shall survey the property and verify the required work, to determine if any discrepancies exist. The Contractor shall be responsible for any errors or omissions that might have been avoided by such a survey/review. The Contractor shall immediately report any discrepancies to the COR or the Contracting Officer and shall not begin work until such matters are resolved.

4. PERSONNEL

- a. The contractor shall furnish sufficient personnel with the technical knowledge and experience necessary to complete the work.
- b. Contractor and their Workers shall have knowledge of health and safety issues that apply to basic construction.

5. UTILITIES

- a. The Government will provide all electrical power and water necessary for the contractor to perform their work.

6. SPECIFICATIONS

The contractor shall:

Remove and save all the toilet bowls, urinals, flush valves, sinks, faucets, mirrors, toilet paper holder, hand paper towel dispensers, soap dispensers and electrical hand dryers. Toilet bowls, urinals and flush valves, hand paper towel dispensers, soap dispensers and electrical hand dryers will be reinstalled by the contractor. Contractor is responsible to re-install the above materials.

Remove all existing wall and floor tiles and suspended ceiling and light fixtures. Remove carefully the floor tiles to avoid damaging the floor water proof insulation membrane. Remove existing stainless steel doors and hardware and provide new PVC doors with the same size of the existing ones, handles and locks. Adjustments to existing stone partitions may be required in order to fit new doors and frames in PVC to be provided by the contractor.

Completely prepare surfaces and retile the walls from bottom to the suspended ceiling and floors. Before retiling walls insert in wall a conduit 20mm in diameter to run an electrical wire for the electric hands dryers installation.

Install new suspended ceilings and light fixtures (light fixtures supplied by the Embassy) similar to other already installed in other bathrooms of the Chancery.

The contractor is responsible to supply all the tiles (floor and wall), glue, grout, suspended ceiling, PVC doors, frames, handles and locks(occupied/free) .

Hand polish the marble counter top and marble partitions as well as stainless steel door. Take special care to protect these stones and stainless steel doors during the all demolition and construction process.

Reinstall existing toilet bowls, urinals, new flush valves, existing sinks, faucets, mirrors, toilet paper holder, hand paper towel dispensers, soap dispensers and two electric hand dryers

Test all the hardware, water supply, drainage system and electrical systems for perfect operation.

Contractors are responsible to obtain the correct measurements for tiles and suspended ceiling quantities.

8. SAFETY

- (1) All electrical work shall be performed by Qualified Personnel
- (2) All equipment and circuits to be worked on shall be de-energized before work is started and personnel protected by clearance procedure, lockout/tag out, and grounding.
- (3) Energized work shall never be performed without prior authorization from the Facility Manager
- (4) Live parts of wiring or equipment shall be guarded to protect all persons or objects from harm.
- (5) All workers shall have the required PPE (personal protective equipment) including eye and face protection, head protection and proper safety shoes,
- (6) Contractor shall use a lock out tag out system to isolate power.
- (7) Contractor shall use GFCI's on extension cords for their power tools.
- (8) Contractor shall apply for a burn permit through the Facility Manager when using torches and welding equipment.
- (9) When using welding equipment, contractor shall provide a use a welding shield.
- (10) Contractor shall close the perimeter around the area where the work is taking place to avoid accidents with persons and vehicles circulating in the vicinity.

9. MATERIAL DISPOSAL

Waste material and rubbish shall be placed in containers provided by the contractor

10. HOUSEKEEPING

- a. Work areas and means of access shall be maintained safe and orderly.
- b. Tools, materials, extension cords, hoses or debris shall not cause tripping or other hazards
- c. Floors being used by contractor's labors to remove debris from bathrooms shall be always protected to avoid scratches and stains.

11. SCHEDULE

- a. The contractor shall complete the renovation of one bathroom before initiating the work on the second one in order to have one bathroom fully operational at all times to be used by the Embassy personnel.
- b. The period for the execution of the project of renovation of these two bathrooms shall not exceed 30 calendar days.

12. PAYMENT

U.S. Government does not pay for services in advance. USG pays within 30 days of receipt of the invoice.

13. INSURANCE

Contractor shall carry the minimum liability insurance that is mandatory from the Portuguese government. Contractor shall show prove of insurance.

14. WARRANTY

Contractor shall provide one year warranty against workmanship.
