

**1.0 DESCRIPTION**

1.1 The American Embassy, Lisbon, requires services to perform maintenance on the fire pump and fire sprinkler system as required by the NFPA 25 standard.

1.2 Service work to the fire pump and sprinkler system must be completed in accordance with the following:

NFPA 25; Inspection, Testing, and Maintenance of Water-Based Fire Protection Systems

1.3 The Chancery, located at Avenida das Forças Armadas 131, is protected by an existing fire sprinkler system with a fire pump. The sprinkler system includes a Aurora electric driven pump at 650 gpm pump and Metron controller model M300-60-380C.

**1.4 TYPE OF CONTRACT**

The contract is a firm fixed price contract payable in EUROS. No additional sums will be payable for any escalation in the cost of materials, equipment or labor, or because of the contractor’s failure to properly estimate or accurately predict the cost or difficulty of achieving the results required. These rates include all costs associated with providing maintenances services including materials, labor, insurance, overhead, profit and VAT. The contract will be for one-year period, with four one-year optional periods of performance.

**1.5 PERIOD OF PERFORMANCE**

The contract will be for a period of one-year, with four one-year optional periods of performance and will be expected to commerce no later than October 1, 2013.

**2.0 PRICING**

**3.0 OBJECTIVES**

3.1 The purpose of this scope of work is to define the requirements for the maintenance tasks associated with the wet fire protection system. **The intent of this contract is to fully service**

**and maintain operation of the chancery sprinkler system. Work shall be done in accordance with the project SOW, specifications and be compliant with referenced codes.**

3.2 Restore full monitoring of fire sprinkler functions at fire detection/alarm panel. The serviced fire sprinkler system shall operate in accordance with NFPA 25 as well as the original design intent at installation.

**4.0 GENERAL REQUIREMENTS**

4.1 The Contractor shall provide services necessary to meet objectives shown in 2.0 above. If the need for repairs is discovered during the execution of this PM contract, the labor cost, bill of material, etc will be negotiated and funded under a separate line item.

4.2 All flow tests are to be performed at system designated test points/valves.

4.3 All parts and materials will be government furnished equipment (GFE). Contractor shall provide a list of spare parts.

- a) The Contractor shall provide all tools necessary to perform the work as specified in this SOW.

4.4 The contractor shall be responsible for removal and replacement of all ceiling tiles affected by the work. Contractor shall dispose of any unused pipe, excess materials or other construction debris.

4.5 Qualified Mechanic. Contractor personnel conducting sprinkler and fire alarm system work and/or testing shall be qualified and experienced in accordance with Section 4.3.3 of NFPA 72, *National Fire Alarm Code*.

4.6 Acceptance of Work. The Contractor shall provide certification that work was approved and accepted by the POC at post. The Contractor shall fill out the work order completion form (attachment D) showing work was completed as required in section 3.0 and 4.0 of this SOW and provide the form to the Post Facilities manager or his official representative. The contractor must submit validation that work was completed satisfactorily with request for payment.

4.7 The Contractor shall coordinate all work and testing of systems with the POC at post.

4.8 Contractor shall provide security and travel information to OBO/OM/FIR for personnel traveling to post for generation of the country clearance cable. Information shall be provided at least 14 days prior day of travel, if applicable.

- g) State whether laptop, digital cameras or other electronics is needed for the task.

**5 SPECIFIC REQUIREMENTS**

5.1 Alarm Devices:

- a) All sprinkler alarm devices shall be serviced per the table in Item 4.0. Verify alarm panel device description/location for accuracy.
- b) All sprinkler flow initiation devices shall alarm within 90 second

5.2 Tamper Switch:

- a) Switch shall give immediate activation of supervisory signal at the fire alarm panel.

5.3 System Checks:

- a) No visible water leaks or standing water (clogged drains).
- b) Record all test data, static pressures, residual pressures
- c) Fire pump test shall not activate general alarm (denotes system pressure problems).
- d) During weekly pump runs: verify fire pump and jockey pump start and stop pressures.
- e) Jockey pump stop pressure shall be equal to or higher than fire pump churn (zero flow) pressure. Jockey pump run cycles should be no more than 10 runs within a 24hr period.

5.4 Dry Sprinkler Valves:

- a) All systems must be drained for a minimum of 4 hours following a valve trip test.
- b) Inspect for excessive compressor run.
- c) Check for proper system air pressure per manufacturer’s cut sheet

**6.0 POC AT POST**

6.1 The Point of Contact (POC) will be the contractor’s contact at the U.S. Embassy. The POC will assist and direct the contractor when scheduling work, obtaining approved local supplies, and liaison with Embassy personnel during the course of the Project. **7.0 SECURITY CLEARANCES**

7.1 Work within the CAA must be performed by cleared American workers having Top Secret Security clearances. Non-cleared workers will be escorted by a Cleared American in areas defined by the RSO

**8.0 PAYMENTS**

8.1 The Contractor shall receive payments per the basic contract. The Contractor shall issue invoices on semiannual basis. Prior to the first semiannual invoice, all annual flow tests and system maintenance requirements must be completed.

8.2 The contractor must provide the completed form showing work was accepted by post, with the invoice.

**9.0 INSPECTION BY GOVERNMENT**

The services and the supplies furnished will be inspected from time to time by the COR, or his/her authorized representatives, to determine that all work is being performed in a satisfactory manner, and that all supplies are of acceptable quality and standards.

The Contractor shall be responsible for any countermeasures or corrective action, within the scope of this contract, which may be required by the Contracting Officer as a result of such inspection.

**10.0 QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)**

This plan is designed to provide an effective surveillance method to promote effective Contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

## 10.1 SURVEILLANCE

The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

## 10.2 STANDARD

The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.246-4, Inspection of Services – Fixed Price (AUG 1996)), if any of the services exceed the standard.

## 10.3 PROCEDURES

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

## 11. SECURITY

General. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual. The Government will run background checks on all proposed Contractor employees. The Contractor shall provide the names, biographic data and police clearance on all Contractor personnel who shall work on this contract.

Identity Cards. The Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall display identify card(s) on the uniform at all times while providing services under this contract. These identity cards are the property of the Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves Contractor service, or at the request of the Government.

## 12. STANDARDS OF CONDUCT

(a) General. The Contractor shall maintain satisfactory standards of employee competency, conduct, cleanliness, appearance and integrity and shall be responsible for taking such disciplinary action with respect to employees as required. Each Contractor employee is expected to adhere to standards of conduct that reflect credit on themselves, their employer, and the United States Government. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional cost to the Government.

(b) Uniforms. The Contractor's employees shall wear clean, neat and identifiable uniforms, although not necessarily identical uniforms. All employees shall wear accreditation at all times.

(c) Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities that interfere with normal and efficient Government operations.

(d) Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

(e) Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:

- falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records;
- unauthorized use of Government property, theft, vandalism, or immoral conduct;

- unethical or improper use of official authority or credentials;
- security violations; or,
- organizing or participating in gambling in any form.

(f) **Key Control.** The Contractor shall receive, secure, issue and account for any keys issued for access to buildings, offices, equipment, gates, etc., for the purposes of this contract. The Contractor shall not duplicate keys without the COR's approval. Where it is determined that the Contractor or its agents have duplicated a key without permission of the COR, the Contractor shall remove the individual(s) responsible from this contract. If the Contractor has lost any such keys, the Contractor shall immediately notify the COR. In either event, the contractor shall reimburse the Government for the cost of rekeying that portion of the system.

(g) **Neglect of duties** shall not be condoned. This includes sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personnel affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the work site security.

### **13. PERSONNEL HEALTH REQUIREMENTS**

All employees shall be in good general health without physical disabilities that would interfere with acceptable performance of their duties. All employees shall be free from communicable diseases.

### **14. LAWFUL OPERATION, PERMITS, AND INDEMNIFICATION**

(a) **Bonds.** The Government imposes no bonding requirement on this contract. The Contractor shall provide any official bonds required, pay any fees or costs involved or related to the authorization for the equipping of any employees engaged in providing services specified under this contract if such bonds or payments are legally required by the local government or local practice.

(b) **Employee Salary Benefits.** The Contractor shall be responsible for payment of all employee wages and benefits required by host country law or agreements with its employees. The Government, its agencies, agents, and employees shall not be part of any legal action or obligation regarding these benefits which may subsequently arise. Where local law requires bonuses, specific minimum wage levels, and premium pay for holidays, payments for social security, pensions, sick or health benefits, severance payments, child care or any other benefit, the Contractor is responsible for payments of these costs and must include them in the fixed prices in this contract.

(c) **Personal Injury, Property Loss or Damage (Liability).** The Contractor assumes absolute responsibility and liability for any and all personal injuries or death and property damage or losses suffered due to negligence of the Contractor's personnel in the performance of this

contract. The Contractor's assumption of absolute liability is independent of any insurance policies.

(d) Amount Of Insurance. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

For those Contractor employees assigned to this contract who are either United States citizens or hired in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3.

The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- (a) any property of the Contractor,
- (b) its officers,
- (c) agents,
- (d) servants,
- (e) employees, or
- (f) any other person,

arising from and incident to the Contractor's performance of this contract.

The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

(e) Permits. Without additional cost to the Government, the Contractor shall obtain all permits, licenses, and appointments required for the prosecution of work under this contract. The Contractor shall obtain these permits, licenses, and appointments in compliance with applicable host country laws. The Contractor shall provide evidence of possession or status of application for such permits, licenses, and appointments to the Contracting Officer with its proposal. Application, justification, fees, and certifications for any licenses required by the host government are entirely the responsibility of the Contractor.

(f) Workers' Compensation and Employer's Liability

Workers' Compensation and Occupational Disease is statutory and it is required by host country law, according to Portuguese Decree Law No. 98/2009

**15. ORDERING OFFICIAL**

The designated ordering individual under FAR 52.216-18 is the Contracting Officer.

**16. CERTIFICATE OF INSURANCE**

The Contractor shall furnish to the Contracting Officer a current certificate of insurance as evidence of the insurance required. In addition, the Contractor shall furnish evidence of a commitment by the insurance carrier to notify the Contracting Officer in writing of any material change, expiration or cancellation of any of the insurance policies required not less than thirty (30) days before it is effective. When coverage is provided by self-self insurer, the Contractor shall not change or decrease the coverage without the Contracting Officer's approval.
