**DESCRIPTION/SPECIFICATIONS/WORK STATEMENT**

- 1.0 The work shall meet or exceed the standards as described in Qatar Air Conditioning standards and specifications.

The specification and standard shall comply with specified provisions and recommendations of ASHRAE (American Society of Heating, Refrigerating and Air Conditioning Engineers), NEC of U.S.A. (National Electrical Code of the U.S.A), and UL (Underwriters Laboratories of the U. S. A.).

- 2.0 a) The Contractor shall perform all work required to provide and install two packaged air-cooled, direct expansion (DX) air conditioning (AC) unit. Both the packaged AC unit shall perform according to manufacturer's product data, installation instructions, start-up instructions and maintenance information indicated by all Specification Sections, and Contract Documents with supplementary items necessary for proper operation. The contractor shall select the Packaged AC unit considering extreme weather condition of Qatar.
- b) Air-cooled packaged AC unit shall consist of hermetic scroll compressor component utilizing R- 407C, evaporator coil, air-cooled condenser coil, condenser fans, supply fan, vibration isolation assemblies, and microprocessor control center.
- c) The contractor shall suggest the capacity of the packaged units in his bid after the site visit. If contractor's bid is selected then he must produce the product manual of the packaged unit to the COR and get approval prior to installation. The Product Data shall consist of:
- i) Provide literature that indicates dimensions, weight, loading, clearances, capacities, gauges, thickness, and finishes of materials, electrical characteristics and connections.
  - ii) Rigging, installation, testing, start-up and operating instructions, maintenance data including type and quantity of oil and refrigerant change, parts lists, and troubleshooting guide.
  - iii) Data on energy input versus cooling load output from 100 percent to 20 percent of full load with constant entering condenser air temperature.
  - iv) Information about control and wiring diagrams.
  - v) Product test data on sound power levels for both fan inlet and outlet at the rated design capacity.
  - vi) Operating data such as fans speeds, compressor Locked Running Ampere (LRA) and Running Ampere (RA) and sound levels.
  - vii) Product data on special condenser coating.
  - viii) Product data on all condenser fan accessories such as controls.

2.2 The Contractor shall visit the site before submitting any bids. During site visit the Contractor shall ensure the following:

- i) Location of existing two packaged unit.
- ii) Air conditioning ducts installed for both of the units.
- iii) Heights and layouts of the ducts.
- iv) Area and volume of the Warehouse.
- v) Difficult areas where it is hard to reach with machines.
- vi) Note any potential obstacles or problems that might be encountered.

2.3 **REMOVE EXISTING UNIT:** The contractor shall replace the units one by one, i.e. when one existing unit has been replaced with a new one, it should be operative after commissioning and testing. Then the contractor can start replacing the other one. Go through the following steps while dismantling the unit:

i) Switch off the isolator of the packaged unit. The contractor must follow “Lock out Tag out” policy while working on the electrical circuit of the units throughout the installation process. Disconnect all electrical wires from the unit. Must ensure to insulate bare parts of the wires properly after disconnecting from the unit.

The contractor may use existing electrical cable that ran from the main isolator, (which supplies power to the isolator of a particular unit) to the unit.

ii) After disconnecting the electrical wire, the contractor shall recover refrigerant R-22 from the existing unit. The contractor shall bring his own refrigerant recovery machine. Refrigerant of the existing unit must not be exposed at the atmosphere by any means.

When ensured no more refrigerant is left over, the contractor shall dismantle the unit and dispose of disassembled unit or other construction debris to a specified location. Debris shall be cleaned on regular basis.

The contractor shall make every effort to protect the adjacent property. After completion of all work, the contractor is responsible for restoration or better, of any damages incurred during implementation of the plan.

iii) The contractor shall demolish concrete structures on which the AC unit is installed. Remove debris from site on regular basis. ...

2.4 **INSTALLATION OF THE NEW UNIT:** i) The contractor shall carefully read all instructions for the installation prior to installing unit. Make sure each step and procedure is understood and any special considerations are taken into account before starting installation. Assemble all tools, hardware and supplies needed to complete the installation.

ii) **Pre-Installation Checkpoints**

Before attempting any installation, the following points should be considered:

- Structural strength of supporting members

- Clearances and provision for servicing
- Power supply and wiring – The contractor must conduct a Meggar Test of the power supply cable and provide the test result to the COR.
- Air duct connections
- Drain facilities and connections

iii) Space clearance required for the new unit. – Before installation of the unit the contractor shall follow instructions mentioned in the product manual.

iv) Concrete slab installation:

- The contractor shall build new concrete slabs on which new package unit shall be installed. The contractor must follow the instructions as mentioned in the product manual for dimensions and size of the concrete structures. Before building the concrete slabs compact the ground properly by following the instructions as mentioned in Qatar Civil Specification. Concrete structures shall be made of R.C.C. (Reinforced Cement Concrete) consist of 10 mm. dia. steel bars. Ensure proper levelling of each surface of the slabs. The contractor must ensure curing of the concrete structures as mentioned in Qatar Civil Specification.
- Consider the effect of outdoor fan noise on conditioned space and any adjacent occupied space. The slab should be above ground level at least 4” and surrounded by an area for good drainage. Any slab used as a unit’s foundation should not adjoin the building as it is possible that sound and vibration may be transmitted to the structure.
- The contractor shall select a location that will minimize modification work for the length of the supply and return ducts.
- Select a location where external water drainage cannot collect around the unit.

v) Unit placement and connection with existing duct:

- The unit must be installed as per product’s manual.
- Unit must be placed on anti-vibration rubber pads. The rubber pads must suitable enough so those don’t get damage due to the weight of the unit, due to vibration of the running unit and due to wear and tear considering extreme weather condition of Doha.
- The unit must be situated to permit free unobstructed drainage of the defrost water and ice. A minimum 2" clearance under the outdoor coil is required.
- The contractor shall modify duct at the exterior of the warehouse (Please note ducting inside the warehouse remain be same as it, need not any modification). The contractor shall replace the insulation of the duct; the contractor shall use insulation material of same specification and quality with the existing one. Before replacing the insulation the

contractor must verify condition of the duct's metal portion. Damage metal portions need to be replaced.

- Ducts should run as directly as possible to supply and return outlets. Use of non-flammable weatherproof flexible connectors on both supply and return connections at the unit to reduce noise transmission is recommended. Once the duct is affixed to the unit, seal the collars and flanges with a proper waterproof sealant.
- vi) Filter: If the filters are not provided with unit, the contractor must supply and install both Pre-Filter and HEFA (High Efficiency Particulate Arresting) filter the supply duct system. A field installed filter grille as recommended by the manufacturer for easy and convenient access to the filters for periodic inspection and cleaning.

Filters must have adequate face area for the rated quantity of the unit. The contractor shall follow the instruction as mentioned in the Product data for recommended filter size.

- vii) Fabrication and masonry job: The contractor shall conduct all necessary fabrication and masonry work related with the project.

- viii) Electrical Wiring:

**Note: NO SPLICING OF WIRES OR WIRE JOINTS BY ANY MEANS INSIDE THE CONDUIT RUNS SHALL BE PERMITTED.**

- All wiring should be made in accordance with the National Electrical Code. The voltage, frequency, and phase at the power supply should be checked to make sure it corresponds to the unit's RATED VOLTAGE REQUIREMENT.
- Arrange electrical cabinet for connecting electrical service at one point only.
- The contractor shall install a branch circuit isolator (preferably a miniature circuit breaker) near to the unit, in accordance with the N.E.C. or local codes. Wire sizes and overcurrent protection should be determined from the unit nameplate ampacity and in the product data. Under no circumstances should wiring be sized smaller than is recommended by either of these two sources.
- Electrical connection has been drawn through a distribution panel installed inside the warehouse having a main supply of 125 Amp Miniature Circuit Breaker (MCB) for one unit and 63 Amp Miniature Circuit Breaker (MCB) for the other. The contractor gets familiar with these MCBs during site visit.
- Both the packaged AC units got electrical power from one weatherproof type isolator each, which are installed on the exterior wall of warehouse close to each unit. The contractor shall replace both the isolators with UL approved weather proof type isolators. The rating of the new isolators shall comply with the product data. The contractor shall provide and install the isolators. The contractor shall replace the electrical cable from the isolators to the units. Size and rating of the electrical cable

should be as per product data. Electrical cable shall be drawn through recommended G.I. conduit.

- Remove existing electrical cable including the G.I. conduits and the undergrounded portion which has been installed from the isolator to the unit. After replacing the G.I conduit and run the electrical cable, contractor shall back fill sand and place concrete precast blocks again and flush ground surface level with the existing.
- Internal Wiring –

Note: NO SPLICING OF WIRES OR WIRE JOINTS BY ANY MEANS INSIDE THE CONDUIT RUNS, MANHOLES, SHALL BE PERMITTED.

Power and control wiring of the unit shall be factory installed complete within the unit. Provide correctly identified suitable lugs and terminal strips for field connection to electrical power and external controls.

Factory equipped unit with motor starters for each of the motor driven components.

All materials should be UL approved type.

- ix) IMPORTANT NOTE: The contractor shall follow the same procedure for the other unit. All installation and other procedures shall be in accordance with manufacturer's published recommendations.

## 2.5 COMMISSIONING AND TESTING OF THE UNIT:

- i) The contractor shall perform all commissioning and testing as recommended in product manual.
- ii) Equipment shall be cycled through all heating, cooling, and ventilation cycles to ensure proper operation of all components and controls prior to test and balance.
- iii) At time of Start-up, manufacturer's representative shall visit the project site and verify that unit installation and performances are satisfactory, and to make any adjustments or settings to unit operating and safety controls that may be required.
- iv) The contractor's report shall include start-up checkout service of at least one working day for one service technician, including a written report of operational check provided to the COR.

## 2.6 CLEANING OF THE DUCT INSIDE THE WAREHOUSE:

- i) The contractor shall clean the air conditioning ducts installed inside the warehouse.
- ii) Examine ducts around the air handler for holes, loose tape or separated sections that might allow air infiltration.
- iii) The contractor shall remove supply and return grills and diffusers. Clean grills/diffusers and remove debris from accumulating in ducts and clogging filters. Contractor shall clean the duct by suitable vacuum cleaner, which should reach every

portion and every corner of interior portion of the duct. Reinstall grill and diffusers after cleaning.

iv) After cleaning the duct to create positive pressure with clean air inside the warehouse.

### 3.0 SAFETY REQUIREMENTS:

3.1 The contractor must submit a “safety plan” for Post Occupational Safety Health Officer’s (OSHA) approval before commencement of work. The OSHA will review the safety plan and when approved, the contractor will be given a green signal for commencement of any job.

- c) Persons shall be provided with eye and face protective equipment to protect eye or face from injury due to physical, chemical or radiation agents. Safety goggles with safety lenses and screens for side protection shall be used.
- d) Workers at site shall wear protective hard hats whenever work is or materials are overhead.
- e) Approved respiratory devices suitable for their intended use shall be worn. The contractor shall provide safety masks that are appropriate for the type of work and

materials that are being used in order to prevent against exposure to respiratory hazards.

## 5. WARRANTIES

The Contractor shall submit both information and the guarantee or warranty to the Government in sufficient time to permit the Government to meet any time limit requirements specified in the guarantee or warranty, but not later than completion and acceptance of all work under this contract.

## 6. WORKING HOURS

The Contractor shall perform all work during the regular working hours (08:00 to 16:30) Sunday thru Thursday with except for the holidays identified in Section I, DOSAR 652.232-70, "Observance of Legal Holidays and Administrative Leave. The Contracting Officer may approve other hours, if the Contractor gives at least 24 hours advance notice. Contractor initiated changes in work hours will not be a cause for a price increase.

## QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

- (2) The abuse or threatened abuse of the legal process.

**Severe forms of trafficking in person's means —**

(1) Sex trafficking in which a commercial sex act is induced by force, fraud, or coercion, or in which the person induced to perform such act has not attained 18 years of age; or

(2) The recruitment, harboring, transportation, provision, or obtaining of a person for labor or services, through the use of force, fraud, or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage, or slavery.

**Sex trafficking** means the recruitment, harboring, transportation, provision, or obtaining of a person for the purpose of a commercial sex act.

**Subcontract** means any contract entered into by a subcontractor to furnish supplies or services for performance of a prime contract or a subcontract.

**Subcontractor** means any supplier, distributor, vendor, or firm that furnishes supplies or services to or for a prime contractor or another subcontractor. United States means the 50 States, the District of Columbia, and outlying areas.

**(b) Policy.**

The United States Government has adopted a policy prohibiting trafficking in persons including the trafficking-related activities of this clause. Contractors, contractor employees, and their agents shall not —

(1) Engage in severe forms of trafficking in persons during the period of performance of the contract;

(2) Procure commercial sex acts during the period of performance of the contract;

(3) Use forced labor in the performance of the contract;

(4) Destroy, conceal, confiscate, or otherwise deny access by an employee to the employee's identity or immigration documents, such as passports or drivers' licenses, regardless of issuing authority;

(5) (i) Use misleading or fraudulent practices during the recruitment of employees or offering of employment, such as failing to disclose, in a format and language accessible to the worker, basic information or making material misrepresentations during the recruitment of employees regarding the key terms and conditions of employment, including wages and fringe benefits, the location of work, the living conditions, housing and associated costs (if employer or agent provided or arranged), any significant cost to be charged to the employee, and, if applicable, the hazardous nature of the work;

(ii) Use recruiters that do not comply with local labor laws of the country in which the recruiting takes place;

(6) Charge employees recruitment fees;

(7) (i) Fail to provide return transportation or pay for the cost of return transportation upon the end of employment —

(A) For an employee who is not a national of the country in which the work is taking place and who was brought into that country for the purpose of working on a U.S. Government contract or subcontract (for portions of contracts performed outside the United States); or

(B) For an employee who is not a United States national and who was brought into the United States for the purpose of working on a U.S. Government contract or subcontract, if the payment of such costs is required under existing temporary worker programs or pursuant to a written

agreement with the employee (for portions of contracts performed inside the United States); except that —

(ii) The requirements of paragraphs (b)(7)(i) of this clause shall not apply to an employee who is — (A) Legally permitted to remain in the country of employment and who chooses to do so; or (B) Exempted by an authorized official of the contracting agency from the requirement to provide return transportation or pay for the cost of return transportation;

(iii) The requirements of paragraph (b)(7)(i) of this clause are modified for a victim of trafficking in persons who is seeking victim services or legal redress in the country of employment, or for a witness in an enforcement action related to trafficking in persons. The contractor shall provide the return transportation or pay the cost of return transportation in a way that does not obstruct the victim services, legal redress, or witness activity. For example, the contractor shall not only offer return transportation to a witness at a time when the witness is still needed to testify. This paragraph does not apply when the exemptions at paragraph (b)(7)(ii) of this clause apply.

(8) Provide or arrange housing that fails to meet the host country housing and safety standards; or

(9) If required by law or contract, fail to provide an employment contract, recruitment agreement, or other required work document in writing. Such written work document shall be in a language the employee understands. If the employee must relocate to perform the work, the work document shall be provided to the employee at least five days prior to the employee relocating. The employee's work document shall include, but is not limited to, details about work description, wages, prohibition on charging recruitment fees, work location(s), living accommodations and associated costs, time off, roundtrip transportation arrangements, grievance process, and the content of applicable laws and regulations that prohibit trafficking in persons.

**(c) Contractor requirements.** The Contractor shall —

(1) Notify its employees and agents of — (i) The United States Government's policy prohibiting trafficking in persons, described in paragraph (b) of this clause; and (ii) The actions that will be taken against employees or agents for violations of this policy. Such actions for employees may include, but are not limited to, removal from the contract, reduction in benefits, or termination of employment; and

(2) Take appropriate action, up to and including termination, against employees, agents, or subcontractors that violate the policy in paragraph (b) of this clause.

**(d) Notification.**

(1) The Contractor shall inform the Contracting Officer and the agency Inspector General immediately of —

(i) Any credible information it receives from any source (including host country law enforcement) that alleges a Contractor employee, subcontractor, subcontractor employee, or their agent has engaged in conduct that violates the policy in paragraph (b) of this clause (see also 18 U.S.C. 1351, Fraud in Foreign Labor Contracting, and 52.203-13(b)(3)(i)(A), if that clause is included in the solicitation or contract, which requires disclosure to the agency Office of the Inspector General when the Contractor has credible evidence of fraud); and

(ii) Any actions taken against a Contractor employee, subcontractor, subcontractor employee, or their agent pursuant to this clause.

(2) If the allegation may be associated with more than one contract, the Contractor shall inform the contracting officer for the contract with the highest dollar value.

**(e) Remedies.**

In addition to other remedies available to the Government, the Contractor's failure to comply with the requirements of paragraphs (c), (d), (g), (h), or (i) of this clause may result in —

- (1) Requiring the Contractor to remove a Contractor employee or employees from the performance of the contract;
- (2) Requiring the Contractor to terminate a subcontract;
- (3) Suspension of contract payments until the Contractor has taken appropriate remedial action;
- (4) Loss of award fee, consistent with the award fee plan, for the performance period in which the Government determined Contractor non-compliance;
- (5) Declining to exercise available options under the contract;
- (6) Termination of the contract for default or cause, in accordance with the termination clause of this contract; or
- (7) Suspension or debarment.

**(f) Mitigating and aggravating factors.** When determining remedies, the Contracting Officer may consider the following:

- (1) Mitigating factors. The Contractor had a Trafficking in Persons compliance plan or an awareness program at the time of the violation, was in compliance with the plan, and has taken appropriate remedial actions for the violation, that may include reparation to victims for such violations.
- (2) Aggravating factors. The Contractor failed to abate an alleged violation or enforce the requirements of a compliance plan, when directed by the Contracting Officer to do so.

**(g) Full cooperation.**

(1) The Contractor shall, at a minimum —

- (i) Disclose to the agency Inspector General information sufficient to identify the nature and extent of an offense and the individuals responsible for the conduct;
- (ii) Provide timely and complete responses to Government auditors' and investigators' requests for documents;
- (iii) Cooperate fully in providing reasonable access to its facilities and staff (both inside and outside the U.S.) to allow contracting agencies and other responsible Federal agencies to conduct audits, investigations, or other actions to ascertain compliance with the Trafficking Victims Protection Act of 2000 (22 U.S.C. chapter 78), E.O. 13627, or any other applicable law or regulation establishing restrictions on trafficking in persons, the procurement of commercial sex acts, or the use of forced labor; and
- (iv) Protect all employees suspected of being victims of or witnesses to prohibited activities, prior to returning to the country from which the employee was recruited, and shall not prevent or hinder the ability of these employees from cooperating fully with Government authorities.

(2) The requirement for full cooperation does not foreclose any Contractor rights arising in law, the FAR, or the terms of the contract. It does not —

- (i) Require the Contractor to waive its attorney-client privilege or the protections afforded by the attorney work product doctrine;

- (ii) Require any officer, director, owner, employee, or agent of the Contractor, including a sole proprietor, to waive his or her attorney client privilege or Fifth Amendment rights; or
- (iii) Restrict the Contractor from —
  - (A) Conducting an internal investigation; or
  - (B) Defending a proceeding or dispute arising under the contract or related to a potential or disclosed violation.

**(h) Compliance plan.**

(1) This paragraph (h) applies to any portion of the contract that — (i) Is for supplies, other than commercially available off-the-shelf items, acquired outside the United States, or services to be performed outside the United States; and (ii) Has an estimated value that exceeds \$500,000.

(2) The Contractor shall maintain a compliance plan during the performance of the contract that is appropriate — (i) To the size and complexity of the contract; and (ii) To the nature and scope of the activities to be performed for the Government, including the number of non-United States citizens expected to be employed and the risk that the contract or subcontract will involve services or supplies susceptible to trafficking in persons.

(3) Minimum requirements. The compliance plan must include, at a minimum, the following: (i) An awareness program to inform contractor employees about the Government's policy prohibiting trafficking-related activities described in paragraph (b) of this clause, the activities prohibited, and the actions that will be taken against the employee for violations. Additional information about Trafficking in Persons and examples of awareness programs can be found at the Web site for the Department of State's Office to Monitor and Combat Trafficking in Persons at <http://www.state.gov/j/tip/>. (ii) A process for employees to report, without fear of retaliation, activity inconsistent with the policy prohibiting trafficking in persons, including a means to make available to all employees the hotline phone number of the Global Human Trafficking Hotline at 1-844-888-FREE and its email address at [help@befree.org](mailto:help@befree.org). (iii) A recruitment and wage plan that only permits the use of recruitment companies with trained employees, prohibits charging recruitment fees to the employee, and ensures that wages meet applicable hostcountry legal requirements or explains any variance. (iv) A housing plan, if the Contractor or subcontractor intends to provide or arrange housing, that ensures that the housing meets host-country housing and safety standards. (v) Procedures to prevent agents and subcontractors at any tier and at any dollar value from engaging in trafficking in persons (including activities in paragraph (b) of this clause) and to monitor, detect, and terminate any agents, subcontracts, or subcontractor employees that have engaged in such activities.

(4) Posting.

(i) The Contractor shall post the relevant contents of the compliance plan, no later than the initiation of contract performance, at the workplace (unless the work is to be performed in the field or not in a fixed location) and on the Contractor's Web site (if one is maintained). If posting at the workplace or on the Web site is impracticable, the Contractor shall provide the relevant contents of the compliance plan to each worker in writing.

(ii) The Contractor shall provide the compliance plan to the Contracting Officer upon request.

(5) Certification. Annually after receiving an award, the Contractor shall submit a certification to the Contracting Officer that — (i) It has implemented a compliance plan to prevent any prohibited activities identified at paragraph (b) of this clause and to monitor, detect, and terminate any agent, subcontract or subcontractor employee engaging in prohibited activities; and (ii) After having conducted due diligence, either — (A) To the best of the Contractor's knowledge and belief, neither it nor any of its agents, subcontractors, or their agents is engaged in any such activities; or (B) If abuses relating to any of the prohibited activities identified in paragraph (b) of this clause have been found, the Contractor or subcontractor has taken the appropriate remedial and referral actions.

**(i) Subcontracts.**

(1) The Contractor shall include the substance of this clause, including this paragraph (i), in all subcontracts and in all contracts with agents. The requirements in paragraph (h) of this clause apply only to any portion of the subcontract that —

(A) Is for supplies, other than commercially available off-the-shelf items, acquired outside the United States, or services to be performed outside the United States; and

(B) Has an estimated value that exceeds \$500,000.

(3) If any subcontractor is required by this clause to submit a certification, the Contractor shall require submission prior to the award of the subcontract and annually thereafter.

The certification shall cover the items in paragraph (h)(5) of this clause.

(a) Authorization to operate and do business in Qatar, and necessary licenses and permits. (Qatari Commercial licenses, Company Commercial Card, Tax Card...

(b) Name of a Project Manager (or other liaison to the Embassy/Consulate) who understands written and spoken English;

(b) Evidence that the offeror/quoter operates an established business with a permanent address and telephone listing;

3. List of clients over the past **(7) years**, demonstrating prior experience with relevant past performance information and references (provide dates of contracts, places of performance, value of contracts, contact names, telephone and fax numbers and email addresses). If the offeror has not performed comparable services in Qatar then the offeror shall provide its international experience. # Quick Start Guide For New Foreign Registrations

## Helpful Information

SAM is the official **free, government-operated website** – there is NO charge to register or maintain your entity registration record in SAM.

### What is an Entity?

In SAM, your company / business / organization is referred to as an "Entity." You register your entity to do business with the U.S. Federal government by completing the registration process in SAM.

### What do I need to get started?

1. **DUNS Number:** You need a Data Universal Numbering System (DUNS) number to register your entity in SAM. DUNS numbers are unique for each physical location you want to register.
2. **NATO Commercial and Government Entity (NCAGE) Code:** Foreign entities must obtain a NCAGE code for each DUNS number they plan to register in SAM before you start the registration process.

### How do I get a DUNS number?

If you do not have one, you can request a DUNS number for **free** to do business with the U.S. Federal government by visiting Dun & Bradstreet (D&B) at <http://fedgov.dnb.com/webform>. It takes up to 5 business days to obtain an international DUNS number.

### How do I get an NCAGE code?

For instructions on obtaining a NCAGE, visit: [http://www.dlis.dia.mil/Forms/Form\\_AC135.asp](http://www.dlis.dia.mil/Forms/Form_AC135.asp). Make sure the name and address information you provide to get your NCAGE code is the same as what you used to get your DUNS number. It takes up to 3 business days to obtain a NCAGE code.

### What about a Taxpayer Identification Number (TIN)?

You only need a TIN if your entity pays U.S. taxes. If you are a foreign entity that does not pay taxes in the U.S., do not enter a number in the TIN field during registration.

## Steps for Registering

1. Type [www.sam.gov](http://www.sam.gov) in your Internet browser address bar.
2. Create a SAM Individual User Account (be sure to validate your e-mail address to activate the user account), then Login.
3. Select "Register New Entity" under "Register/Update Entity" on your "My SAM" page.
4. Select your type of Entity, most likely "Business or Organization." Definitions are in the Content Glossary on the right side of the page.
5. Tell the system why you are registering in SAM. This determines what information you have to provide.
  - Are you interested in bidding on Federal contracts? If you say "Yes," you will complete all four sections in SAM.
  - Are you just interested in becoming eligible to apply for grants or other Federal financial assistance? If you say "No" to the contracts question and "Yes" to the grants question, you will only have to complete the grant-related information.
6. Complete your registration. On each page, required information that you must provide has a red asterisk (\*) next to the name of the field. Here are a few helpful hints:
  - On the Business Information page, you will create a Marketing Partner Identification Number (MPIN). Write your MPIN down. It is used as a password in other government systems.
  - If you do not pay U.S. taxes, do not enter a TIN or select a TIN type. Leave those fields blank.
  - Only use the NCAGE code you got for your DUNS number. Remember, the name and address information must match on the DUNS and NCAGE records.
  - Make sure to select "Foreign Owned and Located" on the General Information page.
  - As a foreign entity, you do not need to provide Electronic Funds Transfer (EFT) banking information on the Financial Information page. If you do choose to provide this electronic banking information, it must be for a U.S. bank: SAM cannot accept foreign banking information. The remittance name and address are the only mandatory information for you on this page.
  - In the "Points of Contact" section, list the names of people in your organization who know about this registration in SAM and why you want to do business with the U.S. Federal government. These are called "Points of Contact" or POCs.
7. Make sure to hit [Submit] after your final review. You will get a *Congratulations* message on the screen. If you do not see this message, you did not submit your registration. What happens next?
  - Once approved by the IRS (if you entered a TIN) and the Commercial and Government Entity (CAGE) system, you will get an email from SAM.gov when your entity registration is active.

**Please give yourself plenty of time before your contract or grant application deadline. Allow up to 10 business days after you submit before your registration is active in SAM, then an additional 24 hours for other systems such as Grants.gov to recognize your information.**

## SECTION 4 - EVALUATION FACTORS

- The Government will determine contractor responsibility by analyzing whether the apparent successful offeror complies with the requirements of FAR 9.1, including:
  - Adequate financial resources or the ability to obtain them;
  - Ability to comply with the required performance period, taking into consideration all existing commercial and governmental business commitments;
  - Satisfactory record of integrity and business ethics;
  - Necessary organization, experience, and skills or the ability to obtain them;
  - Necessary equipment and facilities or the ability to obtain them; and
  - Be otherwise qualified and eligible to receive an award under applicable laws and regulations.

## SECTION 5 - REPRESENTATIONS AND CERTIFICATIONS

### 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS—COMMERCIAL ITEMS (NOV 2015)

The offeror shall complete only paragraphs (b) of this provision if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site accessed through <http://www.acquisition.gov>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (p) of this provision.

(a) *Definitions.* As used in this provision--

“Economically disadvantaged women-owned small business (EDWOSB) concern” means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

“Forced or indentured child labor” means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

“Highest-level owner” means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

“Immediate owner” means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

“Inverted domestic corporation,” means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
