I. SCOPE OF SERVICES

Contractor shall provide:

- hotel rooms for 30 participants, single rooms x 3 nights (check in November 23, check out November 26 )
- Conference room rental x 2 days (November 24-25) –U-shape preferred set-up or classroom/cabaret set up for 55 participants, with sound system, audio/video equipment, projection screen/system, wireless internet, power outlets for 30 laptop computers, 2 mobile microphones and 2 fixed on head table and private area for breakout sessions with seating area or conference room large enough to accommodate 5 group breakout sessions during training
- Buffet lunch for 55 participants x 2 days ( November 24-25)
- Coffee breaks for 55 participants – 2 per training day x 2 days (November 24-25)
- Buffet dinner for 55 participants ( November 24) with seating area

Contract type will be firm fixed price.

Lodging rooms shall include private bath, heating and air conditioning, and telephone, in hotel located *in Bucharest, downtown area*. The Government shall be liable for the price of each room ordered but not used, unless the Contracting Officer gave the Contractor an oral or written cancellation no less than one day before to the anticipated effective date of the cancellation.

### C. VALUE ADDED TAX (VAT)

VALUE ADDED TAX. Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to VAT; this percentage is multiplied only against that portion. It is reflected for each performance period. - (a) Make its award based on comparisons of price, past performance, and unique qualifications which meet the level of quality required to meet the Government's security and logistical requirements. Award will be made to the lowest priced, technically acceptable hotel.
  - (b) Regardless of whether the procedures in paragraph (1) or (2) above were followed, selection of contractors shall not be protestable to GAO under FAR subpart 33.1, except on the grounds that the order increases the scope, period, or maximum value of the contract. However, the Department of State does have an Acquisition Ombudsman who will review complaints by contractors to ensure that all contractors are afforded a fair opportunity to be considered for these task orders, pursuant to the procedures for award of task orders established herein.
- (4) Exceptions to the procedures in paragraph (3) above:
- (a) The agency need for the required services is of such urgency that providing such competitive opportunity would result in unacceptable delays;

The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.
