

1. PRICES AND PERIOD OF PERFORMANCE

The Contractor shall perform janitorial work, including furnishing all labor, material, equipment and services, for the U.S. Consulate General in St. Petersburg, Russian Federation. The price listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. The Government will pay the Contractor a fixed rate for services that have been satisfactorily performed.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from start date listed in Notice to Proceed unless the Contractor agrees to an earlier date) on which performance shall start.

The performance period of this contract is from the start date in the Notice to Proceed and continuing for 12 months, with four, one-year options to renew.

1.1 VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to VAT; this percentage is multiplied only against that portion. It is reflected for each performance period. SCHEDULE OF SUPPLIES/SERVICES, BLOCK 20
DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

1. SCOPE OF WORK

The purpose of this fixed price contract is to obtain janitorial services for real property owned or managed by the U.S. Consulate in St. Petersburg. The Contractor shall perform janitorial services in all designated spaces including, but not limited to halls, offices, restrooms, work areas, entrance ways, lobbies, balconies, kitchens, and stairways. The contract will be for a one year period from the date of the contract award, with four one-year options.

The Contractor shall furnish all managerial, administrative, and direct labor personnel that are necessary to accomplish the work in this contract. Contractor employees shall be on site only for contractual duties and not for other business purposes.

1.1 General Instructions

The Contractor shall prepare general instructions for the work force. The Contractor shall provide drafts to the Contracting Officer's Representative (COR) for review within thirty days after contract award. The Contracting Officer's Representative must approve these general instructions before issuance.

1.2 Duties and Responsibilities

1.2.1 Areas listed in paragraph #3 require an escort and can only be entered during scheduled times. The General Instructions shall emphasize security requirements so that accidental security violations do not occur.

1.2.2 Contractor shall schedule periodic cleaning requirements so that it causes minimal disruption to the normal operation of the facility. The COR shall determine the schedules presented which meet the needs of the individual facility.

1.3 Types of Services

1.3.1 Standard Quarterly Services shall include the following work:

1.3.1(a) Removing and washing 20 (twenty) window blinds in the Consular section including wiping blinds with a damp cloth to ensure that all smudges are removed. When cleaning finished all blinds shall be installed back. The size of each blinds section is 2280x1210mm. When completed the blinds shall be free from dust, dirt and stains.

1.3.1(b) Thorough cleaning and sanitizing 25 restrooms, including cleaning of toilets, bathrooms, mirrors, and shower facilities, using suitable non-abrasive cleaners and disinfectants. Cleaning and sanitizing toilet bowls (inside and outside), sinks and faucets. Descale toilet bowls. When completed all surfaces shall be free of grime, soap scum, mold, smudges, lime and mineral deposits.

1.3.1(c) Thorough cleaning of 10 kitchens. Each kitchen is equipped with a dishwasher, a microwave oven and a refrigerator. These appliances must be cleaned inside and outside including vacuuming dust from around motor areas.

All kitchen furniture and equipment surfaces shall be wiping with clean, dry cloths saturated with the specially formulated cleaning solution or cleaning wax both inside and outside. All removable parts (shelves, drawers) shall be removed and cleaned also. The area around the knobs and switches shall be free of grease. If you need to remove the knobs, make sure you return them in the correct order. Washing of dishes and other kitchenware shall not be performed.

When completed the furniture shall be free of dust and stains and have polished surfaces. Kitchen sinks and faucets shall be free of lime and mineral deposits and have shiny surfaces. The entire dishwasher, oven, microwave and refrigerator shall be free of grease, spills and crumbs. Don't use any of harsh cleaning chemicals which can cause etching and scratches in the surface.

1.3.1(d) Dusting and wiping 7 (seven) light fixtures and chandeliers. This will include ensuring that all crystal parts and reflectors are individually washed, wiped and properly treated to provide transparency and shiny view. When completed, the light fixtures shall be free from bugs, dirt, grime, dust, and marks.

1.3.2 Standard Semi-annual Services shall include the following work:

1.3.2(a) Stripping and waxing vinyl flooring surface in the Nonimmigrant Visas waiting room with the total square 80 m2. The work shall include surface preparation (old seal removal), and application of two coats of new waterproof seal. When completed the flooring shall have a smooth slip-resistant surface and uniform appearance with no blemishes, visible stains and scratches.

1.3.2(b) Sweeping and washing 14 (fourteen) balconies to remove all accumulated dirt and debris. Wiping balconies banisters, cleaning balconies doors.

1.3.2(c) Cleaning decorative handrails on 3 (three) stairwells. One stairwell is located between 1 and 4 floor, two stairwells are located between 2 and 4 floors. Handrails are made of cast iron and must be cleaned with a steam vacuum cleaner and polished with anti-static chemicals

1.3.2(d) Vacuuming and shampooing carpets in all areas with the total square of 2,500 (two-thousand-five-hundred) square meters so that they are free from dust, dirt, mud, etc. The Contractor shall use a certified commercial chemicals and heavy-duty industrial type vacuum cleaner to ensure adequate cleaning. When completed, the area shall be free of all litter, lint, loose soil and debris. Adjacent surfaces shall have no stains or splash marks caused by the shampooing. Remove spots, as necessary.

1.3.2(e) Washing 175 windows in the Consulate building including the outsides of the windows and window frames. When completed the windows shall be free of streaks, smears, all marks like fingerprints, smudges and visible soap residue. Window

frames and ledges shall be clear and free of dust, marks and spots. The windows sizes are provided in Attachment 1 to this contract.

2.0 MANAGEMENT AND SUPERVISION

2.1 The Contractor shall designate a representative who shall be responsible for on-site supervision of the Contractor's workforce at all times. This supervisor shall be the focal point for the Contractor and shall be the point of contact with U.S. Government personnel. The supervisor shall have sufficient English language skill to be able to communicate with members of the U.S. Government staff. The supervisor shall have supervision as his or her sole function.

2.2 The Contractor shall maintain schedules. The schedules shall take into consideration the hours that the staff can effectively perform their services without placing a burden on the security personnel of the Post. For those items other than routine daily services, the Contractor shall provide the Contracting Officer's Representative (COR) with a detailed plan as to the personnel to be used and the time frame to perform the service.

2.3 The Contractor shall be responsible for quality control. The Contractor shall perform inspection visits to the work site on a regular basis. The Contractor shall coordinate these visits with the COR. These visits shall be surprise inspections to those working on the contract.

2.4 The Contractor shall control overtime through efficient use of the work force. Individual work schedules shall not exceed 8 hours per day to preclude overtime being part of the standard services provided under the contract.

4.0 WORK SCHEDULES

When the Government has accepted any time schedule, this acceptance shall be binding on the Contractor. The completion date is fixed and may be extended only by a written contract modification signed by the Contracting Officer. Acceptance or approval of any schedule or revision by the Government shall not:

- (1) extend the completion date or obligate the Government to do so;
- (2) constitute acceptance or approval of any delay, or;

excuse or relieve the Contractor of its obligation to maintain the progress of the work and achieve final completion by the established completion date

5.0 TASKS COMPLETION DATES

5.1 The Contractor shall submit to the COR the dates and times for standard services at least 15 days before the work begins.

5.2 The following are maximum completion times that will be spent by the Contractor depending upon the type and amount of work to be done:

5.2.1 Spot waxing and polishing floors covered with linoleum in the Nonimmigrant Visas waiting room with the total square 80 m2 -	2 day
5.2.2 Removing and washing 20 (twenty) window blinds in the Consular section -	2 days
5.2.3 Thorough cleaning and sanitizing 25 restrooms -	5 days
5.2.4 Thorough cleaning of 10 kitchens -	10 days
5.2.5 Dusting and wiping 7 (seven) light fixtures and chandeliers -	3 days
5.2.6 Sweeping and washing 14 (fourteen) balconies -	3 days
5.2.7 Cleaning decorative handrails on 3 (three) stairwells -	2 days
5.2.8 Vacuuming and shampooing carpets in all areas (2,500 sqm) –	12 days

6.0 PERSONNEL

6.1 General. The Contractor shall maintain discipline at the site and shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by Contractor employees at the site. The Contractor shall preserve peace and protect persons and property on site. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional costs to the Government.

6.2 Standard of Conduct.

6.2.1 Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat and complete uniforms when on duty. All employees shall wear uniforms approved by the Contracting Officer's Representative (COR).

6.2.2 Neglect of duties shall not be condoned. The Contractor shall enforce no sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

6.2.3 Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is

participation in disruptive activities, which interfere with normal and efficient Government operations.

6.2.4 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

6.2.5. Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:

- falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records;
- unauthorized use of Government property, theft, vandalism, or immoral conduct;
- unethical or improper use of official authority or credentials;
- security violations; or,
- organizing or participating in gambling in any form.

6.2.6 Key Control. RESERVED

6.3. Notice to the Government of Labor Disputes

The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

6.4. Personnel Security

6.4.1 After award of the contract, the Contractor shall provide the following list of data on each employee who will be working under the contract. The Contractor shall include a list of workers and supervisors assigned to this project. The Government will run background checks on these individuals. It is anticipated that security checks will take up to 30 days to perform. For each individual the list shall include:

- Full Name
- Place and Date of Birth
- Current Address
- Copy of the passport

6.4.2 The Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall display identity card(s) on the uniform at all times while providing services under this contract. These identity cards are the property of the US Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves Contractor service, or at the request of the Government. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual.

7.0. MATERIALS AND EQUIPMENT

The Contractor shall provide all necessary janitorial supplies and equipment, including mops, brooms, dust rags, detergents, cleaners, etc. to perform the work identified in this contract.

8.0. GOVERNMENT FURNISHED PROPERTY/EQUIPMENT

No Government furnished property or equipment shall be provided under this contract.

9. INSURANCE

9.1 Amount of Insurance. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

9.2 General Liability (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

9.3 The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

9.4 For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3.

9.5 The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- a) any property of the Contractor,
- b) its officers,
- c) agents,
- d) servants,
- e) employees, or
- f) any other person

arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and

all claims arising, except in the instance of gross negligence on the part of the Government.

9.6 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

9.7 Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

9.8 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) calendar days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

10.0. LAWS AND REGULATIONS

10.1 Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. In the event of a conflict among the contract and requirements of local law, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.

10.2 The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, to the extent that such compliance is not inconsistent with the requirements of this contract.

13. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

13.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

13.2 STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

13.3 PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
